Nurse Therapist Enquiry (Behavioural Psychotherapy, 6 No. 1 p.23)

We have several reservations concerning the nature of this enquiry, the manner in which it is being conducted and the authority with which it has been mounted. The following points are at issue :

(1) Have the Executive Committee of the B.A.B.P. been invited by the G.N.C. to institute this enquiry or, alternatively, have they (the Executive) approached the G.N.C. for approval to mount such an enquiry?

(2) Have the B.A.B.P. been approached by or have they themselves approached the J.B.C.N.S. or the C.C.N.S. in respect of this matter? (particularly with regard to questions 2 and 3 listed on their accouncement).

(3) Why, in the list of professions invited to surrender opinions or evidence were nurses (as distinct from trainee and trained nurse therapists) not included?

(4) What is the objective of the enquiry?

(5) To what extent does the Executive Committee of the B.A.B.P. consider that it is appropriate to publicise an enquiry into a branch of nursing without (a) making explicit the intention of the exercise (b) informing their readership whether or not this "enquiry" meets with the approval of the governing body of the nursing profession.

We would be grateful for clarification of these issues particularly in view of the fact that we currently organise the only **approved** course which undertakes to train nurses in behavioural methods in mental handicap, acute and long term psychiatry and therefore consider it our duty to make representation to, and if necessary express our
