The *American Philosophical Quarterly* has in its short history established itself as one of the principal English vehicles for the publication of scholarly work in philosophy. The whole of each issue—printed in a large-page double-column format—is given entirely to articles. This policy makes possible the publication of longer and more substantial articles than usually find a place in philosophical journals. A continuing feature of the *American Philosophical Quarterly* is the publication of analytical and critical surveys of "Recent Work in . . ." various areas of philosophy, taking account not only of books but of significant discussions in the journal literature.

The scope of the *American Philosophical Quarterly* is the entire range of philosophical inquiry: it seeks to be emphatically synoptic—no branch of philosophy and no approach to the subject being excluded from the intended purview. The editorial policy is to publish work of high quality regardless of the school of thought from which it derives.

The *American Philosophical Quarterly* also publishes a supplementary Monograph Series. Apart from the publication of original scholarly monographs, this includes occasional collections of original articles on a common theme. These monographs are included in the subscription.
