# LIU SHAO-CH'I AND THE CHINESE CULTURAL REVOLUTION

The Politics of Mass Criticism

*Lowell Dittmer*

Riding a wave of criticism unprecedented in intensity or scope, China's Great Proletarian Cultural Revolution represented an epoch-making "struggle between two lines" to determine the direction of national development at a critical transition point. Leader of the triumphant "proletarian revolutionary line" was Mao Tse-tung; leader of the vanquished "bourgeois reactionary line" was erstwhile Chief of State Liu Shao-ch'i, a prominent Communist theorist and organizer who had served as Mao's "close comrade-in-arms" for more than twenty years and was his designated successor. What brought about this confrontation?

In his attempt to answer this question, Mr. Dittmer illuminates the policy-making process of a revolutionary state facing the diverging exigencies of economic modernization and political development. Liu Shao-ch'i emerges as the symbol of a systematic endeavor to combine order with revolution and equality with economic efficiency and technocratic values. In the end, his vision of how this synthesis could be achieved was overwhelmed by the sweep and depth of the revolutionary drive in China, as symbolized by Mao Tse-tung, and Liu was destroyed politically.

## **Governing of Men, 4/e**

*By Austin Ranney, University of Wisconsin, Madison, Wisconsin (Ph.D., Yale University)*

Now, in this fourth edition of **Governing of Men**, all the material has been updated to 1974, and the impact of many new political developments—Watergate, the impeachment crisis, the alienation from governmental institutions, and the efforts of parties to reform themselves—are given in-depth treatment. The civil rights section has a considerable new discussion of the conflict over busing; and an entirely new section on the conflict over status of women analyses the law, politics, sociology, and ethics of the struggle. There is an in-depth discussion of electoral behaviour, focusing mainly on the 1972 presidential election, that strongly emphasises such topics as the rise in ticket-splitting, the impact of the McGovern–Fraser Commission reforms, and the influence of the new 18-year-old vote.

## **Nations and Men, 3/e**

**Nations and Men** is a concise, introductory text in international politics that seeks to provide today's students with the essential tools for analysing how nations, people, and the system of nation states interact. Emphasis is on why nations and people act as they do and how they can be expected to act—in all probability—towards the end of the twentieth century. Now in this third edition, controversial concepts and approaches are placed in a context of arguments for and against. And chapters on international law, and organisation are now placed in the second half of the book. The material on international economic affairs has been substantially expanded to include discussions of imperialism, neoimperialism, the political consequence of economic asymmetry, new international economic order, and the law of the sea. The author has included simplified graphic illustrations to add visual aids to the discussion of complex problems or concepts. Plus an increased number of short insert-featurettes which quote some original documents and statements—providing the student with the exact wording of legal and ideological rhetorics.
