She is the author of *Religion and Politics in the Nineteenth Century: The Party Faithful in Ireland and Germany* (Greenwood Press, 2002) and several articles in *Perspectives on Politics, PS: Political Science and Politics, Women & Politics, Irish Political Studies* and *Nationalism and Ethnic Studies*.

Kristin A. Goss is Assistant Professor of Public Policy Studies and Political Science at Duke University. She studies civic engagement, interest groups, and the intersection of public policy, social movements, and private philanthropy. Her work has appeared in Women & Politics, Social Science Quarterly, and Nonprofit and Voluntary Sector Quarterly, among other journals. She is author of Disarmed: The Missing Movement for Gun Control in America (Princeton University Press, 2006), an earlier version of which won the 2003 Harold D. Lasswell Award for best dissertation in the field of public policy.

Jane S. Jaquette is the Bertha Harton Orr Professor and Professor of Politics, Emerita at Occidental College. She has edited six books and published over fifty articles and book chapters on women's political participation, women and development, and feminist political theory. Her most recent book, *Feminist Agendas and Democracy in Latin America* (Duke University Press, 2009) features articles by scholar activists from the region. She continues to teach at Occidental, and to work on a book on Machiavelli and Hobbes.

Alice Kang is a PhD candidate in the Department of Political Science at the University of Wisconsin-Madison. Her dissertation analyzes conflict between Islamists, women's movements, and government actors over gender equality policies in French-speaking West Africa. She has co-authored publications on the effect of quotas on women's political representation in *Comparative Political Studies* and on the power of regional women's advocacy networks in *Politics & Gender*.

Laura Langbein is Professor of Public Administration and Policy at American University. She teaches quantitative methods, program evaluation and policy analysis. Her research includes empirical applications in various policy fields, including the environment, education, criminal justice (death penalty and the police), corruption, and discretion and pay-forperformance for federal public employees. Her recent articles have appeared in *Political Research Quarterly, Journal of Politics, Journal of Policy Analysis and Management, Social Science Quarterly, Journal of Public Administration Research and Theory, Public Choice, and Economics of Education Review.* 

**Susan Gluck Mezey** is Professor of Political Science and Chair of the Political Science Department at Loyola University Chicago. Her publications include *Queers in Court: Gay Rights Law and Public Policy* (2007); *Disabling Interpretations: Judicial Implementation of the Americans with Disabilities Act* (2005); and *Elusive Equality: Women's Rights, Public Policy, and the Law* (2003). She teaches courses on civil rights and liberties and women's rights and publishes in the area of litigation and social reform policy.

Valentine M. Moghadam is director of the Women's Studies Program and Professor of Sociology at Purdue University. She was previously employed at UNESCO where she led a policy-oriented research program on globalization, women's human rights, and the gender dynamics of conflict and war. She is the author of many publications, including Modernizing Women: Gender and Social Change in the Middle East (2003, 2nd ed.), Globalizing Women: Transnational Feminist Networks (2005), and the forthcoming Globalization and Social Movements: Islamism, Feminism, and the Global Justice Movement (2009).

**Pippa Norris** is the McGuire Lecturer in Comparative Politics at Harvard University and the author of more than three dozen books comparing gender politics, elections and public opinion, and political communications.

Joe Rollins is Associate Professor of Political Science at Queens College and the Graduate Center, CUNY. He is the author of AIDS and the Sexuality of Law: Ironic Jurisprudence (Palgrave/Macmillan, 2004), and has published scholarly work in Law & Society Review, Social Politics, and Radical Statistics in addition to several edited volumes. He has served as a Board member at the Center for Lesbian and Gay Studies (CLAGS) as well as on the board of Women's Studies Quarterly.

Michael L. Ross is Professor of Political Science at the University of California, Los Angeles (UCLA); he is also the Director of the Center for Southeast Asian Studies. He was previously Assistant Professor of Political Science at the University of Michigan, Ann Arbor (1996-2001) and Visiting Scholar at the World Bank (2000). In 2003, he was a member of the Advisory Committee to the Extractive Industries Review, which advised the World Bank on reforming its oil, gas, and minerals policies. Since 2006, he has served on the Advisory Board of the Revenue Watch Institute. He has published widely on the political and economic problems caused by resource abundance, the causes of civil war, the determinants of democratization, and the politics of Southeast Asia. His book Timber Booms and Institutional Breakdown in Southeast Asia was published in 2001 by Cambridge University Press. He received his M.A. and Ph.D. degrees in Politics from Princeton University, and his B.A. degree from the University of California, Santa Cruz. **Ronnee Schreiber** is Associate Professor of Political Science at San Diego State University. Her new book, *Righting Feminism: Conservative Women and American Politics* (Oxford University Press) examines the political significance of prominent national conservative women's organizations. In addition to her book, she has published articles on the media coverage of women in Congress, how feminist organizations adapt to conservative political climates, and how conservative women challenge feminist understandings of gender consciousness.

#### MANUSCRIPT PREPARATION

- Manuscripts must be no longer than 30 pages including text, tables and figures, references and appendices. The entire manuscript (including notes and references) must be double-spaced, with one-inch margins and 12-point font, and printed on one side of the page only.
- The author must include a separate title page, with his or her full contact information (including email address, telephone number and institutional affiliation), and a brief biographical statement. All identifying information must be removed from the manuscript.
- A second page must include an abstract of no more than 200 words.
- Placement of tables or figures should be cited in the text. The publisher will be responsible for placing artwork, tables or figures, as well as converting endnotes to footnotes.
- Appendices, tables, and figures should be numbered consecutively throughout the article and be included on separate pages

appearing after the reference section. Figures should be ready for photographic reproduction; they cannot be redrawn by the publisher. Charts, graphs, or other artwork should be professional rendered or computer generated. Photographs should be clearly printed and should remain legible after a 50% reduction.

- References and notes should conform to the APSA Style Manual. Authors should include full volume, issue, and page numbers for references. Author's acknowledgments or other personal notes will appear as an unnumbered note at the foot of the page. Notes should be numbered consecutively throughout the article. Numbered notes should appear at the end of the sentence. If multiple texts are cited in a sentence they should appear as one consolidated note at the end of the sentence.
- Endnotes should be employed (rather than footnotes).
- All figure captions should be typed on a separate page (or pages), rather than on the figures themselves (which are camera-ready art) so that they can be copyedited.

Originality and copyright: Papers with multiple authors are reviewed with the assumption that all authors concur with its submission. A Copyright Transfer Agreement, with certain specified rights reserved by the author, must be signed and returned to the Editor by senior authors of accepted manuscripts, prior to publication. *Politics & Gender* does not accept manuscripts for review that are under review elsewhere, previously published or already committed for publication.

For general guidelines for preparing a manuscript for submission, please refer to the *APSA Style Manual for Political Science* (rev. ed. 2001) for citation, footnotes, references, and other style issues. Please note, in particular, the statement on gender-specific language (15).
