# Escape From Empire

The Attlee Government and the Indian Problem

**R. J. Moore**

The British abdication of the government of India in August 1947 was a great escape. By the end of the war Britain lacked the military and administrative resources for a long extension of the Raj, whose strategic and economic objects might now be better achieved through co-operative Indian authorities. The difficulty facing the incoming Attlee Government was to bring the Indian National Congress and the Muslim League to an agreement upon terms for a transfer of power. Under Attlee's firm guidance and Cripps's expert advice the Government avoided the perils of Wavell's favoured quasi-military retreat and Conservative schemes for an India of many nations. £19.50
