# TRACE FORMULA OF CERTAIN HECKE OPERATORS FOR $\Gamma_o(q^v)$

### Introduction

Let  $S_{\kappa}(\Gamma_0(q^{\nu}))$  be the space of cusp forms of weight  $\kappa$  with respect to the congruence subgroup  $\Gamma_0(q^{\nu})$ , and  $S^0_{\star}(\Gamma_0(q^{\nu}))$  its subspace of all new forms in  $S_{\iota}(\Gamma_{0}(q^{\nu}))$ , where q is a prime such that  $q \geq 3$ . Now for  $f \in S_{\epsilon}(\Gamma_0(q^{\nu}))$ , put  $(f \mid W)(z) = f\left(\frac{-1}{q^{\nu}z}\right)(q^{\nu}z)^{\epsilon}q^{\nu\epsilon/2}$ . Then it is known that W induces an automorphism of  $S_{\epsilon}(\Gamma_0(q^{\nu}))$ . On the other hand, for the character  $\chi$  of  $(Z/qZ)^{\times}$  of order 2, let  $\delta_{\chi}$  denote the "twisting operator" with respect to  $\chi$ , which was defined in [15] by Shimura, namely,  $(f | \delta_{\chi})(z)$  $=\sum_{n=1}^{\infty}a_n\chi(n)e^{2\pi i nz}$  for  $f(z)=\sum_{n=1}^{\infty}a_ne^{2\pi i nz}S_{\epsilon}(\Gamma_0(q^{\nu})).$  If  $\nu\geq 2, S_{\epsilon}(\Gamma_0(q^{\nu}))$  is closed under  $\delta_{\chi}$  and if  $\nu \geq 3$ , using W and  $\delta_{\chi}$  we can decompose  $S^{0}_{\kappa}(\Gamma_{0}(q^{\nu}))$ into four subspaces  $S_{I}$ ,  $S_{II}$ ,  $S_{II}$ , and  $S_{III}$  in a natural way. For example,  $S_{I}$ is the space consisting of all  $f \in S^0_{\alpha}(\Gamma_0(q^{\nu}))$  satisfying f | W = f and  $f | \delta_{\alpha} W$  $= f | \delta_x$ . We see these subspaces are closed under Hecke operators  $T_n$  for all n. In the case where  $\nu = 2$ , we can also consider such a decomposition of  $S^0_{*}(\Gamma_0(q^{\nu}))$  and we shall discuss this case in § 5. The main purpose of this paper is to give a formula for the trace of the Hecke operator  $T_n$ on each subspace  $S_{I}$ ,  $S_{II}$ , etc.. Noticing the trace tr  $T_{n}$  restricted on each subspace  $S_{I}$ ,  $S_{II}$ , etc. can be expressed as a sum of tr  $T_{n}$ , tr  $WT_{n}$ , tr  $\delta_{\chi}W\delta_{\chi}T_{n}$ , and tr  $\delta_x W \delta_x W T_n$  on  $S_{\epsilon}(\Gamma_0(q^{\nu}))$ , in §2 and §3, we shall give explicit formulae for tr  $\delta_{\chi} W \delta_{\chi} T_n$  and tr  $\delta_{\chi} W \delta_{\chi} W T_n$  on  $S_{\epsilon}(\Gamma_0(q^{\nu}))$  for  $\nu \geq 2$  by means of Eichler-Selberg's trace formula and Hijikata's result [6] on the conjugacy with respect to  $\Gamma_0(N)$ . As an application of these formulae, we can give additions to the examples which were discussed by Doi and Yamauchi [4]. Namely, in this paper, we shall give several Fourier coefficients of a certain primitive cusp form  $f \in S_2^0(\Gamma_0(q^{\nu}))$  for  $q^{\nu} = 11^3$  and  $q^{\nu} = 19^2$ , and

discuss on the class field theoretical property of special points of the abelian variety associated with f. These examples turn out to be related to Shimura's theory on the construction of class fields over real quadratic fields. In §6, we shall give formulae for tr  $\delta_z$  and tr  $T_q W$  on  $S_{\epsilon}(\Gamma_0(q^{\nu}), \psi)$ . As a corollary of these formulae, we obtain another proof of the theorem of Asai ([2], Th. 4) and Ribet ([9], Prop. 4.4 and Th. 4.5) on the characterization of primitive cusp forms in  $S_{\epsilon}(\Gamma_0(q^{\nu}))$  corresponding to L-functions of  $Q(\sqrt{-q})$ .

### Notation

The symbols Z, Q, R and C denote respectively the ring of rational integers, the rational number field, the real number field, and the complex number field. The symbol  $\S$  denotes the upper half complex plane:

$$\mathfrak{H} = \{ z \in C | \operatorname{Im} z > 0 \}$$
.

If we discuss a Fuchsian group of the first kind  $\Gamma$  on  $\mathfrak{H}$ , then  $\mathfrak{H}^*$  denotes the union of  $\mathfrak{H}$  and the cusps of  $\Gamma$ . For an associative ring S with an identity element, we denote by  $S^{\times}$  the group of all invertible elements of S, and by  $M_n(S)$  the ring of all square matrices of size n with coefficients in S. Then we put  $GL_n(S) = M_n(S)^{\times}$ . For subsets  $S_{ij}$  of S,  $1 \leq i, j \leq n$ ,  $(S_{ij})$  denotes the subset  $\{(s_{ij}) \in M_n(S) | s_{ij} \in S_{ij}\}$ . Let G be a group and Hbe its subgroup. We denote by  $\tilde{H}$  the conjugacy with respect to H, i.e.,  $g\tilde{H}g'$  if and only if  $h^{-1}gh = g'$  for  $h \in H$ . For a subset X of G, let  $X/\tilde{H}$ denote the quotient of X by  $\tilde{H}$  and sometimes also a complete system of representatives of  $X/\tilde{H}$ . For a finite-dimensional vector space V over Cand a linear operator T on V, tr  $T^{\dagger}V$  denotes the trace of T on V.

#### §1. Preliminaries

In this section, we shall recall some facts on "twisting operator" defined in [15] and abelian varieties associated with primitive cusp forms, and make preliminary considerations. Let  $\alpha = \begin{pmatrix} a & b \\ c & d \end{pmatrix} \in GL_2(\mathbf{R})$ , det  $\alpha > 0$ . For a complex-valued function f(z) on  $\mathfrak{H}$  and a positive integer  $\kappa \geq 2$ , we define a function  $f|[\alpha]_{\kappa}$  on  $\mathfrak{H}$  by

$$(f|[\alpha]_{\star})(z) = (\det \alpha)^{{\star}/{2}}(cz+d)^{-{\star}}f(\alpha(z)),$$

where  $\alpha(z) = (az+b)/(cz+d)$  for  $z \in S$ . For a positive integer N, put

$${\varGamma}_{\scriptscriptstyle 0}(N) = \left\{ egin{pmatrix} a & b \ c & d \end{pmatrix} \in SL_{\scriptscriptstyle 2}({oldsymbol Z}) \, | \, c \equiv 0 \pmod{N}

For a character  $\psi$  modulo N, we denote by  $S_{*}(\Gamma_{0}(N), \psi)$  the space of all holomorphic cusp forms on  $\mathfrak{H}$  satisfying

$$f|[\gamma]_{\scriptscriptstyle s}=\psi(a)^{-1}\!f\qquad ext{for}\ \gamma=egin{pmatrix} a&b\c&d\end{pmatrix}\in arGamma_{\scriptscriptstyle 0}(N)\ ,$$

and by  $S^{\circ}_{\epsilon}(\Gamma_{0}(N), \psi)$  the space of all new forms in  $S_{\epsilon}(\Gamma_{0}(N), \psi)$ . Throughout this paper, we fix a prime  $q \geq 3$ , and assume  $N = q^{*}$  with a non-negative integer  $\nu$ . Let  $\chi$  be a real primitive character of  $(\mathbb{Z}/q\mathbb{Z})^{\times}$  of order 2, and assume  $\nu \geq 2$  and the conductor  $\mathfrak{f}_{\psi}$  of  $\psi$  satisfies  $\mathfrak{f}_{\psi} \leq q^{\nu-1}$ . Let  $\alpha_{u} = \begin{pmatrix} q & u \\ 0 & q \end{pmatrix}$ for  $u \in \mathbb{Z}$ , then as in [15] we can define the twisting operator  $\delta_{\chi}$  on  $S_{\epsilon}(\Gamma_{0}(q^{\nu}), \psi)$  with respect to  $\chi$  by

$$f|\delta_{\chi} = \frac{1}{W(\chi)} \sum_{u=1}^{q-1} \chi(u) f| [\alpha_u]_{\star},$$

where  $W(\chi)$  is the Gaussian sum for  $\chi$ . For  $f \in S_{\epsilon}(\Gamma_0(q^{\nu}), \psi)$ , put

$$f \mid W = f \mid \begin{bmatrix} \begin{pmatrix} 0 & -1 \\ q^{\nu} & 0 \end{bmatrix} \end{bmatrix}_{\star},$$

then W gives an isomorphism of  $S_{\epsilon}(\Gamma_{0}(q^{\nu}), \psi)$  onto  $S_{\epsilon}(\Gamma_{0}(q^{\nu}), \overline{\psi})$ . In the following, except in § 6, we assume  $\psi$  is the identity character and  $\kappa$  is an even positive integer. Put  $S_{\epsilon}(\Gamma_{0}(q^{\nu})) = S_{\epsilon}(\Gamma_{0}(q^{\nu}), \psi)$ . By a result of Atkin-Lehner [3], we know W induces an isomorphism of  $S_{\epsilon}^{0}(\Gamma_{0}(q^{\nu}))$  onto itself. On the other hand, if  $\nu \geq 3$ , we can prove

PROPOSITION 1.1. If  $\nu \geq 3$ ,  $\delta_{\chi}$  induces an isomorphism

*Proof.* For a primitive form  $f \in S^0_{\mathfrak{s}}(\Gamma_0(q^{\mathfrak{v}}))$ , assume  $f|_{\delta_{\mathfrak{x}}}$  is contained in the space of old forms, then there exist  $g_1, g_2 \in S_{\mathfrak{s}}(\Gamma_0(q^{\mathfrak{v}^{-1}}))$  such that  $(f|_{\delta_{\mathfrak{x}}})(z) = g_1(z) + g_2(qz)$ . Applying  $\delta_{\mathfrak{x}}$  on both sides, we obtain  $f|_{\delta_{\mathfrak{x}}}\delta_{\mathfrak{x}} = g_1|_{\delta_{\mathfrak{x}}}$ . Since  $\nu \geq 3$ ,  $f|_{\delta_{\mathfrak{x}}}\delta_{\mathfrak{x}} = f$  and  $g_1|_{\delta_{\mathfrak{x}}} \in S_{\mathfrak{s}}(\Gamma_0(q^{\mathfrak{v}^{-1}}))$ . This contradicts our assumption.

If  $\nu \geq 3$ , by means of  $\delta_{\chi}$  and W, we can decompose  $S^{0}_{\kappa}(\Gamma_{0}(q^{\nu}))$  into the following four spaces, namely,

$$S^{\scriptscriptstyle 0}_{\scriptscriptstyle {\scriptscriptstyle {\rm I}}}({\Gamma}_{\scriptscriptstyle 0}(q^{\scriptscriptstyle 
u}))=S_{\scriptscriptstyle {\rm I}}\oplus S_{\scriptscriptstyle {\rm II}}\oplus S_{\scriptscriptstyle {\rm II}_{\scriptscriptstyle {\rm I}}}\oplus S_{\scriptscriptstyle {\rm III}}$$
 ,

where

$$egin{aligned} S_{ ext{I}} &= \{f \in S^{0}_{\star}(arGamma(\Gamma_{0}(q^{*}))) \mid f \mid W = f, f \mid \delta_{\chi}W = f \mid \delta_{\chi}\} \ S_{ ext{II}} &= \{f \in S^{0}_{\star}(arGamma(\Gamma_{0}(q^{*}))) \mid f \mid W = f, f \mid \delta_{\chi}W = -f \mid \delta_{\chi}\} \ S_{ ext{III}} &= \{f \in S^{0}_{\star}(arGamma(q^{*})) \mid f \mid W = -f, f \mid \delta_{\chi}W = f \mid \delta_{\chi}\} \ S_{ ext{III}} &= \{f \in S^{0}_{\star}(arGamma(q^{*}))) \mid f \mid W = -f, f \mid \delta_{\chi}W = -f \mid \delta_{\chi}\} \end{aligned}$$

Then we see easily that these four spaces are closed under Hecke operators, and that  $S_{II} | \delta_{\chi} = S_{II_{\chi}}$ . In the case where  $\nu = 2$ , we can also consider a similar decomposition of  $S^{0}_{\epsilon}(\Gamma_{0}(q^{2}))$ , however the situation is a little more complicated in this case, so we shall discuss it in detail in §5. To give a formula of traces of Hecke operators on the above spaces, let us consider the operators  $\delta_{\chi}W\delta_{\chi}$  and  $\delta_{\chi}W\delta_{\chi}W$  on  $S_{\epsilon}(\Gamma_{0}(q^{\nu}))$  for  $\nu \geq 2$ . These operators have a good property if  $\nu \geq 3$ , namely we can prove

PROPOSITION 1.2. If g is an old form in  $S_{\epsilon}(\Gamma_0(q^{\nu}))$  with  $\nu \geq 3$ , then

$$egin{array}{lll} g \, | \, \delta_{\chi} W \delta_{\chi} &= 0 \ g \, | \, \delta_{\chi} W \delta_{\chi} W &= 0 \ . \end{array}$$

*Proof.* If g(z) = f(qz) for  $f \in S_{\epsilon}(\Gamma_0(q^{\nu-1}))$ ,  $g | \delta_{\chi} = 0$ . Hence we may assume g is a primitive form with the level  $q^{\lambda}$ ,  $\lambda < \nu$ . Then we see  $(g | \delta_{\chi} W)(z) = f(qz)$  for some  $f \in S_{\epsilon}(\Gamma_0(q^{\nu-1}))$ , and we obtain  $g | \delta_{\chi} W \delta_{\chi} = 0$  and  $g | \delta_{\chi} W \delta_{\chi} W = 0$ .

If  $\nu \geq 3$ , we can express the traces of Hecke operators on  $S_{I}$ ,  $S_{II}$ ,  $S_{II_2}$ , and  $S_{III}$  by using tr  $T_n$ , tr  $WT_n$ , tr  $\delta_{\chi}W\delta_{\chi}T_n$ , and tr  $\delta_{\chi}W\delta_{\chi}WT_n$  on  $S_{\epsilon}(\Gamma_0(q^{\nu}))$ . For example, on  $S_{I}$ , we have

$$\mathrm{tr} \; T_n \, | \, S_{\mathrm{I}} = rac{1}{4} \{ \mathrm{tr} \; T_n \, | \, S^{\scriptscriptstyle 0}_{\scriptscriptstyle \mathbf{z}}(arGamma_{\scriptscriptstyle 0}(q^{\scriptscriptstyle \mathbf{v}})) + \mathrm{tr} \; W T_n \, | \, S^{\scriptscriptstyle 0}_{\scriptscriptstyle \mathbf{z}}(arGamma_{\scriptscriptstyle 0}(q^{\scriptscriptstyle \mathbf{v}})) \ + \mathrm{tr} \; \delta_\chi W \delta_\chi T_n \, | \, S_{\scriptscriptstyle \mathbf{z}}(arGamma_{\scriptscriptstyle 0}(q^{\scriptscriptstyle \mathbf{v}})) + \mathrm{tr} \; \delta_\chi W \delta_\chi W T_n \, | \, S_{\scriptscriptstyle \mathbf{z}}(arGamma_{\scriptscriptstyle 0}(q^{\scriptscriptstyle \mathbf{v}})) \} \; .$$

Formulae for tr  $T_n$  and tr  $WT_n$  are already given by Hijikata [6] and Yamauchi [16] respectively. In §2 and §3 we shall give formulae for tr  $\delta_x W \delta_x T_n$  and tr  $\delta_x W \delta_x W T_n$  on  $S_{\epsilon}(\Gamma_0(q^{\nu}))$  for  $\nu \geq 2$  and for any *n* prime to *q*. In the case where  $\nu = 2$ , we can calculate the traces of Hecke operators on certain subspaces of  $S_{\epsilon}(\Gamma_0(q^2))$  by means of the above traces, we discuss it in §5.

In the rest of this section, we assume  $\kappa = 2$ , and recall a few facts in [15]. Let  $\Gamma$  be a group of level  $q^{\nu}$  given by

$$\varGamma = \left\{ egin{pmatrix} a & b \ c & d \end{pmatrix} \in \varGamma_{\scriptscriptstyle 0}(q^{\scriptscriptstyle arphi}) \, | \, a \equiv d \equiv 1 \pmod{q} 
ight\}.$$

Let J be the jacobian variety of  $\mathfrak{F}'/\Gamma$  and  $S_2(\Gamma)$  the vector space of all holomorphic cusp forms on  $\mathfrak{F}$  of weight 2 with respect to  $\Gamma$ . Then it is known that J is defined over Q. Let  $f(z) = \sum_{n=1}^{\infty} a_n e^{2\pi i n z}$ ,  $a_1 = 1$ , be a primitive cusp form in  $S_2(\Gamma_0(q^p))$ , then f is a common eigen-function for Hecke operators  $T_n$  for all n as an element of  $S_2(\Gamma)$ . Let K be the subfield of C generated over Q by  $a_n$  for all n. Then by [15, Th. 1], we have

- (1.1) There exists a triple (A, μ, θ) formed by the objects satisfying the following conditions.
  - (i) A is a quotient of J by an abelian variety defined over Q, and  $\mu$  is a natural map  $J \rightarrow A$ .
  - (ii)  $\theta$  is an isomorphism of K into End (A)  $\otimes Q$  such that  $\mu \circ \xi_n = \theta(a_n) \circ \mu$  for all n. ( $\xi_n$  is an element of End (J) associated with  $T_n$ .)
  - (iii) dim A = [K: Q].

Now if we take  $N(=M) = q^{\nu} (\nu > 1)$ , r = q, s = N in the notation of [15, §4], then we see our  $\Gamma$  satisfies the condition (4.8) in [15, §4]. Suppose the following condition (the condition (4.9) in [15]) is satisfied:

(\*) There is an automorphism  $\rho$  of K, other than the identity map, such that  $\chi(n)a_n = a_n^{\rho}$  for all n. (This implies especially that  $\rho^2 = 1$  and  $a_n = 0$  if  $(n, q) \neq 1$ .)

Then by [15, Prop. 8 and Prop. 9], under the assumption (\*), there exists an endomorphism  $\eta$  of A which is defined over the quadratic extension kof Q corresponding to  $\chi$  and satisfies the condition

(1.2) (i) 
$$\eta^* = -\eta$$
 if  $\varepsilon$  is the generator of Gal  $(k/Q)$ .  
(ii)  $\eta^2 = \chi(-1)q \cdot \mathrm{id}_A$ .  
(iii)  $\eta \circ \theta(a) = \theta(a^{\rho}) \circ \eta$  for every  $a \in K$ .

Under the assumption (\*), we follow the procedure in [15]. Let F be the invariant subfield of K under  $\rho$ , and  $o_K$ ,  $o_F$  be the maximal orders of K, F respectively. Let  $b_0$  denote the ideal of K generated by all x in  $o_K$  such that  $x^{\rho} = -x$ . We define the odd part b of  $b_0$  and an integral ideal c of  $o_F$  in exactly the same way as in [14, § 2] for the present F and K. We put

$$\mathfrak{x} = \{t \in A \,|\, \theta(\mathfrak{b})t = 0\},\$$

then g is isomorphic to  $(\mathfrak{o}_{\kappa}/\mathfrak{b})^2$  as an  $\mathfrak{o}_{\kappa}$ -module. Further we assume as in [14, § 9],

(\*\*)  $\chi(-1)q \equiv e^2 \pmod{\mathfrak{c}}$  for some  $e \in \mathfrak{o}_F$  prime to  $\mathfrak{c}$ ,

and put

$$\mathfrak{y} = \{t \in \mathfrak{x} \mid (\eta - \theta(e))t = 0\}$$
$$\mathfrak{z} = \{t \in \mathfrak{x} \mid (\eta + \theta(e))t = 0\}.$$

Then as in [14, Prop. 9.2], we can verify

(1.3) The submodules  $\mathfrak{y}$  and  $\mathfrak{z}$  are  $\mathfrak{o}_{F}$ -isomorphic to  $\mathfrak{o}_{F}/\mathfrak{c}$ , and  $\mathfrak{x} = \mathfrak{y} \oplus \mathfrak{z}$ .

Let  $k(\underline{x})$  (resp.  $k(\underline{y}), k(\underline{\vartheta})$ ) denote the smallest extension of k over which the points of  $\underline{x}$  (resp.  $\underline{y}, \underline{\vartheta}$ ) are rational. Then  $k(\underline{x})$  is an abelian extension of k, and making Gal  $(k(\underline{x})/k)$  act on  $\underline{y}$  and  $\underline{\vartheta}$ , we obtain an injective homomorphism

Gal 
$$(k(\mathfrak{x})/k) \to (\mathfrak{o}_F/\mathfrak{c})^{\times} \times (\mathfrak{o}_F/\mathfrak{c})^{\times}$$
.

We shall discuss on the class-field theoretical properties of  $(\mathfrak{o}_F/\mathfrak{c})$ -valued "character" associated with the abelian extensions  $k(\mathfrak{y})$  and  $k(\mathfrak{z})$  for some numerical examples in §4 and §5.

## §2. A formula for $\operatorname{tr} \delta_x W \delta_x W T_n$

For a rational prime p, let  $Z_p$  and  $Q_p$  denote the ring of p-adic integers and the field of p-adic numbers respectively. Let  $Q_A$  (resp.  $Q_A^{\times}$ ) be the adele ring (resp. the idele group) of Q. For a non-negative integer  $\mu$  and a prime p, put

$$R_{p}(\mu) = egin{pmatrix} Z_{p} & Z_{p} \ p^{\mu}Z_{p} & Z_{p} \end{pmatrix}.$$

For a prime p different from q (resp. p = q), let  $U_p$  denote  $R_p(0)^{\times} = GL_2(\mathbb{Z}_p)$ (resp.  $R_q(\nu)^{\times}$ ) and let  $U_{\infty}$  denote the subgroup  $\{g \in GL_2(\mathbb{R}) | \det g > 0\}$  of  $GL_2(\mathbb{R})$ . Then  $U = \prod_p U_p \times U_{\infty}$  is an open subgroup of  $GL_2(\mathbb{Q}_A)$ , and  $\Gamma_0(q^{\nu}) = U \cap GL_2(\mathbb{Q})$ .

LEMMA 2.1. The notation being as above, one has

and the right hand side is a disjoint union.

Proof. It is easy to see that the right hand side is contained in the left hand side and that the union is disjoint. Let  $g = \begin{pmatrix} a & b \\ c & d \end{pmatrix}$  be an element contained in the left hand side, then det  $g = q^2$ . If  $c \neq 0$ , there exist  $a', c' \in \mathbb{Z}$  prime to q such that  $a = qa' \ c = q^{\mu}c'$  with a positive integer  $\mu \geq \nu + 1$  and (a', c') = 1. Hence there exists an element  $h = \begin{pmatrix} m & n \\ -q^{\mu-1}c' & a' \end{pmatrix} \in \Gamma_0(q^{\nu})$  for some  $m, n \in \mathbb{Z}$ . Since  $hg = \begin{pmatrix} * & * \\ 0 & * \end{pmatrix}$  and det  $g = q^2$ , we may assume c = 0 and g is of the form  $\begin{pmatrix} q & b \\ 0 & q \end{pmatrix}$ . Now we easily see such elements are contained in the right hand side. This completes the proof of our lemma.

*Proof.* The right hand side is clearly contained in the left hand side. For  $i, j, i', j', 1 \le i, j, i', j' \le q - 1$ , we have

and the disjointness of the right hand side follows from this easily. Hence to prove our lemma, it is enough to show  $\mathcal{Z}_q(\delta_{\chi}W\delta_{\chi}W) \subset \bigcup_{i,j=1}^{q-1} U_q\alpha_{ij}$ . Let  $\alpha$  be an element of  $\mathcal{Z}_q(\delta_{\chi}W\delta_{\chi}W)$ . We may assume  $\alpha = \begin{pmatrix} q^{\nu+2}a & q^{\nu+1} \\ q^{2\nu+1}c & q^{\nu+2} \end{pmatrix}$ with  $a, c \in \mathbb{Z}_q$ . By noticing  $\mathcal{E}(\delta_{\chi}W\delta_{\chi}WT_n) = \begin{pmatrix} -1 & 0 \\ 0 & 1 \end{pmatrix} \mathcal{E}(\delta_{\chi}W\delta_{\chi}WT_n) \begin{pmatrix} -1 & 0 \\ 0 & 1 \end{pmatrix}^{-1}$ and  $\chi_1 \begin{pmatrix} \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix} \alpha \begin{pmatrix} 0 & 1 \\ 1 & 0 \end{pmatrix}^{-1} \end{pmatrix} = \chi_1(\alpha)$  for  $\alpha \in \mathcal{E}(\delta_{\chi}W\delta_{\chi}WT_n)$ , we obtain

where  $\mathcal{E}(\delta_{\chi}W\delta_{\chi}WT_n)_e$  (resp.  $\mathcal{E}(\delta_{\chi}W\delta_{\chi}WT_n)_h$ ; resp.  $\mathcal{E}(\delta_{\chi}W\delta_{\chi}WT_n)_p$ ) denotes the set of all elliptic elements (resp. hyperbolic elements fixing cusps of  $\Gamma_0(q^{\nu})$ ; resp. parabolic elements fixing cusps of  $\Gamma_0(q^{\nu})$ ) in  $\mathcal{E}(\delta_{\chi}W\delta_{\chi}WT_n)$ . For  $\alpha \in GL_2(\mathbf{Q}), \zeta_{\alpha}$  and  $\eta_{\alpha}$  are the two characteristic roots of  $\alpha$  and  $\Gamma(\alpha)$  $= \{\gamma \in \Gamma_0(q^{\nu}) | \gamma^{-1}\alpha\gamma = \alpha\}$ . For a parabolic element  $\alpha$  in  $GL_2(\mathbf{Q}) \cap U_{\infty}$  fixing a cusp of  $\Gamma_0(q^{\nu})$ , there exists  $g \in GL_2(\mathbf{Q}) \cap U_{\infty}$  such that  $g\Gamma(\alpha)g^{-1}$  $= \{\begin{pmatrix} 1 & mh \\ 0 & 1 \end{pmatrix} | m \in Z\}$  and  $g\alpha g^{-1} = \begin{pmatrix} \zeta_{\alpha} & \lambda_{\alpha} \\ 0 & \zeta_{\alpha} \end{pmatrix}$  with h > 0, then  $m(\alpha) = \lambda_{\alpha}\zeta_{\alpha}^{-1}/h$ . To express tr  $\delta_{\chi}W\delta_{\chi}WT_n$  in a more explicit form, we follow Hijikata

[6]. First let us introduce some notation. For a quadratic polynomial  $\Phi(X) = X^2 - sX + n$  in  $\mathbb{Z}[X]$ , we put

$$K(\Phi) = \mathbf{Q}[X]/(\Phi(X))$$
,

then  $K(\Phi)$  is a commutative Q-algebra of dimension 2 over Q. We denote by  $\tilde{X}$  the class of X in  $K(\Phi)$ . By a Z-order of  $K(\Phi)$  we understand a subring  $\Lambda$  of  $K(\Phi)$  containing the unity which is a free Z-module of rank 2. For a prime p, we put  $K(\Phi)_p = K(\Phi) \otimes_Q Q_p$  and  $\Lambda_p = \Lambda \otimes_Z Z_p$ . Let  $\alpha$ be an element of  $GL_2(Q)$  with the minimal polynomial  $\Phi(X)$ . For a Zorder  $\Lambda$  containing  $\tilde{X}$  and a non-negative integer  $\mu$ , put

$$C_p(\mu, lpha, \Lambda) = \{g^{-1}lpha g \mid g \in GL_2(\boldsymbol{Q}_p), \varphi(\Lambda_p) = gR_p(\mu)g^{-1} \cap |\boldsymbol{Q}_p[lpha]\},$$

where  $Q_p[\alpha]$  is a  $Q_p$ -algebra generated by  $\alpha$  and  $\varphi$  is a canonical isomorphism of  $K(\Phi)_p$  to  $Q_r[\alpha]$  such that  $\varphi(\tilde{X}) = \alpha$ . For the infinite prime, we put

$$C_{\infty}(\alpha, \Lambda) = \{g^{-1}\alpha g \mid g \in GL_2(\mathbf{R})\}.$$

THEOREM 2.4 (Hijikata [6]). The notation being as above, let  $\rho$  be a non-negative integer such that  $[\Lambda_p: \mathbb{Z}_p[\tilde{X}]] = p^{\rho}$ . For a non-negative integer  $\mu$ , put

and let  $\Omega$  and  $\Omega'$  be a complete system of representatives of  $\Omega_p(\mu, \Phi, \Lambda)$ modulo  $p^{\mu+\rho}$  and  $\Omega'_p(\mu, \Phi, \Lambda)$  modulo  $p^{\mu+\rho}$  respectively. For  $\xi \in \Omega_p(\mu, \Phi, \Lambda)$ ,  $\eta \in \Omega'_p(\mu, \Phi, \Lambda)$ , put

Then  $\{\varphi_{\xi}(\widetilde{X}) | \xi \in \Omega\} \cup \{\varphi'_{\eta}(\widetilde{X}) | \eta \in \Omega'\}$  gives a complete system of representatives of  $C_p(\mu, \Phi, \Lambda) / \widetilde{R_p(\mu)}^{\times}$ .

COROLLARY 2.5. The notation being as above, one has

These are the special cases of Th. 2.3 and its corollary of [6].

Let  $R(q^{\nu})$  be a Z-order of  $M_2(Q)$  such that  $R(q^{\nu}) \otimes_Z Z_p = R_p(0)$  for  $p \neq q$  and  $R(q^{\nu}) \otimes_Z Z_q = R_q(\nu)$ . For a Z-order  $\Lambda$  of  $K(\Phi)$  containing  $\tilde{X}$ , put

Here  $\Lambda_{\infty}^{+}$  denotes the subgroup of  $(K(\Phi) \otimes_{Q} R)^{\times}$  consisting of all elements with positive determinants for the regular representation of  $(K(\Phi) \otimes_{Q} R)$ .

PROPOSITION 2.6. Let  $\alpha$  be an element of  $GL_2(\mathbf{Q})$  with the minimal polynomial  $\Phi(X) = X^2 - sX + n \in \mathbb{Z}[X]$ . Let  $\theta$  be the canonical map from  $C(\alpha, \Lambda)/\widetilde{\Gamma_0(q^*)}$  to  $C_A(\alpha, \Lambda)/\widetilde{U}$  induced by the inclusion  $C(\alpha, \Lambda) \subset C_A(\alpha, \Lambda)$ . For each prime p, let  $\mathbb{Z}_p$  be a union of  $U_p$ -double cosets and assume  $\mathbb{Z}_p$ 

 $= U_p$  except a finite number of primes. Put  $\mathbb{Z}_A = \prod_p \mathbb{Z}_p \times U_{\infty}$  and  $\mathbb{Z}$  $= \mathbb{Z}_A \cap GL_2(Q)$ , then one has

Proof. Let  $g^{-1}\alpha g$  be an element of  $C_A(\alpha, \Lambda) \cap \mathcal{Z}_A$ , then there exist  $g_1 \in GL_2(Q)$  and  $g_2 \in U$  such that  $g = g_1g_2$ , since  $GL_2(Q_A) = GL_2(Q)U$ . We see  $g^{-1}\alpha g \tilde{U}g_1^{-1}\alpha g_1$  and  $g_1^{-1}\alpha g_1 \in C(\alpha, \Lambda) \cap \mathcal{Z}$ , and i) follows from this. Let  $g \in GL_2(Q_A)$  be an element such that  $g^{-1}\alpha g$  is contained in  $\tilde{\alpha}$ . Then we see  $\theta^{-1}(\tilde{\alpha})$  is in one to one correspondence with  $Q[\alpha]^{\times} \setminus ((Q[\alpha] \otimes_Q Q_A)^{\times} gU) \cap GL_2(Q)/\Gamma_0(q^{*})$ . Since  $g_1^{-1}\alpha g_1 \in C(\alpha, \Lambda) \cap \mathcal{Z}$ , we have

thus we have proved the assertion ii). If  $p \neq q$  and  $\mathcal{Z}_p = U_p$ , by Cor. 2.4, we have  $|C_p(\alpha, \Lambda) \cap \mathcal{Z}_p/\tilde{U}_p| = 1$ , and iii) follows from this easily.

Now we are ready to give a formula for tr  $\delta_{\chi} W \delta_{\chi} W T_n | S_{\epsilon}(\Gamma_0(q^{\nu}))$ .

THEOREM 2.7. Let n be a positive integer prime to q and  $\kappa$  be an even positive integer. Assume  $\nu \geq 2$ , then one has

For  $\Phi_s(X)$ ,  $\zeta$  and  $\eta$  denote the two roots of  $\Phi_s(X) = 0$ . s runs through all integers such that  $s^2 - 4n < 0$ , and f runs through all positive integers such that  $f^2|(s^2 - 4n), (f, q) = 1$ , and  $(s^2 - 4n)/f^2 \equiv 1$  or  $0 \pmod{4}$ .  $h(\varDelta)$ denotes the class number of the order of  $Q(\sqrt{\varDelta})$  with the discriminant  $\varDelta$ . d runs through all positive integer such that d|n and  $0 < d < \sqrt{n}$ .  $\delta(n) = 1$ or 0 according as n is a square or not.

Proof. We know by (2.2) that for  $\alpha \in \prod_{p \neq q} \overline{Z}_p(n) \times \overline{Z}_q(\delta_x W \delta_x W) \times U_{\infty}$ ,  $\chi_1(\alpha)$  depends only on the  $U_q$ -conjugacy class of the q-component  $\alpha_q$  of  $\alpha$ and  $\chi_1(\alpha) = \chi_1(\alpha_q)$ . For  $\alpha \in \overline{Z}(\delta_x W \delta_x W T_n)$ , let  $f_a(X)$  denote the characteristic polynomial of  $\alpha$ . Then we see  $f_\alpha(X) = q^{2\nu+4}\Phi_s(q^{-\nu-2}X)$  for some  $s \in \mathbb{Z}$ . First we treat the contribution  $t_e$  from the elliptic elements. For  $\alpha \in \overline{Z}(\delta_x W \delta_x W T_n)$ , let  $\Phi_s(X)$  be as above, then  $\alpha$  is an elliptic element if and only if  $s^2 - 4n < 0$ . For  $\Phi_s(X) = X^2 - sX + n \in \mathbb{Z}[X]$ , put  $\Psi_s(X)$  $= q^{2\nu+4}\Phi_s(q^{-\nu-2}X)$ , then we have

Let  $\Omega_q(\nu, \Psi_s, \Lambda)$  and  $\Omega'_q(\nu, \Psi_s, \Lambda)$  be as in Th. 2.4 and for  $x \in \Omega_q(\nu, \Psi_s, \Lambda)$  (resp.  $y \in \Omega'_q(\nu, \Psi_s, \Lambda)$ ) let  $\varphi_x(\tilde{X})$  (resp.  $\varphi_y(\tilde{X})$ ) be as in Th. 2.4. Then x (resp. y) runs through a complete system of representatives of  $\{x \in \Omega_q(\nu, \Psi_s, \Lambda) | \varphi_x(\tilde{X}) \in \Xi_q(\delta_z W \delta_z W)\}$  (resp.  $\{y \in \Omega'_q(\nu, \Psi_s, \Lambda) | \varphi'_y(\tilde{X}) \in \Xi_q(\delta_z W \delta_x W)\}$  modulo  $q^{\nu+\rho}$ , where  $\rho$  is a non-negative integer such that  $[\Lambda_q: \mathbb{Z}_q[\tilde{X}]] = q^{\rho}$ . Now by the definition of  $\Xi_q(\delta_z W \delta_z W)$ , we see  $[\Lambda_q: \mathbb{Z}_q[\tilde{X}]]$ must be  $q^{\nu+1}$ , hence  $\rho = \nu + 1$ . Assume  $\Lambda_q$  is such an order. We note for  $K(\Psi_s) = \mathbf{Q}[X]/(\Psi_s(X))$  and  $K(\Phi_s) = \mathbf{Q}[Y]/(\Phi_s(Y))$  there exists an isomorphism  $\lambda$  of  $K(\Psi_s)$  to  $K(\Phi_s)$  such that  $\lambda(\tilde{X}) = q^{\nu+2}\tilde{Y}$ , and for a Zorder  $\Lambda$  of  $K(\Psi_s)$ ,  $[\Lambda_q: \mathbb{Z}_q[\tilde{X}]] = q^{\nu+1}$  if and only if  $[\mathbb{Z}_q[\tilde{Y}]: \lambda(\Lambda_q)] = q$ . The contribution from the hyperbolic elements can be treated in the same way by noting that  $|C_{\infty}(\alpha, \Lambda) \cap U_{\infty}/\tilde{U}_{\infty}|$ = 1 for a hyperbolic element  $\alpha$  fixing a cusp of  $\Gamma_0(q^{\nu})$  and that the class number of the order  $\Lambda$  of  $\mathbb{Q} \oplus \mathbb{Q}$  such that  $[\mathbb{Z} \oplus \mathbb{Z}: \Lambda] = m$  is given by  $\varphi(m)$  with the Euler function  $\varphi$ , and we obtain

Thus we have

Now we shall calculate the contribution  $t_p$  from the parabolic elements. If  $\mathcal{E}(\delta_{\chi}W\delta_{\chi}WT_n)_p$  is not empty, n is a square, and the characteristic polynomial  $f_{\alpha}$  of an element  $\alpha$  of  $\mathcal{E}(\delta_{\chi}W\delta_{\chi}WT_n)_p$  is either  $(X - q^{\nu+2}\sqrt{n})^2$  or  $(X + q^{\nu+2}\sqrt{n})^2$ . Since the contributions from the parabolic elements with the characteristic polynomial  $(X - q^{\nu+2}\sqrt{n})^2$  and from those with the characteristic polynomial  $(X + q^{\nu+2}\sqrt{n})^2$  are the same, it is enough to consider only the parabolic element  $\alpha$  with  $f_a(X) = (X - q^{\nu+2}\sqrt{n})^2$ . Put  $\Psi(X)$  $= (X - q^{\nu+2}\sqrt{n})^2$  and  $\Phi(X) = (X - \sqrt{n})^2$ , then we have

where  $\varphi$  is the isomorphism of  $K(\Psi)$  to  $Q[\alpha]$  such that  $\varphi(\tilde{X}) = \alpha$  and  $\Lambda$ runs through all Z-order of  $K(\Psi)$  such that  $\Lambda \ni \tilde{X}$ . As in the case of elliptic elements, we see  $[\Lambda_q: \mathbb{Z}_q[\tilde{X}]]$  must be  $q^{\nu+1}$ , and for such an order  $\varphi'_y(X) \notin \Xi_q(\delta_x W \delta_x W)$  for  $y \in \Omega'_q(\nu, \Psi, \Lambda)$ . If  $\nu$  is odd, for  $x \in Z_q, \Psi(x) \equiv 0$  $(\mod q^{3\nu+2})$  implies  $\Psi(x) \equiv 0 \pmod{q^{3\nu+3}}$ , hence  $\mathcal{E}(\delta_x W \delta_x W T_n)_p$  is empty in this case. Assume  $\nu$  is even. Put  $\Omega = \{x \in \mathbb{Z}_q | \Psi(x) \equiv 0 \pmod{q^{3\nu+2}}, \Psi(x) \neq 0$  $(\mod q^{\mathfrak{z}_{\nu+3}})\}$  for  $\nu \geq 4$  and  $\Omega = \{x \in Z_q | \mathcal{V}(x) \equiv 0 \pmod{q^{\mathfrak{s}}}, \mathcal{V}(x) \not\equiv 0 \pmod{q^{\mathfrak{s}}},$  $x \not\equiv 2q^4 \sqrt{n} \pmod{q^5}$  for  $\nu = 2$ . Then  $\{\varphi_x(\tilde{X}) \mid x \in \Omega \pmod{q^{2\nu+1}}\}$  gives a complete system of representatives of  $C_q(\alpha, \Lambda) \cap \mathcal{Z}_q(\delta_{\chi} W \delta_{\chi} W) / \tilde{U}_q$  for  $\alpha$  with the minimal polynomial  $\mathscr{V}$ . We see  $\chi_1(\varphi_x(\tilde{X})) = 1$  for  $x \in \mathscr{Q}$  and  $|\mathscr{Q}(\mod q^{2\nu+1})|$  $|=q^{\nu/2}(1-1/q) \text{ if } \nu \geq 4 \text{ and } |\Omega(\mathrm{mod} \ q^5)|=(q-2) \text{ if } \nu=2.$  Let  $\alpha$  $\in \mathcal{Z}(\delta_{\chi}W\delta_{\chi}WT_n)_p$  be an element such that  $f_{\alpha} = \mathcal{V}, \ Q[\alpha] \cap R(q^{\nu}) = \varphi(\Lambda)$ , and put  $[\Lambda: \mathbf{Z}[\tilde{X}]] = mq^{\nu+1}$  with a positive integer m prime to q, then  $m(\alpha)$  $=q^{\nu+1}m/q^{\nu+2}\sqrt{n}=m/(q\sqrt{n})$ . We note  $|C_{\infty}(\alpha, \Lambda)\cap U_{\infty}/\tilde{U}_{\infty}|=2$  for  $\alpha$  with the minimal polynomial  $\Psi$  and  $h(K(\Psi), \Lambda) = 1$  for any Z-order  $\Lambda$  of  $K(\Psi)$ . Let  $t_{1}$  (resp.  $t_{2}$ ) denote the contribution from the elliptic elements with the characteristic polynomial  $X^{2} + q^{2\nu+4}$  (resp.  $X^{2} + q^{\nu+2}X + q^{2\nu+4}$  or  $X^{2} - q^{\nu+2}X + q^{2\nu+4}$ ). Put  $\Phi(X) = X^{2} + 1$ . If the equation  $\Phi(X) \equiv 0$ (mod  $q^{\nu-2}$ ) has a solution, then  $\Phi(X) = (X - \alpha)(X - \beta)$  with some  $\alpha, \beta \in \mathbb{Z}_{q}$ . Since we have  $\alpha - \beta \equiv 0 \pmod{q}$ , all the solutions of  $\Phi(X) \equiv 0 \pmod{q^{\nu-2}}$ are given by  $\{\alpha + q^{\nu-2}\alpha' | \alpha \in \mathbb{Z}_{q}\} \cup \{\beta + q^{\nu-2}\beta' | \beta' \in \mathbb{Z}_{q}\}$ . where  $\mathcal{E}(\delta_{\chi}W\delta_{\chi}T_{n})_{e}$  (resp.  $\mathcal{E}(\delta_{\chi}W\delta_{\chi}T_{n})_{h}$ ; resp.  $\mathcal{E}(\delta_{\chi}W\delta_{\chi}T_{n})_{p}$ ) denotes the set of all elliptic elements (resp. hyperbolic elements fixing cusps of  $\Gamma_{0}(q^{*})$ ; resp. parabolic elements fixing cusps of  $\Gamma_{0}(q^{*})$ ) in  $\mathcal{E}(\delta_{\chi}W\delta_{\chi}T_{n})$  and the other notation is the same as in (2.4). We can express  $\operatorname{tr} \delta_{\chi}W\delta_{\chi}T_{n} | S_{\epsilon}(\Gamma_{0}(q^{*}))$ in a more explicit form, namely, we can prove

Here s runs through all integers such that  $q^{2\nu+2}s^2 - 4q^{\nu+4}n < 0$ , and  $\zeta, \eta$  are the solutions of  $X^2 - q^{\nu+1}sX + q^{\nu+4}n = 0$ . f runs through all positive integers prime to q such that  $f^2|(q^{2\nu+2}s^2 - 4q^{\nu+4}n)$  and  $(q^{2\nu+2}s^2 - 4q^{\nu+4}n)/f^2 \equiv 0$  or  $1 \pmod{4}$ . d runs through all positive integers such that  $d|n, 0 < d < \sqrt{n}$ , and  $d + n/d \equiv 0 \pmod{q^{\nu/2-1}}$ .

*Proof.* As in the case of  $\chi_1$ , for  $\alpha \in \prod_{p \neq q} \Xi_p(n) \times \Xi_q(\delta_r W \delta_r) \times U_{\infty}$ ,  $\chi_2(\alpha)$  depends only on the  $U_q$ -conjugacy class of the q-component  $\alpha_q$  of  $\alpha$  and  $\chi_2(\alpha) = \chi_2(\alpha_q)$ . By the definition of  $\mathcal{Z}(\delta_x W \delta_x T_n)$ , the characteristic polynomial  $f_{\alpha}$  of  $\alpha$  in  $\mathcal{E}(\delta_{x}W\delta_{x}T_{n})$  is of the form  $\Psi_{s}(X) = X^{2} - q^{\nu+1}sX + q^{\nu+4}n$ for some integer s. Let  $\Lambda$  be a Z-order of  $K(\Psi_s)$  such that  $Q[\alpha] \cap R(q^{\nu})$  $\varphi(\Lambda)$ , then we see  $[\Lambda_q: \mathbb{Z}_q[\tilde{X}]]$  must be  $q^2$ , where  $\varphi$  is an isomorphism of  $K(\Psi_s)$  to  $Q[\alpha]$  such that  $\varphi(\tilde{X}) = \alpha$ . First we calculate the contribution  $t_e$  from the elliptic elements. An elements  $\alpha \in \mathcal{Z}(\delta_{\tau}W\delta_{\tau}T_{\tau})$  with  $f_{\alpha} = \Psi_s$  is elliptic if and only if  $q^{2\nu+2}s^2 - 4q^{\nu+4}n < 0$ . Let  $\Lambda$  be a Z-order of  $K(\Psi_s)$ such that  $[\Lambda_q: \mathbb{Z}_q[\tilde{X}]] = q^2$ . For  $x \in \Omega_q(\nu, \Psi_s, \Lambda)$  (resp.  $y \in \Omega'_q(\nu, \Psi_s, \Lambda)$ ), we see  $v_q(x) = v_q(q^{\nu+1}s - x) = \nu + 1$  (resp.  $v_q(y) = v_q(q^{\nu+1}s - y) = \nu + 1$ ) if  $\varphi_x(\tilde{X}) \in \Xi_q(\delta_x W \delta_x)$  (resp.  $\varphi'_u(\tilde{X}) \in \Xi_q(\delta_x W \delta_x)$ ). If  $\nu \ge 3$ ,  $\varphi'_u(\tilde{X}) \notin \Xi_q(\delta_x W \delta_x)$  for  $y \in \Omega'_{a}(\nu, \Psi_{s}, \Lambda)$ , and put  $\Omega = \{q^{\nu+1}x' | x' \in Z_{a}, x' \not\equiv s \pmod{q}\}$ , then  $\{\varphi_{x}(\tilde{X}) | x' \in Z_{a}, x' \not\equiv s \pmod{q}\}$  $\in \Omega \pmod{q^{\nu+2}}$  gives a complete system of representatives of  $\{\alpha \in \Xi_{\alpha}(\delta, W\delta_{\nu}) | f_{\alpha} \in U_{\alpha}(\delta, W\delta_{\nu}) \}$  $= \Psi_s / \tilde{U}_q$  and  $\chi_2(\varphi_x(\tilde{X})) = \chi(x'(s-x'))$ . If  $\nu = 2$ , put  $\Omega = \{q^3x' \mid x' \in Z_q^{\times}, x' \not\equiv s\}$  $(\text{mod } q), x'^2 - sx' + n \not\equiv 0 \pmod{q}$  and  $\Omega' = \{q^3y' | y' \in Z_q, y'^2 - sy' + n \equiv 0$ (mod q), then we see  $\{\varphi_x(\tilde{X}) | x \in \Omega \pmod{q^4}\} \cup \{\varphi'_y(\tilde{X}) | y \in \Omega' \pmod{q^4}\}$  gives a complete system of representatives of  $\{\alpha \in \mathbb{Z}_q(\delta_{\alpha} W \delta_{\alpha}) | f_{\alpha} = \Psi_s\}/\tilde{U}_q$  and  $\chi_2(\varphi_x(\tilde{X})) = \chi(x'(s-x')), \chi_2(\varphi_y(\tilde{X})) = \chi(y'(s-y')).$  Our assertion on  $t_e$  follows from this in the same way as in the case of  $\delta_x W \delta_x W T_n$ . If  $\nu$  is odd, we see easily  $\mathcal{Z}(\delta_{\tau}W\delta_{\tau}T_{n})_{h}$  is empty, hence  $t_{h} = 0$ . Assume  $\nu$  is even, and let  $\alpha$  be an element of  $\mathcal{Z}(\delta_{\chi}W\delta_{\chi}T_{n})_{h}$  with  $f_{\alpha} = \Psi_{s}$  for some integer s. Let  $q^{\nu_1}n_1$  and  $q^{\nu_2}n_2$  be the solutions of  $\Psi_s(X) = 0$ , then  $\nu_1 + \nu_2 = \nu + 4$  and  $n = n_1 n_2$ . Since  $(q^{\nu_1} n_1 - q^{\nu_2} n_2)^2 = (q^{\nu+1} s)^2 - 4q^{\nu+4} n = q^{\nu+4} (q^{\nu-2} s^2 - 4n), \nu_1 = \nu_2$ 

 $= (\nu + 4)/2$  and  $s = q^{(\nu+4)/2}(n_1 + n_2)$ . Hence  $\Psi_s$  is of the form  $X^2 \pm q^{(\nu+4)/2}$  $(d + n/d)X + q^{\nu+4}n$  for d, where d satisfies  $d \mid n, 0 < d < \sqrt{n}$  and d + n/d $\equiv 0 \pmod{q^{\nu/2-1}}$ . Thus our assertion on  $t_n$  can be proved in the same way as above. Finally we treat the contribution from the parabolic elements. If  $(q^{\nu+2}s)^2 - 4q^{\nu+4}n = 0$  for an integer  $s, \nu$  must be 2 since we assume n is prime to q. Hence  $\mathcal{E}(\delta_{\chi}W\delta_{\chi}T_n)_p$  is empty if  $\nu \geq 3$ , and  $t_p = 0$ . Assume  $\nu = 2$  and n is a square, then the characteristic polynomial  $f_{\alpha}$  of  $\alpha$  in  $\mathcal{E}(\delta_{\chi}W\delta_{\chi}T_n)_p$  is of the form  $\Psi_s(X) = X^2 - q^3sX + q^6n$  for  $s = \pm 2\sqrt{n}$ . Let  $\Lambda$  be a Z-order of  $K(\Psi_s)$  such that  $\mathbf{Q}[\alpha] \cap R(q^{\nu}) = \varphi(\Lambda)$ , then  $[\Lambda_q: \mathbb{Z}_q[\tilde{X}]] = q^2$ . If we put  $[\Lambda: \mathbb{Z}[\tilde{X}]] = mq^2$  with m prime to q, then  $m(\alpha) = m/(\sqrt{n}q)$ . In the same way as above, we obtain

Thus the proof of our theorem is completed.

### §4. The case $q^{\nu} = 11^3$

In this section, we shall make some numerical observation on  $S_2^o(\Gamma_0(11^3))$ , which is of dimension 100, using the formulae obtained in §2 and §3. As was shown in §1,  $S_2^o(\Gamma_0(11^3))$  decomposes into 4 subspaces  $S_{I}$ ,  $S_{II}$ ,  $S_{II}$ ,  $S_{IIZ}$ , and  $S_{III}$ . We find dim  $S_{I} = 15$ , dim  $S_{II} = \dim S_{IIZ} = 25$ , and dim  $S_{III} = 35$ . Now we take the space  $S_{I}$  and give the characteristic polynomials of the Hecke operators  $T_n$  acting on  $S_{I}$  for several n, whose roots give n-th Fourier coefficients  $a_n$  for some primitive form  $f(z) = \sum_{n=1}^{\infty} a_n e^{2\pi i nz}$  in  $S_{I}$ .

For an explanation of this table, we remark the space  $S_{I}$  decomposes into the 5-dimensional space  $S_{I_1}$  and the 10-dimensional space  $S_{I_2}$ . As was proved in [13], we have ten primitive forms in  $S_2^0(\Gamma_0(11^3))$ , which correspond to the *L*-functions of  $Q(\sqrt{-11})$  with Grössencharacters. By the following lemma, we know five such primitive forms spann the space  $S_{I_1}$ and the remaining five primitive forms are contained in  $S_{III}$ .

LEMMA 4.1. Let q be a prime such that  $q \equiv 3 \pmod{4}$ , q > 3, and  $\kappa$  be an even positive integer. Let  $\lambda$  be a Grössencharacter of  $Q(\sqrt{-q})$  with the conductor (q) which satisfies

$$\lambda((a)) = \left(\frac{a}{|a|}\right)^{\epsilon-1}$$

for  $a \in Q(\sqrt{-q})$  with  $a \equiv 1 \mod^{\times} (q)$  and  $\chi(a)\lambda((a)) = 1$  for  $a \in \mathbb{Z}$ . For an integer a in  $Q(\sqrt{-q})$ , put  $\lambda_0(a) = \lambda((a))\left(\frac{a}{|a|}\right)^{-(\epsilon-1)}$  and let  $x_0$  be a rational integer such that

$$\lambda_0(1 + a\sqrt{-q}) = e^{2\pi i a x_0/q}$$

for  $a \in \mathbb{Z}$ . Then the primitive cusp form  $f_{\lambda}(z) = \sum_{\alpha} \lambda(\alpha) N(\alpha)^{(\kappa-1)/2} e^{2\pi i N(\alpha) z}$  corresponding to  $\lambda$  is contained in  $S^{0}_{\kappa}(\Gamma_{0}(q^{3}))$  and satisfies

$$|f_\lambda| W = (-i)^{\iota} \chi(-2) \chi(x_0) f_\lambda$$
 .

*Proof.* Comparing the functional equation of the L-function of  $\lambda$  with that of cusp forms in  $S^{\circ}_{\epsilon}(\Gamma_{0}(q^{3}))$ , we obtain

$$f_{\lambda}|W = (-i)^{\kappa}T(\lambda)f_{\lambda}$$

where  $T(\lambda) = \frac{1}{q} \sum_{a \mod (q)} \lambda_0(a) e^{2\pi i \operatorname{tr} (a/q \sqrt{-q})}$ . By an easy calculation, we have  $T(\lambda) = \chi(-2)\chi(x_0)$ , and this completes the proof.

Hereafter we restrict our discussion to the 10-dimensional space  $S_{I_2}$ , which is closely related to Shimura's theory on the construction of class fields over real quadratic fields. Let us fix a primitive form  $f(z) = \sum_{n=1}^{\infty} a_n e^{2\pi i n z} \in S_{I_2}$ , and let K denote the field generated over Q by  $a_n$ for all n. Then as the table shows, K and f(z) satisfy the assumption (\*) in § 1. Let  $F_{11}$  be the maximal real subfield of  $Q(e^{2\pi i/11})$ , and put  $\alpha_0$  $= e^{2\pi i/11} + e^{-2\pi i/11}$ . Since  $\sqrt{3-\alpha_0}$  satisfies  $X^{10} - 16X^8 + 98X^8 - 285X^4$  $+ 390X^2 - 199 = 0$ , we may put  $a_2 = \sqrt{3-\alpha_0}$  and  $K = F_{11}(\sqrt{3-\alpha_0})$ . Then we find

$$a_2=\sqrt{3-lpha_0}\;,\;\;\;a_3=lpha_0\;,\;\;\;a_5=lpha_0^4-4lpha_0^2+1\;, 
onumber \ a_{199}=-12lpha_0^4-lpha_0^3+44lpha_0^2-9lpha_0-33\;.$$

(These Fourier coefficients are obtained from tr  $T_n$  for several composite integers n, which are not given here.) We remark f(z) and its companions  $f_{\sigma}(z) = \sum_{n=1}^{\infty} a_n^{\sigma} e^{2\pi i n z}$  spann the space  $S_{I_2}$ , where  $\sigma$  runs over all isomorphisms of K into C, and the invariant subfield F of K under  $\rho$  which is defined in § 1 is  $F = F_{11}$ . In the following we follow the notation in § 1. Since f satisfies (\*), we can associate with f a triple  $(A, \mu, \theta)$  and an endomorphism  $\eta$  of A defined over  $k = Q(\sqrt{-11})$  corresponding to  $\chi$ . Let  $o_k$  denote the ring of all integers in k. In the present case, we see  $b = b_0$  $= (\sqrt{3 - \alpha_0})$  and  $c = (3 - \alpha_0)$ , and the condition (\*\*) is satisfied with, e.g., e = 136. Hence we can define an  $o_K$ -module  $g = \{t \in A | \theta(b)t = 0\}$  and an  $o_F$ -module  $\mathfrak{h} = \{t \in g | (\eta - \theta(e))t = 0\}$ . Let  $k(\mathfrak{h})$  be as in § 1, then from the action of Gal  $(k(\mathfrak{h})/k)$  on  $\mathfrak{h}$ , we obtain an injective homomorphism

$$r' \colon \operatorname{Gal} (k(\mathfrak{y})/k) o (\mathfrak{o}_F/\mathfrak{c})^{ imes} \simeq (Z/199Z)^{ imes} ,$$

and put  $r(a) = r'\left(\left(\frac{k(y)/k}{a}\right)\right)$ .

PROPOSITION 4.2. The field k(y) is a ray class field over k of conductor 111 with a prime factor 1 of 199 in k, and one has

$$r((\alpha)) = \varphi(\alpha)\mu(\alpha \bmod l) ,$$

for every  $\alpha$  in k prime to 11*l*, where  $\mu$  is the isomorphism of  $o_k/l$  onto  $o_F/(3 - \alpha_0)$  and  $\varphi$  is a homomorphism of  $(o_k/(11))^{\times}$  into  $(o_F/(3 - \alpha_0))^{\times}$  of order 22 such that

$$\varphi(m) = \chi(m)$$

for  $m \in Z$ .

**Proof.** Since every prime factor of the conductor  $\mathfrak{f}$  of  $k(\mathfrak{y})/k$  divide  $N(\mathfrak{l})N = 199 \cdot 11^{\mathfrak{s}}$  (see Shimura [12, § 7.5, p. 181 and Prop. 7.23]), we may put  $\mathfrak{f} = \prod_{\mathfrak{p}} \mathfrak{p}^{f_{\mathfrak{p}}}$ , where  $\mathfrak{p}$  runs through all prime factors of  $199 \cdot 11$ . By the same argument as in the proof of [14, Th. 2.3] we first obtain

$$r((m)) = \chi(m)\mu(m \bmod l)$$

for every  $m \in \mathbb{Z}$  prime to  $199 \cdot 11$ . So we have  $[k(\mathfrak{y}):k] = 99$  or 198, and the l-component  $f_{\mathfrak{l}} = 1$  by [14, Lemma 7.32]. To determine  $f_{\mathfrak{l}}$ , we use the following fact which is nothing but [14, Th. 2.8] for the present case.

Let *l* be a rational prime which divides N(c) but not  $N = 11^3$ . Suppose that  $\chi(l) = 1$ , and  $\alpha_l$  is prime to  $c = (3 - \alpha_0)$ . Then f is divisible by only one of the prime factors of *l* in *k*. Moreover if  $\iota$  denotes the factor of *l* which divides f, then

$$r(\mathfrak{l}^{\mathfrak{s}}) \equiv a_{\mathfrak{l}} \mod \mathfrak{c}$$
.

Take l = 199. Since  $a_{199}$  is prime to 199, one has  $f_{1*} = 0$ . Hence  $f = (\sqrt{-11})^m l$  for some positive integer m. Owing to Hasse's conductor ramification theorem, we have  $1 \le m \le 2$ . Thus we have

$$r((\alpha)) = \varphi(\alpha)\mu(\alpha \bmod \mathfrak{l})$$

for every  $\alpha$  in k prime to 11l with a homomorphism  $\varphi$  of  $(o_k/(11))^{\times}$  into  $(o_F/c)^{\times}$  and the isomorphism  $\mu$  of  $o_k/l$  onto  $o_F/c$ . The order of  $\varphi$  is determined as follows. Because  $r(l^{\epsilon}) \equiv a_{199} \equiv 133 \mod (3 - \alpha_0)$ , we have  $\varphi(l^{\epsilon}) \equiv 136 \pmod{199}$ . Therefore the order of  $\varphi$  is 22. Hence m = 2 and f = 11l. This completes the proof of our proposition.

Remark 4.3. Let  $p \ (\neq 199)$  be a rational prime such that  $\chi(p) = 1$ , then p decomposes into two distinct primes  $\mathfrak{p} = (\gamma)$  and  $\mathfrak{p}^{\mathfrak{e}} = (\gamma^{\mathfrak{e}})$  in k $= \mathbf{Q}(\sqrt{-11})$ .  $\gamma$  can be so chosen as  $p = \gamma\gamma^{\mathfrak{e}}, \chi(\gamma + \gamma^{\mathfrak{e}}) = 1$ . Observe that  $\varphi(\gamma^{11}) = \chi(-\gamma - \gamma^{\mathfrak{e}}) = -1$ . Let  $\pi$  and  $\pi'$  be the solutions of  $X^2 - a_p X + p$  $\equiv 0 \mod (3 - \alpha_0)$ . Then by [14, Th. 2.3], we have

$$\pi^{11} + \pi'^{11} \equiv -\gamma^{11} - (\gamma^*)^{11} \mod (3 - lpha_{\scriptscriptstyle 0}) \; .$$

Remark 4.4. Let  $\alpha_0 = e^{2\pi i/11} + e^{-2\pi i/11}$  as above. We note  $\alpha_0$  is one of the fundamental units of  $F_{11}$ , and we have  $N_{F_{11}/Q}(\alpha_0^{11}-1) = 23^2 \cdot 67 \cdot 199$ . As was indicated in [4] for the case of  $q = 7^3$ , the prime N(c) = 199 seems to be closely related to the factor 199 of  $N_{F_{11}/Q}(\alpha_0^{11}-1)$ .

Let us consider the endomorphism algebra  $\operatorname{End}_{Q}(A)$ . Put  $\delta = \sqrt{3} - \alpha_{0}$ , then  $\theta(\delta)$  and  $\eta$  generate a quaternion subalgebra  $\mathfrak{A}$  of  $\operatorname{End}_{Q}(A)$  over  $F = F_{11}$ . Since  $\delta^{2} = (3 - \alpha_{0}) \in N_{F(\sqrt{-11})/F}(F(\sqrt{-11}))$ ,  $\mathfrak{A}$  is isomorphic to  $M_{2}(F)$ . Denote by ' the canonical involution of  $\mathfrak{A}$ . Then we can find an element  $\xi = a + b\theta(\delta) + c\eta + d\theta(\delta)\eta$  in  $\mathfrak{A}$  with  $a, b, c, d \in \theta(\mathfrak{o}_{F}) \cap \operatorname{End}(A)$  such that  $\xi\xi' = 0$  and  $\xi^{2} = e$  with  $e \in \theta(\mathfrak{o}_{F}) \cap \operatorname{End}(A)$ . Define an abelian subvariety B of A by

$$\xi B = A \; .$$

Then B is rational over  $k, A = B + B^{\epsilon}$  and  $B^{\epsilon} = \xi^{\epsilon}A$ . We can easily verify that  $B \cap B^{\epsilon}$  is a finite group annihilated by  $(e - 2b\theta(\delta))$ . Denote by  $\theta_F(a)$  the restriction of  $\theta(a)$  to B for  $a \in F$ , then we have an isomorphism  $\theta_F$  of F into End<sub> $\theta$ </sub> (B).

PROPOSITION 4.5. The notation being as above, the abelian variety B is simple and  $\operatorname{End}_{Q}(B) = \theta_{F}(F)$ .

**Proof.** Let  $\varphi_p$  be the *p*-th power Frobenius endomorphism of *B* modulo  $\mathfrak{p}$ , where  $\mathfrak{p}$  is a prime ideal in *k* such that  $N\mathfrak{p} = p$ . By the table, we know that  $F(\varphi_3) \neq F(\varphi_5)$ . Therefore by the same argument as that of [12, Th. 7.39], we obtain our proposition.

### §5. The case $q^* = 19^2$

In this section, we shall study particularly the case  $\nu = 2$ , and give an example for  $q^{\nu} = 19^2$ . Let  $\psi$  be a character modulo q. Then for  $f = \sum_{n=1}^{\infty} a_n e^{2\pi i n z} \in S_{\epsilon}(\Gamma_0(q), \psi^2)$ , put  $f_{\bar{\psi}} = \sum_{n=1}^{\infty} a_n \bar{\psi}(n) e^{2\pi i n z}$ , then by [13, Prop. 3.64], we know  $f_{\psi} \in S_{\epsilon}(\Gamma_0(q^2))$ . Put  $S_{\epsilon}(\Gamma_0(q), \psi^2)^{\bar{\psi}} = \{f_{\bar{\psi}} | f \in S_{\epsilon}(\Gamma_0(q), \psi^2) \}$ ,  $S_{\epsilon}(SL_2(Z))^{\chi} = \{f_{\chi} | f \in S_{\epsilon}(SL_2(Z))\}$  and  $S_{\epsilon}^0(\Gamma_0(q))^{\chi} = \{f_{\chi} | f \in S_{\epsilon}^0(\Gamma_0(q))\}$ . Then by [8, Prop. 7.1 and Prop. 7.2], we know  $S_{\epsilon}^0(\Gamma_0(q))^{\chi} \oplus S_{\epsilon}(SL_2(Z))^{\chi}$ , where the sum  $\bigoplus_{\{\psi\},\psi^2\neq 1} S_{\epsilon}(\Gamma_0(q),\psi^2) \oplus S_{\epsilon}^0(\Gamma_0(q))^{\chi} \oplus S_{\epsilon}(SL_2(Z))^{\chi}$ , where the sum  $\bigoplus_{\{\psi\},\psi^2\neq 1}$  runs over a set of representatives of the pairs  $\{\psi,\bar{\psi}\},\psi^2\neq 1$ , of the characters of  $(Z/qZ)^{\times}$ . Let  $S_{\epsilon}^n(\Gamma_0(q^2))$  denote the orthogonal complement of  $S_{\epsilon}^0(\Gamma_0(q))^{\chi} \oplus S_{\epsilon}(SL_2(Z))^{\chi}$  in  $S_{\epsilon}^0(\Gamma_0(q^2))$  with respect to the Petersson inner product. Then  $S_{\epsilon}^n(\Gamma_0(q^2))$  is closed under the action of  $W, \delta_{\chi}$  and Hecke operators  $T_n$ . Hence as in the case  $\nu \geq 3$ , we can define the subspaces  $S_{\Gamma}, S_{\Gamma}, S_{\Gamma}, S_{\Gamma}$  satisfying  $S_{\epsilon}^n(\Gamma_0(q^2)) = S_{\Gamma} \oplus S_{\Gamma} \oplus S_{\Gamma_{\Gamma}} \oplus S_{\Gamma_{\Gamma}}$ 

$$\begin{split} S_{\mathrm{I}} &= \{ f \in S_{\star}^{n}(\Gamma_{0}(q^{2})) \mid f \mid W = f, f \mid \delta_{\chi} W = f \mid \delta_{\chi} \} \\ S_{\mathrm{II}} &= \{ f \in S_{\star}^{n}(\Gamma_{0}(q^{2})) \mid f \mid W = f, f \mid \delta_{\chi} W = -f \mid \delta_{\chi} \} \\ S_{\mathrm{II}_{\chi}} &= \{ f \in S_{\star}^{n}(\Gamma_{0}(q^{2})) \mid f \mid W = -f, f \mid \delta_{\chi} W = f \mid \delta_{\chi} \} \\ S_{\mathrm{III}} &= \{ f \in S_{\star}^{n}(\Gamma_{0}(q^{2})) \mid f \mid W = -f, f \mid \delta_{\chi} W = -f \mid \delta_{\chi} \} . \end{split}$$

By the following lemma we know to which subspace  $f_{\bar{\psi}}, \psi^2 \neq 1$ , belongs.

LEMMA 5.1. Let  $\psi$  be a character modulo q and f be an element of  $S_{*}(\Gamma_{0}(q), \psi^{2})$ . Then one has

$$f_{\scriptscriptstyle \overline{\Psi}} ert W = \psi(-1) f_{\scriptscriptstyle \overline{\Psi}}$$
 .

*Proof.* For  $u \in \mathbb{Z}$ , put  $\alpha_u = \begin{pmatrix} 1 & u/q \\ 0 & 1 \end{pmatrix}$ , then we have

$$f_{\psi} = \frac{1}{W(\psi)} \sum_{u=1}^{q-1} \psi(u) f | [\alpha_u]_{\varepsilon} ,$$

where  $W(\psi)$  is the Gaussian sum of  $\psi$ . Hence we have

Since (u, q) = 1, there exist  $c, d \in \mathbb{Z}$  such that ud - qc = 1. Then we see

and  $f \Big| \begin{bmatrix} \alpha_u \begin{pmatrix} 0 & -1 \\ q^2 & 0 \end{bmatrix} \Big|_{\epsilon} = \overline{\psi}^2(u) f \Big| \begin{bmatrix} \begin{pmatrix} -1 & d/q \\ 0 & -1 \end{bmatrix} \Big|_{\epsilon}$ . Therefore we obtain

This completes the proof.

To calculate tr  $T_n$  on each subspace  $S_I$ ,  $S_{II}$ , etc., we need the following lemma.

LEMMA 5.2. Let n be a positive integer prime to q.

i) Put  $S(1) = S_{\epsilon}(SL_2(Z)) \oplus S_{\epsilon}(SL_2(Z))^q \oplus S_{\epsilon}(SL_2(Z))^{q^2} \oplus S_{\epsilon}(SL_2(Z))^{x}$ , where  $S_{\epsilon}(SL_2(Z))^m = \{f(mz) | f \in S_{\epsilon}(SL_2(Z))\}$  for a positive integer m. Then one has

$$\mathrm{tr}\, \delta_{\chi} W \delta_{\chi} T_n \,|\, S(1) = (\chi(-1) + q^{-1}) \,\mathrm{tr}\, T_n \,|\, S_{\star}(SL_2(Z)) \ \mathrm{tr}\, \delta_{\chi} W \delta_{\chi} W T_n \,|\, S(1) = 2q^{-1} \chi(-1) \,\mathrm{tr}\, T_n \,|\, S_{\star}(SL_2(Z)) \;.$$

ii) Put  $S(q) = S^{\mathfrak{o}}_{\mathfrak{c}}(\Gamma_{\mathfrak{o}}(q)) \oplus S^{\mathfrak{o}}_{\mathfrak{c}}(\Gamma_{\mathfrak{o}}(q))^{\mathfrak{a}} \oplus S^{\mathfrak{o}}_{\mathfrak{c}}(\Gamma_{\mathfrak{o}}(q))^{\mathfrak{a}}$ , where  $S^{\mathfrak{o}}_{\mathfrak{c}}(\Gamma_{\mathfrak{o}}(q))^{\mathfrak{a}} = \{f(qz) | f \in S^{\mathfrak{o}}_{\mathfrak{c}}(\Gamma_{\mathfrak{o}}(q))\}$ . Then one has

$$\mathrm{tr}\, \delta_\chi W \delta_\chi T_n \,|\, S(q) = (\chi(-1) + q^{-1}) \,\mathrm{tr}\, T_n \,|\, S^{0}_{\star}(\Gamma_{\mathfrak{d}}(q)) \ \mathrm{tr}\, \delta_\chi W \delta_\chi W T_n \,|\, S(q) = 2q^{-1}\chi(-1) \,\mathrm{tr}\, T_n \,|\, S^{0}_{\star}(\Gamma_{\mathfrak{d}}(q)) \;.$$

*Proof.* We prove only the formula for  $\operatorname{tr} \delta_{\chi} W \delta_{\chi} T_n$  in the case of ii). The other cases can be treated in the same way. If f is contained in  $S^{0}_{\star}(\Gamma_{0}(q))^{q}$ , obviously  $f|\delta_{\chi}W\delta_{\chi}T_{n}=0$ . Let f be a primitive form in  $S^{0}_{\star}(\Gamma_{0}(q))$ , then we have by Lemma 5.1

(5.1) 
$$f|\delta_{\chi}W\delta_{\chi} = \chi(-1)f_{\chi}|\delta_{\chi} = \chi(-1)(f(z) - a_{q}f(qz)).$$

Let  $f = g_{\chi}$  for a primitive form g(z) in  $S^{\circ}_{\epsilon}(\Gamma_{\circ}(q))$ , and  $b_{q}$  be the q-th Fourier coefficient of g. Put  $g | \begin{bmatrix} \begin{pmatrix} 0 & -1 \\ q & 0 \end{pmatrix} \end{bmatrix}_{\epsilon} = \epsilon g$ , then we have

(5.2) 
$$f|\delta_{\chi}W\delta_{\chi} = (g(z) - b_{q}g(qz))|W\delta_{\chi} = (\varepsilon q^{\kappa/2}g(qz) - b_{q}\varepsilon q^{-\kappa/2}g(z))$$
$$= q^{-1}f,$$

since  $\varepsilon = -\bar{b}_q q^{1-k/2}$ . Our assertion follows from (5.1) and (5.2) easily.

By virtue of this lemma, we can express tr  $T_n$  on each space  $S_I$ ,  $S_{II}$ , etc. by using formulae for tr  $T_n$ , tr  $WT_n$ , tr  $\delta_{\chi}W\delta_{\chi}T_n$ , and tr  $\delta_{\chi}W\delta_{\chi}WT_n$ . For example, on  $S_I$ , we have

$$egin{aligned} &\mathrm{tr}\; T_n \,|\, S_{{\scriptscriptstyle \mathbf{z}}}^{_0}({\Gamma_{_0}}(q^2)) + \mathrm{tr}\; WT_n \,|\, S_{{\scriptscriptstyle \mathbf{z}}}^{_0}({\Gamma_{_0}}(q^2)) \ &+ \mathrm{tr}\, \delta_{{\scriptscriptstyle \mathbf{x}}} W \delta_{{\scriptscriptstyle \mathbf{z}}} T_n \,|\, S_{{\scriptscriptstyle \mathbf{z}}}({\Gamma_{_0}}(q^2)) + \mathrm{tr}\, \delta_{{\scriptscriptstyle \mathbf{x}}} W \delta_{{\scriptscriptstyle \mathbf{x}}} WT_n \,|\, S_{{\scriptscriptstyle \mathbf{z}}}({\Gamma_{_0}}(q^2)) \ &- (\chi(-1) + \,q^{-1} + \,2\chi(-1)q^{-1})(\mathrm{tr}\; T_n \,|\, S_{{\scriptscriptstyle \mathbf{z}}}(SL_2(Z)) \oplus S_{{\scriptscriptstyle \mathbf{z}}}^{_0}({\Gamma_{_0}}(q)) \} \,. \end{aligned}$$

Now let us discuss a numerical example in the case where  $q = 19^2$ and  $\kappa = 2$ . We find dim  $S_2^0(\Gamma_0(19^2)) = 20$  and dim  $S_2^0(\Gamma_0(19))^{\chi} = 1$ . In the following we give the characteristic polynomials of Hecke operators  $T_n$ acting on  $S_I$  and  $S_{III}$  for several n. We note  $S_{II} = \bigoplus_{\{\psi\}, \psi^2 \neq 1, \psi(-1) = 1} S_2(\Gamma_0(19), \psi^2)^{\psi}$ .

The one-dimensional part in  $S_{\rm I}$  is obtained by a primitive form corresponding to an *L*-function of the field  $Q(\sqrt{-19})$ . Let  $f = \sum_{n=1}^{\infty} a_n e^{2\pi i n z}$  be a primitive form in the four-dimensional part of  $S_{I}$ . We may assume

(5.3) 
$$a_2 = \sqrt{\frac{5+\sqrt{5}}{2}}, a_5 = -1 - \sqrt{5}, a_7 = -2 + \sqrt{5}$$

(These coefficients are obtained from tr  $T_n$  for several n, which are not given here.) Let K be the field generated over Q by  $a_n$  for all n, then  $K = Q\left(\sqrt{\frac{5+\sqrt{5}}{2}}\right)$ , and we see f and K satisfy the condition (\*) in §1. In this case we have  $F = Q(\sqrt{5})$ ,  $c = (\sqrt{5})$ , and  $k = Q(\sqrt{-19})$  in the notation of §1 and §4. Since the condition (\*\*) is satisfied by taking e = 1, we can consider the  $o_F$ -module v, the extension k(v)/k, and an injective homomorphism

$$r': \operatorname{Gal}(k(\mathfrak{y})/k) \to (\mathfrak{o}_F/\mathfrak{c})^{\times} \simeq (Z/5Z)^{\times}$$
.

Put  $r(a) = r'\left(\left(\frac{k(t)/k}{a}\right)\right).$ 

**PROPOSITION 5.3.** The field  $k(\mathfrak{y})$  is a ray class field of conductor  $(\sqrt{-19})\mathfrak{l}$  with a prime factor  $\mathfrak{l}$  of 5, and one has

$$r((\alpha)) = \varphi(\alpha)\mu(\alpha \bmod l)$$

for every  $\alpha$  in k prime to 191, where  $\mu$  is the isomorphism of  $o_k/($  onto  $o_F/c$ and  $\varphi$  is a homomorphism of  $(o_k/(\sqrt{-19}))^{\times}$  into  $(o_F/c)^{\times}$  of order 2.

This proposition can be proved by virtue of (5.3) in the same way as Prop. 4.2, and we omit the proof. We can show also in this case that there exists a simple abelian subvariety B defined over k of the abelian variety A associated with f such that  $A = B + B^{\epsilon}$  and  $\operatorname{End}_{q}(B) = Q(\sqrt{5})$ , where  $\epsilon$  is the generator of Gal (k/Q).

### §6. Formulae for tr $\delta_x$ and tr $T_g W$

For a character  $\psi$  modulo  $q^{\nu}$  and a positive integer  $\kappa \geq 2$ , let  $S_{\epsilon}(\Gamma_0(q^{\nu}), \psi)$  be as in §1. We assume  $\psi(-1) = (-1)^{\epsilon}$  and the conductor  $\mathfrak{f}_{\psi}$  satisfies  $\mathfrak{f}_{\psi} \leq q^{\nu-1}$ . If  $\nu \geq 2$ , we can define the twisting operator  $\delta_{\chi}$  on  $S_{\epsilon}(\Gamma_0(q^{\nu}), \psi)$  as in §1. Let us express  $\delta_{\chi}$  as an action of double cosets. We use the same notation as in §2. Put  $\Xi_q = U_q \begin{pmatrix} q & 1 \\ 0 & q \end{pmatrix} U_q$ , then we see

For  $g = \begin{pmatrix} a & b \\ c & d \end{pmatrix} \in E_q$ , put

$$\lambda(g) = (\psi \chi)^{-1}(a/q)\chi(b)$$
,

and for  $g \in \prod_{p \neq q} U_p \times {\mathcal Z}_q imes U_{\infty}$ , put

$$\lambda(g)=\lambda(g_q),$$

where  $g_q$  denotes the q-component of g. For  $\gamma = \begin{pmatrix} a & b \\ c & d \end{pmatrix} \in \Gamma_0(q^*)$ , put  $\psi(\gamma) = \psi(a)^{-1}$ . Then for  $g \in (\prod_{p \neq q} U_p \times \Xi_q \times U_\infty) \cap GL_2(Q)$ , we have

(6.1) 
$$\lambda(\gamma_1 g \gamma_2) = \psi(\gamma_1) \lambda(g) \psi(\gamma_2)$$

Let  $(\prod_{p\neq q} U_p \times Z_q \times U_{\infty}) \cap GL_2(\mathbf{Q}) = \bigcup_{u=1}^d \Gamma_0(q^v) \alpha_u$  be a disjoint union. Then by Lemma 2.1 and (6.1), we obtain

$$f|\delta_{\chi} = \frac{1}{W(\chi)} \sum_{u=1}^{d} \lambda(\alpha_{u})^{-1} f|[\alpha_{u}]_{\epsilon}.$$

Now in the case where  $\nu = 1$  and  $\psi = \chi$ , we consider the operator  $T_q W$ . Put

For  $g = \begin{pmatrix} a & b \\ c & d \end{pmatrix} \in \mathcal{Z}_q$ , define

$$\lambda(g)=\chi(b)\;,$$

and for  $g \in \prod_{p \neq q} U_p \times \mathcal{Z}_q \times U_{\infty}$ , put

$$\lambda(g)=\lambda(g_q)\;,$$

where  $g_q$  denotes the q-component of g. Then we have

$$\lambda(\gamma_1 g \gamma_2) = \chi(\gamma_1) \lambda(g) \chi(\gamma_2) \quad \text{for } \gamma_1, \gamma_2 \in \Gamma_0(q) ,$$

where  $\chi(\gamma) = \chi(a)$  for  $\gamma = \begin{pmatrix} a & b \\ c & d \end{pmatrix} \in \Gamma_0(q)$ . Let  $(\prod_{p \neq q} U_p \times \Xi_q \times U_{\infty}) \cap GL_2(Q)$ =  $\bigcup_{u=1}^d \Gamma_0(q) \alpha_u$  be a disjoint union, then we can verify for  $f \in S_{\epsilon}(\Gamma_0(q), \chi)$

$$f|T_qW = q^{\epsilon/2-1}\sum_{u=1}^d \lambda(\alpha_u)^{-1}f|[\alpha_u]_\epsilon$$

THEOREM 6.1. Let  $\psi$  be a character modulo  $q^{\nu}$  with the conductor  $f_{\psi}$  such that  $f_{\psi} \leq q^{\nu-1}$ , and  $\kappa$  be a positive integer such that  $\kappa \geq 2$ . Assume  $q \geq 5$  and  $\psi(-1) = (-1)^{\epsilon}$ . If  $\nu \geq 2$ , one has

(6.2) 
$$\operatorname{tr} \delta_{\chi} | S_{\mathfrak{s}}(\Gamma_{0}(q^{\nu}), \psi) = \begin{cases} q^{\nu-1-\lfloor \nu/2 \rfloor} \frac{1-\chi(-1)}{2} h(-q) , & \text{if } f_{\psi} \leq q^{\lfloor \nu/2 \rfloor} \\ 0 , & \text{otherwise }, \end{cases}$$

and if  $\nu = 1$ , one has

(6.3) 
$$\operatorname{tr} T_{q}W|S_{\epsilon}(\Gamma_{0}(q),\chi) = \begin{cases} \chi(-1)W(\chi)q^{\epsilon/2-1}h(-q), & q \equiv 3 \pmod{4} \\ 0, & q \equiv 1 \pmod{4}, \end{cases}$$

where h(-q) is the class number of  $Q(\sqrt{-q})$ .

Proof. Put  $T = \operatorname{tr} \delta_{\chi} | S_{\epsilon}(\Gamma_0(q^{\nu}), \psi)$  if  $\nu \geq 2$ , and  $T = \frac{1}{\chi(-1)W(\chi)q^{\epsilon/2-1}}$ tr  $T_q W | S_{\epsilon}(\Gamma_0(q), \chi)$  if  $\nu \geq 1$ . Let  $\mathcal{Z}_A$  denote the set  $\prod_{p \neq q} U_p \times \mathcal{Z}_q \times U_{\infty}$  and put  $\mathcal{Z} = \mathcal{Z}_A \cap GL_2(\mathbf{Q})$ . We note  $\mathcal{Z}$  contains neither scalars nor hyperbolic elements whose characteristic roots are contained in  $\mathbf{Q}$ . By Eichler-Selberg's trace formula, we have  $T = t_e + t_p$ , where

Here  $\mathcal{Z}_e$  (resp.  $\mathcal{Z}_p$ ) denotes the set of all elliptic elements (resp. parabolic elements fixing cusps of  $\Gamma_0(q^*)$ ) in  $\mathcal{Z}$ .  $\zeta_{\alpha}$  and  $\eta_{\alpha}$  are the characteristic roots of  $\alpha$  determined by  $\rho \alpha \rho^{-1} = \begin{pmatrix} \eta_{\alpha} & 0 \\ 0 & \zeta_{\alpha} \end{pmatrix}$ , where  $\rho = \begin{pmatrix} 1 & -z_0 \\ 1 & -\overline{z}_0 \end{pmatrix}$  for the fixed point  $z_0$  of  $\alpha$  in  $\mathfrak{H}$ . For a parabolic element  $\alpha$ ,  $m(\alpha)$  has the same meaning as in (2.4), and  $\operatorname{sgn}(\alpha) = \operatorname{sgn} \zeta_{\alpha}$  for the characteristic root  $\zeta_{\alpha}$  of  $\alpha$ . First we show  $t_e = 0$ . Let f(X) be the characteristic polynomial of an elliptic element in  $\mathcal{Z}$ , then  $f(X) = X^2 + q^2$ , or  $X^2 \pm qX + q^2$ . For a Z-order  $\Lambda$  of K(f), we see by the theorem of Hijikata quoted in § 2 that if  $C_A(\alpha, \Lambda) \cap \mathcal{Z}_A$  is not empty, then  $\Lambda_q = \mathbb{Z}_q[X]/(f(X))$ . Put  $U_q^+ = \{g \in U_q | \chi(\det g) = 1\}$  and  $U^+ = \prod_{p \neq q} U_p \times U_q^+ \times U_{\infty}$ . Then  $U^+$  is a subgroup of U of index 2 and for  $\gamma \in U^+$  and  $g \in \mathcal{Z}_A$ , we have

$$\lambda(\gamma^{-1}g\gamma)=\lambda(g).$$

For a Z-order  $\Lambda$  of K(f), let  $\theta$  be the map  $\theta: C(\alpha, \Lambda) \cap \mathbb{Z}/\widetilde{\Gamma_0(q^\nu)} \to C_A(\alpha, \Lambda)$  $\cap E_4/\tilde{U}$ . Let  $\theta_1$  and  $\theta_2$  be the natural maps  $\theta_1: C(\alpha, \Lambda) \cap E/\widetilde{\Gamma_0(q^*)} \to C_4(\alpha, \Lambda)$  $\cap \mathcal{Z}_{A}/\tilde{U}^{+}$ , and  $\theta_{2} \colon C_{A}(\alpha, \Lambda) \cap \mathcal{Z}_{A}/\tilde{U}^{+} \to C_{A}(\alpha, \Lambda) \cap \mathcal{Z}_{A}/\tilde{U}$  induced by the inclusion, then  $\theta$  is the composite of  $\theta_1$  and  $\theta_2$ . Let N denote the norm map of K(f) to Q, and  $Q_A^+$  denotes the subgroup  $(\prod_{p\neq q} Z_p^{\times} \times Z_q^+ \times R_+^{\times})Q^{\times}$  of  $Q_A^{\times}$ , where  $Z_q^+ = \{x \in Z_q | \chi(x) = 1\}$  and  $R_+^{\times} = \{x \in R | x > 0\}$ . Since  $\Lambda_q = Z_q[X]/$ (f(X)) is not the maximal order of  $K(f)_q$ , we have  $N(\prod_p \Lambda_p^{\times} \times K(f)_{\infty}^{\times}) \subset Q_A^+$ . Hence for a class  $\tilde{g}$  of  $C_A(\alpha, \Lambda) \cap \mathcal{Z}_A/\tilde{U}, \theta_2^{-1}(\tilde{g})$  consists of two classes  $\tilde{g}_1$  and  $\tilde{g}_2$  of  $C_A(\alpha, \Lambda) \cap \mathcal{Z}_A/\tilde{U}^+$  and  $\lambda(\tilde{g}_1) = -\lambda(\tilde{g}_2)$ . We claim  $|\theta_1^{-1}(\tilde{g}_1)| = |\theta_1^{-1}(\tilde{g}_2)|$  $=\frac{1}{2}h(K(f), \Lambda)$ . Our assertion on  $t_e$  follows from this. Since we assume  $q \geq 5, N(K(f)_A^{\times})Q_A^+ = Q_A^{\times}, \text{ hence } \det(Q[\alpha]_A^{\times})Q_A^+ = Q_A^{\times}, \text{ where } Q[\alpha]_A = Q[\alpha]$  $\otimes_{\boldsymbol{Q}} \boldsymbol{Q}_{\scriptscriptstyle A}$ . Therefore we have  $GL_2(\boldsymbol{Q}_{\scriptscriptstyle A}) = \boldsymbol{Q}[\alpha]_{\scriptscriptstyle A}^{\times}GL_2(\boldsymbol{Q})U^+$ , so  $\theta_1$  is surjective. Let  $u_0$  be an element of U such that  $u_0 \notin U^+$ . Then we may assume  $g_1$  $=h^{-1}lpha h, g_2=u_0^{-1}h^{-1}lpha hu_0 ext{ for } h\in GL_2(oldsymbol{Q}_{A}) ext{ and we see } | heta_1^{-1}(\widetilde{g_1})|=|oldsymbol{Q}[lpha]^{ imes}ighta)$  $(\boldsymbol{Q}[\alpha]_{A}^{\times}hU^{+})\cap GL_{2}(\boldsymbol{Q})/\Gamma_{0}(q^{\nu})| \text{ and } |\theta_{1}^{-1}(\widetilde{g_{2}})| = |\boldsymbol{Q}[\alpha]^{\times} \setminus (\boldsymbol{Q}[\alpha]_{A}^{\times}hu_{0})\cap GL_{2}(\boldsymbol{Q})/\Gamma_{0}(q^{\nu})|.$ Put  $G_1 = \{x \in \mathbb{Q}[\alpha]_A^{\times} | \det(xh) \in \mathbb{Q}_A^+\}, \text{ then } (\mathbb{Q}[\alpha]_A^{\times}hU^+) \cap GL_2(\mathbb{Q}) = (G_1hU)$  $\cap GL_2(Q)$ . By the same calculation as in Prop. 2.6, we obtain  $|\theta_1^{-1}(g_1)|$  $= |G_1/Q[\alpha]^{\times}(hUh^{-1} \cap Q[\alpha]_A)| = \frac{1}{2}h(K(f), \Lambda)$ , and in the same way  $|\theta_1^{-1}(\widetilde{g}_2)|$  $=\frac{1}{2}h(K(f), \Lambda)$ . Now let us calculate  $t_p$ . Let  $\alpha$  be an element of  $\mathcal{Z}_p$ , then the characteristic polynomial  $f_{\alpha}$  is either  $X^2 - 2qX + q^2$ , or  $X^2 + 2qX + q^2$ . Since the contribution from the parabolic elements  $\alpha$  with  $f_{\alpha} = X^2 - 2qX$  $+ q^2$  is the same with that from the parabolic elements lpha with  $f_{lpha} = X^2$  $+2qX+q^2$ , we may assume  $f = X^2 - 2qX + q^2$ . Put  $f(X) = X^2 - 2qX$  $(+q^2)$ , and  $\Omega = \{x \in \mathbb{Z} | f(x) \equiv 0 \pmod{q^{\nu+1}}\}$  if  $\nu \geq 2$ , and  $\Omega = \{qx | x \in \mathbb{Z}, (x, q) = 1\}$ if  $\nu = 1$ . For  $x \in \Omega$ , put

$$\alpha_x = \begin{pmatrix} x & 1 \\ -f(x) & 2q - x \end{pmatrix}$$

then  $\alpha_x$  is contained in  $C(\alpha, \Lambda_0) \cap \overline{Z}$  for  $\Lambda_0 = \mathbb{Z}[X]/(f(X))$ . For  $m \in \mathbb{Z}$ , put  $\alpha_{x,m} = q + m(\alpha_x - q)$  and for a positive integer m, let  $\Lambda(m)$  denote the  $\mathbb{Z}$ -order of K(f) such that  $[\Lambda(m): \Lambda_0] = m$ . Then we see easily that for a positive integer m prime to q,  $\{\alpha_{x,m} | x \in \Omega \pmod{q^v}\} \cup \{\alpha_{x,-m} | x \in \Omega \pmod{q^v}\}$  gives a complete system of representatives of  $C(\alpha, \Lambda(m)) \cap \mathbb{Z}/\widetilde{\Gamma_0(q^v)}$ . We

have  $m(\alpha_{x,m}) = m/q$  and  $\lambda(\alpha_{x,m}) = \psi(1 + m(x-q)/q)\chi(m)$  for  $m \in \mathbb{Z}$ , where we put  $\psi$  = the identity character if  $\nu = 1$ . Therefore we obtain

$$t_p = rac{1}{W(\chi)} \lim_{s \to 0} rac{qi}{2\pi} \sum_{m=1 \ (m,q)=1}^{\infty} rac{1}{m^{1+s}} igg( \sum_{x \in \mathcal{Q}(\mathrm{mod}\ q^{

Since we have for  $m \in Z$ 

$$\sum_{x \in \mathscr{Q} \pmod{q^{
u}}} \psi(1 + \mathit{m}(x - q)/q) = egin{cases} |\mathscr{Q}(\mathrm{mod}\;q^{
u})| \;, & f_{\psi} \leq q^{[
u/2]} \ 0 \;, & \mathrm{otherwise} \;, \end{cases}$$

and  $|\Omega(\mod q^{\nu})| = q^{\nu-1-[\nu/2]}$ , we obtain

$$t_p = rac{1}{W(\chi)} rac{qi}{2\pi} q^{

This completes the proof.

Put  $q = (\sqrt{-q})$ . Let  $\lambda$  be a Grössencharacter of  $Q(\sqrt{-q})$  satisfying

(6.4) 
$$\lambda((\alpha)) = \left(\frac{\alpha}{|\alpha|}\right)^{\epsilon^{-1}} \quad \text{for } \alpha \equiv 1 \mod^{\times} \mathfrak{q}^{\nu^{-1}}$$

(6.5) 
$$\lambda((n)) = \psi(n)\chi(n)$$
 for  $n \in \mathbb{Z}$ .

For  $\lambda$ , put  $f_{\lambda}(z) = \sum_{\alpha} \lambda(\alpha) N(\alpha)^{(z-1)/2} e^{2\pi i N(\alpha) z}$ , then we know by [14]  $f_{\lambda}$  is contained in  $S_{\varepsilon}(\Gamma_{0}(q^{\nu}), \psi)$ . If  $\nu \geq 2$ , we see  $f = f_{\lambda}$  satisfies

(6.6) 
$$(f|\delta_{x}) = f(z) + cf(qz) \quad \text{for some } c.$$

If  $\nu = 1, f = f_{\lambda}$  satisfies

$$(6.7) f = f_{\rho} ,$$

where  $f_{\rho} = \sum_{n=1}^{\infty} \bar{a}_n e^{2\pi i n z}$  for  $f = \sum_{n=1}^{\infty} a_n e^{2\pi i n z}$ . On the other hand, we can prove

COROLLARY 6.2. Let q and  $\psi$  be as in Th 6.1. Let M be the subspace of  $S_{\epsilon}(\Gamma_0(q^{\nu}), \psi)$  spanned by the common eigen-functions of  $T_n$  for all n prime to q satisfying (6.6) if  $\nu \geq 2$  or (6.7) if  $\nu = 1$  and  $\psi = \chi$ . Then M is spanned by  $f_{\lambda}$  for all  $\lambda$  satisfying (6.4) and (6.5).

*Proof.* If  $\nu \geq 2$ , it is easy to see tr  $\delta_{\chi} | S_{\kappa}(\Gamma_0(q^{\nu}), \psi) = \dim M$ . If  $\nu = 1$ ,

by [1, Th. 2] for a primitive form f in  $S_{\epsilon}(\Gamma_0(q), \chi)$ , we have

$$f | T_q W = \chi(-1) W(\chi) q^{\epsilon/2 - 1} f_{\rho}$$

Hence we obtain  $\frac{1}{\chi(-1)W(\chi)q^{\epsilon/2-1}} \operatorname{tr} T_q W| S_{\epsilon}(\Gamma_0(q), \chi) = \dim M$ . For  $\lambda$  satisfying (6.4) and (6.5),  $f_{\lambda}$  is contained in M and we see there exist exactly  $q^{\nu-1-[\nu/2]}h(-q)$  such Grössencharacters if  $\mathfrak{f}_{\psi} \leq q^{[\nu/2]}$  and otherwise there are no such Grössencharacters. Since  $f_{\lambda}$ 's are linearly independent over C for such  $\lambda$ 's, our assertion is proved.

Remark 6.3. The trace of the twisting operator has been given in Shimura [15] in the case where  $\nu = 2$  by another method. The special case of Cor. 6.3 was proved by Asai [2] as an application of Doi-Naganuma lifting for imaginary quadratic fields. In [9], Ribet proved a general result on the characterization of cusp forms associated with *L*-functions with Grössencharacters of imaginary quadratic fields. Cor. 6.3 gives another proof of the results of Asai and Ribet in the special cases.
