

Maury Klein is professor of history at the University of Rhode Island. He is the author of eleven books, most recently The Life and Legend of E. H. Harriman and Days of Defiance: Sumter, Secession, and the Coming of the Civil War, as well as numerous articles. Another book, Rainbow's End: The Crash of 1929, is scheduled to be published by Oxford University Press in October 2001. He is currently writing a book tentatively titled The Art of the Great Entrepreneurs.

Eugene N. White is professor of economics at Rutgers University in New Brunswick, New Jersey, and a research associate at the National Bureau of Economic Research. He is also editor of Explorations in Economic History. He has recently published papers on stock market crashes and banking panics in the United States, and macroeconomic policy in France. He contributed a chapter, "Banking and Finance in the Finance in the Twentieth Century," to The Cambridge Economic History of the United States (2000). Currently, he is working with Lance Davis and Larry Neal on a comparative study of the stock exchanges of New York, London, and Paris.

Julie Winch is professor of history at the University of Massachusetts in Boston. Her first book, *Philadelphia's Black Elite: Activism*, Accommodation, and the Struggle for Autonomy, 1787–1848, was published by Temple University Press in 1988. She has also edited and annotated two works by antebellum African American writers, Cyprian Clamorgan's 'The Colored Aristocracy of St. Louis' (1999), and The Elite of Our People: Joseph Willson's Sketches of Black Upper-Class Life in Antebellum Philadelphia (2000). She has been the recipient of a number of grants and awards. Her biography of James Forten, A Gentleman of Color, will be published by Oxford University Press in February 2002.
