GIAMBATTISTA VICO'S SCIENCE OF HUMANITY

Giambattista Vico, the Neapolitan philosopher who lived from 1668 to 1744, has been called by Isaiah Berlin "the most unacknowledged source of ideas in the history of philosophy". The current resurgence of interest in Vico can in part be explained by the dissatisfaction with traditional ways of looking at human knowledge and the mind derived from Cartesian philosophy. The Cartesian approach is unable to satisfy the concern of the twentieth century for understanding the non-cognitive—the imagination, the will, creativity, feeling, the sensuous, and the aesthetic.

Vico asserts the value of the imagination in all its forms. His masterwork, the *New Science*, although long neglected, is gradually being reestablished as one of the seminal books of Western thought. James Joyce, who wove Vico into the texture of *Finnegans Wake*, declared: "My imagination grows when I read Vico as it doesn't when I read Freud or Jung." The twenty-nine essays by prominent American and European scholars gathered together in this volume further illuminate the multi-faceted aspects of Vico's "science of humanity".
