The East Asian Institute is a new research organization, recently set up under a statute of the National University of Singapore.

Applications are invited from suitably qualified China scholars, trained in the broad fields of economics, sociology, political science and international relations, who are interested in doing research on China's economic reforms and political and social changes, including the integration of China into the global community and its impact on Southeast Asia.

Intellectual maturity and a good command of Chinese and English are important prerequisites. Actual working experience in China would be an additional asset. Successful candidates will be offered an initial contract of up to three years at a time which is renewable. Senior scholars can come for shorter terms on visiting appointments.

Salary offered will be within the range: Gross S\$58,300 - S\$138,100 per annum.
(US\$1.00 = S\$1.43 approximately)

In addition, a 13th month Annual Allowance (of one month's salary) and an Annual Variable Component (of normally 2 months' salary) may be payable at year end, under the flexible wage system, to staff on normal contracts. The commencing salary will depend on the candidate's qualifications, experience and the level of appointment offered.

Leave and medical benefits will be provided. Depending on the type of contract offered, other benefits may include: provident fund benefits or an end-of-contract gratuity, a settling-in allowance, subsidised housing, education allowance for up to three children subject to a maximum of S\$16,425 per annum per child, passage assistance and baggage allowance for the transportation of personal effects to Singapore.

Manuscripts

The China Quarterly welcomes the submission of manuscripts from scholars, including postgraduate students, on all aspects of contemporary China and from all points of view, including those which deal with Taiwan and Overseas Chinese. Articles on China prior to 1949 are also welcome, particularly, but not exclusively, when these relate directly to contemporary China or to the history of the Chinese Communist Party. Articles should be submitted in quadruplicate to the editorial office. They should normally not exceed 8,000 words in length; should be typed in double spacing, with footnotes at the end; and should conform to the styling of *The China Quarterly* (see below). An abstract of 100–150 words should also be provided for on-line promotional purposes. Submission of a manuscript is taken to imply that it has not previously been published in any form (including non-copyrighted working papers) and that it is not currently being considered elsewhere.

Style

Romanization

Pinyin is used without tone/diacritical marks, except the following which should use the Wade-Giles system: names such as Chiang Kai-shek, Sun Yat-sen, Taipei and Kuomintang; names of individuals living outside mainland China. Chinese characters should be provided on the first occurrence of each romanization, to assist in proofreading.
