Comparative Legislative Research Series

The Consortium for Comparative Legislative Studies, recently organized by Duke University, the University of Hawaii, and the University of Iowa, announces the establishment of a new publishing program in Comparative Legislative Research, to be brought out by Sage Publications (Beverly Hills and London). The program consists of three series. The Sage Progress Series in Comparative Legislative Research will report the results of collective research activities, including conferences, and other edited, theme-oriented works. One volume (in two separate bound parts) will be published each year. The Sage Series on Legislative Studies will include two book-length studies each year. In addition, a series of eight individual papers annually (ranging in length from 32-96 pages each) will be published in a Comparative Legislative Studies Series-within a larger series ("Sage Research Papers in Political Science") which will be launched in 1973. The general editor for these three series is Malcolm E. Jewell, who will be assisted by an international editorial advisory board.

The purpose of the overall program is to make possible, in a flexible format, the prompt publication and wide distribution of legislative research that has a comparative perspective. The editors are interested in receiving manuscripts that report cross-national research on legislative systems, institutions, behavior, and outputs. They are also interested in single-nation legislative research, particularly on foreign countries, that tests and develops hypotheses which are significant for comparative research.

The editors welcome contributions from scholars in the United States and other countries. Each manuscript that is submitted will be evaluated by members of the editorial advisory board and/or other well-qualified scholars. Conference Group on German Politics

The Conference Group on German Politics wishes to announce several publications, programs and conferences as follows:

Publications

The Summer 1972 issue of the journal Social Research is devoted to papers presented at the Conference on Weimar, Germany, co-sponsored by the CGGP and the Graduate Faculty of the New School for Social Research in New York, October 1971. The CGGP has also assisted in the compilation of "The Federal Republic of Germany: A Selected Bibliography of English-Language Publications" recently issued by the Library of Congress and prepared by Arnold Price of the Library's Slavic and Central European Division.

Programs

The CGGP is undertaking an expansion of its Internship programs (now being conducted with the Bundestag and the Information Center of West Berlin) and establishment of a "Scholars-in-Residence" program.

Internships

Beginning in 1973, two nine-month and two four-month internships will be available for work-study programs in German governmental offices. Details are being developed with various offices, but potential applicants are invited to state their interests and preferred location for interning, and the CGGP will seek to faciliatte arrangements. Interns may be located in German offices dealing with

international, federal, state or local affairs. Internships are designed to contribute to the professional development of the intern by familiarizing him with the operations of German governmental offices, and interns are also expected to contribute to the work of the office. Emphasis will be placed upon programs which are oriented to a comparative understanding of politics in Western countries.

Stipends and travel grants will be available. In most cases, substantial fluency in German is a prerequisite to application. In lieu of a formal application, potential candidates are invited to submit statements of their background and interests to "Internship Selection Committee," CGGP, P.O. Box 345, Durham, N.H. 03824. Preference will be given to advanced graduate students and younger faculty.

Scholars-In-Residence

This program will support visits up to one month in German offices by scholars whose professional training and work could benefit by intensive contact with the operations of a German governmental office at international, federal, state or local level. It is not primarily intended for specific research projects which are already underway. Periods of residency should rather stimulate understanding of governmental functions and planning for further study. Specific details will be worked out in each case. The CGGP is organizing a list of offices which will accept scholars-in-residence, but interested scholars are invited to submit statements of their background and interests to "Scholars-in-Residence Program," CGGP, P.O. Box 345, Durham, N.H. 03824. Beginning in 1973, stipends and travel support will be available for three resident scholars. Preference will be given to senior scholars.

Conferences

The CGGP sponsored an international conference on "West German Foreign Policy and Contemporary International Politics in Europe" in Cologne, Germany, June 8-10, 1972. Attended by 150 social scientists from the United States and social scientists and political leaders from Germany and other European countries, the gathering included four formal panels (chaired by E. O. Czempiel, Karl Deutsch, Hans J. Morgenthau, and Philip Windsor) and a number of informal sessions. Professor Werner Kaltefleiter was in charge of local arrangements.

Voting Study

Administrative Obstacles to Voting, a recent study by the League of Women Voters Education Fund, details the need for changes in administrative practices of state and local election officials. Financed by a grant from the Ford Foundation, the publication is based on a survey done during the fall election period, 1971, of registration and polling practices in 251 communities in the U.S. The report contains a discussion of survey findings on the power and perceptions of election officials in the conduct of their offices, tables documenting the extent of administrative obstacles to exercise of the franchise, and recommendations for reforming the administration of registration and voting procedures. Stanford Organizational

Research Program

A multi-disciplinary training program in organizational research has been instituted at Stanford University. Participating units are the Graduate School of Business, the School of Education and the Departments of Political Science, Psychology and Sociology. Participating faculty include:

The program incorporates both pre-doctoral and post-doctoral trainees. Since the pre-doctoral program provides training for the final two years of doctoral training, only students who are enrolled in a doctoral program at Stanford University are eligible to apply for admission as pre-doctoral trainees. Support from NIMH provides stipends of \$2600 and \$2800 and utition for eight pre-doctoral trainees, and funds are available for dissertation support.

Post-doctoral applicants are not restricted to Stanford students and inquiries are welcome. Funds from NIMH provide stipends of \$6000 for three post-doctoral trainees. In some cases, these funds may be supplemented from other sources. Only American citizens are eligible for all traineeships.

The training program emphasizes multi-disciplinary research and methodological diversity in training. The aim is to produce researchers equipped to pursue theoretical and applied problems across conventional disciplinary boundaries unhampered by artificial methodological restrictions.
