Between 1946 and 1966, the Republic of Colombia was the scene of one of the most intense and protracted instances of widespread civilian violence in the history of the twentieth century. Known in Colombia simply as La Violencia, this social process left a toll of at least 200,000 fatalities, including 112,000 in the 1948-1950 period alone. This book formulates an explanation of the appearance and subsequent development of La Violencia. What caused this violent process? What might account for its intensity, duration, and geographical distribution? These are the questions that have guided this study. The search for answers to these queries has also led to the tasks of seeking a rigorous description of the phenomenon to be explained; of specifying the socio-historic context of *La Violencia*, with regard both to previous instances of social violence in Colombian history and to the evolution of the nation's basic social structures. This book is based on the first research project to deal with all of these questions and collateral task in an integrated fashion. The result of this approach has been the production of an approximate explanation of *La Violencia* that differs significantly from existing interpretations.
