Reproduction and Distribution of Working Papers

The Social Science History Association has initiated procedures to facilitate the reproduction and distribution of network working papers and newsletters. Under the established procedures, network chairpersons will collect materials from members of their network and send them on to the University of Missouri, where copying and distribution will be centered. Announcements will be made in each issue of Social Science History listing available papers and newsletters with their prices. Individual members of the association can then place their own orders on the form that will be provided in the Journal.

This program will be centered at the University of Missouri because the work can be handled there effectively and inexpensively. Papers will be reproduced by offset, which produces high-quality results. Initial costs will be in the range of 8¢/page, though it is expected that this cost can be substantially reduced as quantities increase. This cost includes copying, first class mailing, envelopes and labor.

All materials reproduced and distributed under these procedures will be protected by copyright, which will be held by the Curators of the University of Missouri. This will in no way hinder later publication, for this copyright can be easily and routinely transferred for any author who publishes his work in a book or journal. There will be no fee for transfer of copyright. It is believed that this approach is superior to having all papers and newsletters put into the public domain without protection. All authors will be asked to sign a statement exempting officers of the Social Science History Association and employees of the University of Missouri from any liability incurred through misuse of the working papers. It is believed that such misuse will be rare.

The initial collection of materials will be the responsibility of network chairpersons who will solicit working papers from members of their networks. These may include papers presented at conferences or scholarly meetings, as well as substantial but uncirculated papers. Send only copies of papers, as these can be lost in the mail. All copies should, however, be clear and dark because there is no possibility of retyping. It

is assumed that scholars who make their work available on this basis will desire pre-publication comments and suggestions from readers. It is therefore advised that all papers contain the mailing address of the author.

Any author who is overlooked by or unknown to the relevant network chairperson should make efforts to contact the appropriate person, using the accompanying list as a guide. Any further inquiries should be sent to: Prof. Robert M. Somers, Department of History, University of Missouri-Columbia, Columbia, Missouri 65201.

The success of this effort depends on the cooperation and support of the membership of SSHA as a whole. This service offers the potential of increasing the quality of published work by gaining valuable criticism and suggestions before formal publication. It also means that important work need not languish for years awaiting publication. This service in no way constitutes the equivalent of formal publication, but may provide with the least possible delay a way of getting manuscripts into the hands of interested readers. With broad cooperation the benefits of this innovation should be substantial and significant.
