The Yorubas comprise one of the largest ethnic groups in Nigeria so that their customs in respect of family property are of great importance to practitioners and students in that country. In this book, after an introduction and a discussion of the basic principles of land tenure, the author deals with immovable and movable property, and the creation and determination of rights and restrictions, both in general terms and how they affect special categories of persons such as chiefs, women, minors, etc. Particular kinds of family property are next dealt with, and there follows a discussion of testate succession, devolution by marriage and conveyancing practice and procedure.

Since the first edition of this book was published in 1958 there has been a substantial growth in the body of case law, and there has been legislation affecting the subject. The task, therefore, of bringing the book up to date has been a formidable one.
