- Cover* People and wildlife are increasingly having to share space and resources, and habitat degradation and fragmentation have heightened the importance of understanding people's tolerance of wildlife. In rural Bangladesh, contrary to expectations, monetary costs do not significantly shape people's tolerance of Asian elephants, despite major impacts on livelihoods. Rather, intangible costs and benefits determine tolerance. The socio-economic and bio-cultural dynamics of communities explain these results, and a wildlife tolerance model of this system could be used to incorporate these complexities into conservation decision-making.
