


# A Concordance to the *Utopia* of St. Thomas More

## and A Frequency Word List

Concordances have been recognized by scholars as indispensable tools for research. Recently, an additional tool has been developed — a special kind of *Index Verborum* that makes possible stylometric analysis. This publication contains both: a concordance and a new kind of *index verborum* to the *Utopia* of St. Thomas More. This concordance and *index verborum* are intended for those interested in the fascinating and multi-faceted "Man for All Seasons", as well as for historians of ideas and specialists in Medieval and Renaissance Latin. This is the only published concordance to the *Utopia* of St. Thomas More, and the only *index verborum* of its kind. Both are complete. Both are based on the latest critical edition of E. L. Surtz, S. J. and J. H. Hexter. The *Index Verborum* found at the end of the concordance has the special feature of being arranged not in the traditional alphabetical order, but listed according to decreasing order of frequency, with absolute and relative frequency counts for each word. Such a list enables a scholar to spot predominant themes. It also serves as a basis for quantifying style by putting in relief, as it were, idiosyncratic words, frequency of similes, preference for certain adjectives, and other data used in stylometry.
