So rapid has been the development of the law of contract in the past five years that many traditional principles have undergone extensive change. The enactment of the Misrepresentation Act 1967, together with a number of important decisions of the House of Lords, have necessitated much new writing in this twenty-third edition of Sir William Anson's classic work. Now in its ninetieth year, *Anson* has consistently provided a clear and comprehensible statement of the law for students. Its long life is some indication of the extent to which it has answered their needs and difficulties; it is now available for the first time in a paper as well as in a cloth edition. A. G. #### \* Comparative Judicial Behaviour

#### GLENDON SCHUBERT and DAVID J. DANELSKI

This book is the first to focus cross-culturally on judicial decisionmaking, using theories and methods developed in the behavioural sciences. It contains a group of original empirical studies designed and carried out by authors who are political scientists or lawyers or both. Though there is an extensive literature on American courts and judges, and much of it from a behavioural point of view, very little work has been done on judicial behaviour in other cultures. The chapters on the Korean, Philippine, and Indian judiciaries are the first behavioural analyses of these subjects to be published anywhere, and with only a few exceptions, the same is true of Japan, Australia, and Canada. #### Precedent in English Law

#### RUPERT CROSS, Vinerian Professor of English Law, University of Oxford

Dr Goodhart said in 1948 that the English doctrine of precedent was more rigid than it ever had been in the past, and when the first edition of this book was being written between 1958 and 1960 that remained substantially true. The message of the second edition is that the doctrine of precedent is less rigid than ever before, the major pointer to that conclusion being the famous Practice Direction of the House of Lords of July 1966 in which the House asserted its power to reconsider its previous decisions. The Direction is discussed, together with several other indications of the loosening of the old rigidity of the English rules of precedent. An effort is made to collect together all the exceptions to the rule of *stare decisis*, but it is recognised that such an undertaking can never be definitive.
