He is the author of two books: *Education, Manpower and Development: The Impact of Educational Policy in Kenya*, and *Revolutionary Ethiopia: From Empire to People's Republic*. In addition, he is co-editor of *Afromarxist Regimes* and *South Africa in Southern Africa* and author of numerous articles on African and African American politics.
