The Teaching of Contempt: Christian Roots of Anti-Semitism

Jules Isaac. Holt, Rinehart & Winston. 154 pp. \$4.00.

In this volume, the first of the late French historian's books to be published in English, Jacobs disputes three main theses of anti-semitic doctrine: "The Dispersion of the Jaws: Providential Punishment for the Crucifixion"; "The Degenerate State of Judaism at the Time of Jesus"; and "The Crime of Deicide."

Ethical Resources for International Relations

Harvey Seifert. Westminster. 88 pp. \$1.25.

Prof. Soifert bolieves that a stalemate has been roached in the approach of the Christian public to political, economic and social problems facing the international community. He endeavors to open up now dimensions of thought and involvement based on "the closest approximations to the norm of love possible under existing circumstances."

The Christian Faith and War in the Nuclear Age

Abingdon, 108 pp. \$1.00.

The special study commission which prepared this report for The Methodist Church, concerned itself not only with setting forth the broad guidelines for individual and Church responsibility in the contemporary world, but also with giving a "Christian evaluation" of the modern theories of war and deterrance—counterforce, limited war, Nth power problem etc.

The End of Alliance

Ronald Steel. Viking. 148 pp. \$3.75.

NATO, "an ingrained dogma of American foreign policy," continues in existence because U.S. designs for Europe have never kept pace with the postwar recovery of the region, the author asserts. Among the areas affected by American intransigence which Steel cites are German reunification, Soviet-American relations and the nuclear deterrent.

Shaping the Future

Robert R. Bowie. Columbia. 118 pp. \$3.50.

The problems of planning, during a period of revolutionary change, a policy for a future world "congenial to freedom," are analyzed by Dr. Bowie here. For his discussion he has drawn upon the trends and lossons of the postwar period, has examined the quest for Atlantic unity, and has considered the difficulties of implementing plans once they have been made.

Power in Washington

Douglass Cater, Random House, 275. pp. \$4.95.

The Reporter's national affairs editor has taken "A Critical Look at Today's Struggle to Govern in the Nation's Capital," assessing the highly fragmented power structure which has emerged in Washington since World War II.
