

NOTES ON THE CONTRIBUTORS

RALPH DELLA CAVA teaches Latin American history at Queens College, CUNY. He is Chairman of the Brazilian Studies Committee of the Conference on Latin American History for 1976, and is currently completing research on several of the issues raised in this article.

GLÁUCIO ARY DILLON SOARES is Professor of Sociology at the University of Brasilia and Professor of Latin American Studies and Sociology at the University of Florida. He directed the Latin American School of Sociology (FLACSO) from 1965 to 1969. His latest book, A Questão Agrária na América Latina, will be published this fall.

RICHARD WEISSKOFF is Associate Professor of Economics at Iowa State University and the author of articles on income distribution, consumption patterns, and import substitution.
