

The connectivity of crystallite agglomerates in low-density firn at Kohnen station, Dronning Maud Land, Antarctica

ABSTRACT. In this study, the three-dimensional (3-D) microstructure of polar firn is investigated by means of X-ray microfocus computer tomography (μ CT). Basic topological properties including the Euler and coordination numbers are derived from the reconstructed 3-D volume images. It is shown that sample volumes of about 4 cm³ are representative for polar firn in terms of their connectivity. The connectivity function defined as the change of Euler number with structure size is calculated via image-processing routines. It is used to split the ice phase at small bridges into single crystallite agglomerates. The bond-size distributions and the mean size of the agglomerates are estimated. All μ CT measurements were carried out on the uppermost 9 m of a shallow firn core (B35) drilled during the 2005/06 field campaign at Kohnen station, Dronning Maud Land (DML), Antarctica. The results are compared with estimates from classical two-dimensional (2-D) surface section observations. The 3-D approach confirms the linear relationship between coordination number and density which hitherto has only been derived from 2-D observations. Layers of buried snow dunes show a stronger connectivity than layers of moderate crystal size and density. The formation of agglomerates made of crystallites is a common feature of polar firn in DML. It is proposed that the growth of agglomerates leads to reduced critical densities for the transition between the densification regime of grain boundary sliding and plastic deformation.

INTRODUCTION

Polar firn forms the upper layer of ice sheets. The interface between atmosphere and ice is of special interest for a wide range of topics including climate studies, interpretations of climate records in deep ice cores, ice-sheet monitoring and mass-balance calculations (Stauffer and others, 1985; Arthern and Wingham, 1998; Li and Zwally, 2002). The microstructure of firn reflects the impact of wind, temperature and solar radiation during and after deposition. In the upper meters the metamorphism of microstructure is mainly caused by diurnal and seasonal temperature gradients. Below the upper meters, the microstructure is subject to isothermal pressure sintering (Colbeck, 1983; Maeno and Ebinuma, 1983). This results in a continuous densification until firn transforms into bubbly ice at 50–150 m depth. Recent isothermal densification models distinguished between rapid densification of highly porous firn by grain boundary sliding in the upper meters and moderate densification of consolidated firn by intracrystalline deformation with a power-law creep in the deeper layers (Maeno and Ebinuma, 1983; Alley, 1987a,b; Arnaud and others, 2000). Most of the measured density profiles show a sharp decrease in densification rate at the ‘critical point’ between the two densification stages. The critical relative density D_0 varies between 0.45 and 0.65 at different polar sites (corresponding to porosities of 0.55–0.35). D_0 is an important input parameter for the semi-empirical models. It can be parameterized with the annual mean site temperature using a linear relationship based on data of recent sites compiled by Arnaud and others (2000). Lower densities have been observed at colder sites. The extrapolation to past climatic conditions during the cold Glacial periods is problematic

because the temperature is up to 10 K lower, the accumulation rate only 30–50% of recent values and the time the firn is sintering significantly longer. The physical background for the variation in D_0 is still under debate. Alley (1987a) emphasizes the geometrical constraint for grain boundary sliding: sliding can only occur if in case of spherical monosized crystals the number of bonds or neighbors of a single crystal (coordination number) in a three-dimensional (3-D) structure is less than 6. However, for elongated particles sliding is still possible at coordination numbers significantly higher than 6. For example, randomly packed cylinders of large aspect ratio approach a coordination number of almost 10 (Blouwolf and Fraden, 2006).

Densification of polar firn and the evolution of microstructure on the grain scale are not well understood. Methodical restrictions in the observations to two dimensions complicate studies of the 3-D nature of microstructure and require stereological assumptions. With the development of microfocus computer tomography (μ CT), first investigations have been performed on 3-D reconstructions of deep polar firn (Freitag, 2004) and alpine and artificial snow (Coléou and others, 2001; Lundy and others, 2002; Schneebeli and Sokratov, 2004). In this study, we present measurements of the 3-D microstructure by means of μ CT. The investigations focus on connectivity to check the geometrical constraint to the proposed sliding at low-density firn. For this we introduce a methodological procedure of image-processing routines to estimate the coordination number from 3-D reconstructions of polar firn. The measurements provide the first dataset of coordination numbers. The results from three selected samples are compared with classical two-dimensional (2-D) observations of cross-sections from samples formerly measured with μ CT.




Fig. 1. (a) A binarized $8 \times 8 \text{ mm}^2$ horizontal cross-section of a firn sample from 8 m depth recorded by the microscopic imaging system. Crystallites are in black. Pores and intercrystalline boundaries are in white. Note the existence of boundaries at almost all grain constrictions. (b) A reconstructed firn cube of 16 mm (400 voxels) side length from 8 m depth measured by μCT . The ice phase is displayed in black; pores are transparent.

3-D X-RAY-MICROFOCUS COMPUTER TOMOGRAPHY (μCT) AND 2-D MICROSTRUCTURE MAPPING

The 3-D microstructure of polar firn is measured using a μCT scanner (1074SR Skyscan) inside a field tent at about -15°C on the Antarctic plateau. The sample size is limited to cylinders of 27 mm diameter and 30 mm height. For each sample a reconstruction algorithm generates a set of 512 images of 736×736 pixels with a pixel resolution and image spacing of $40 \mu\text{m}$. The 3-D grey-value images are filtered and segmented into a digitized volume of air and ice (details in Freitag and others, 2004). The fraction of ice-representing voxels is called relative density D . The fraction of pore-representing voxels is called porosity. Further image analyses are performed on cubes of $400 \times 400 \times 400$ pixels that are located in the centers of the reconstructed samples (Fig. 1b). The side length of the cubes corresponds to 16 mm. In addition, some cylindrical samples were horizontally cut. The samples with circular cross-sections of 27 mm diameter were microtomed and surfaces were recorded under reflected light with a computer-controlled microscopic imaging system (details in Arnaud and others, 1998a; Kipfstuhl and others, 2006). The spatial resolution is $3.3 \mu\text{m}$ (Fig. 1a).

THE EULER AND COORDINATION NUMBER

Basic topological properties of a complex 3-D structure are the number N of isolated objects, the number C of redundant connections or loops, and the number H of completely enclosed cavities or holes. These topological measures are combined in the Euler number E as

$$E = N - C + H \quad (1)$$

(Vogel, 2002). The Euler number per volume is called specific Euler number E_V .

For the ice phase in firn, N is always equal to 1 because all crystallites are connected to each other. In low-density firn

no large-scale pores are completely isolated (Stauffer and others, 1985). The isolation of air in firn starts at relative densities larger than ~ 0.79 , which is far above the density range investigated in this study. Positive values of H are exclusively due to small air inclusions or microscopic bubbles in the ice matrix which do not significantly contribute to porosity ($< 1\%$) and the topology of the ice phase network. To eliminate any noise contribution to H (i.e. $H = 0$) all inclusions smaller than 100 voxels are excluded. With $N = 1$ (there is only one ice cluster in the sample volume) it follows from Equation (1) that the absolute value of the specific Euler number E_V of low-density firn is approximately equal to the amount of redundant ice-phase loops per firn volume C (note the negative sign of C in Equation (1)). Following Vogel and Roth (2001), the (effective) coordination number Z , defined as the mean number of bonds or connected neighbors per object, can be calculated via

$$Z = \frac{2(N_V - E_V)}{N_V} \quad (2)$$

with N_V denoting the number of objects per volume. Due to the complex structure of firn, bonds and objects are not well defined. In the following we use the terms grain and agglomerate as synonyms to describe objects which are frequently composed of two or more distinct crystallites. Kry (1975) investigated snow structures in 2-D cross-sections and defined bonds as geometrical constrictions of more than 30% with aligned notches on both sides. He mentions that the identified bonds are generally coincident with crystallite boundaries. However, single grains were mostly polycrystalline and only a small number of crystal boundaries were classified as grain bonds. In contrast, Alley (1987b) defined all crystallite boundaries as grain bonds without taking geometrical aspects into account. Our 3-D approach described below follows Kry (1975) rather than Alley (1987b) and identifies grain bonds as constricted regions. For that, we derive the connectivity function to obtain a size-dependent description of connectivity.




Fig. 2. Example of the connectivity function $E_V(L)$. The evolution of isolated ice clusters $N_V(L)$ is added. With continued erosion, the connectivity of the ice matrix decreases (Euler number increases starting from E_{Vorg} for the original structure) and the number of isolated objects increases towards a local maximum N_{Vmax} . Here the total eroded thickness approaches the mean thickness of the ice structure. With further erosion, whole objects disappear and both E_V and N_V tend to zero. The local maximum N_{Vmax} is interpreted as the number of crystallite agglomerates that form the ice structure. The dotted curve shows the derivation of $dE_V(L)/dL$ from the branch of positive slope using for the estimation the size distribution of bonds connecting N_{Vmax} agglomerates.

IMAGE PROCESSING: CONNECTIVITY FUNCTION, BONDS AND CRYSTALLITE AGGLOMERATES

The connectivity function is defined as the specific Euler number E_V as a function of structure size (Vogel, 1997). It describes the change in E_V by the successive erosion of the structure and is a measure of the bond-size distribution. In the context of digital image processing, the parameter used to measure the structure size is the number of layers L that are successively eroded from the original ice phase. The erosion process is performed by means of the Euclidean distance transformation (EDT). The EDT generates a distance map for each voxel to the opposite phase and allows a simple layer-by-layer erosion via thresholding. After each erosion step, the specific Euler number E_V , as well as the specific number of isolated objects N_V (number of isolated objects per volume), is measured from the residual structure. The erosion stops when the ice phase is totally eroded. Typical curves for the connectivity function $E_V(L)$ and the number of isolated objects $N_V(L)$ are plotted in Figure 2. The $E_V(L)$ curves start at high negative values (interpreted as the amount of redundant loops in the original structure) and increase to a local positive maximum, with a continuous decrease to zero for large L . The $N_V(L)$ curves start at unity (the original ice cluster consists of one object) and also increase to a positive maximum N_{Vmax} followed by a continuous decrease to zero for large L , similar to $E_V(L)$. N_{Vmax} is interpreted as the number of crystallite agglomerates (grains) that are connected by bonds smaller than their minimum dimension. Agglomerates smaller than the eroded layer thickness at N_{Vmax} of about 0.25 mm are neglected. The total ice volume divided by N_{Vmax} gives the mean volume of an agglomerate. It can be expressed by the effective radius R_{agg} of a sphere of

equal volume. From the part with positive slope of the $E_V(L)$ curve, one obtains the size distribution of bonds which originally connect the agglomerates. $E_V(L_1) - E_V(L_2)$ is equal to the number of bonds with a radius between L_1 and L_2 . Derivation of the $E_V(L)$ function in the interval of positive slope corresponds to the bond-size distribution. As a measure of bond size the mean bond radius r_b of the measured distribution is calculated (Fig. 2).

The coordination number Z is given as

$$Z = \frac{2(N_{Vmax} - E_{Vorg})}{N_{Vmax}} \quad (3)$$

with N_{Vmax} denoting the number of ice objects per volume (i.e. to the maximum in the $N_V(L)$ curve) and E_{Vorg} the specific Euler number $E_V(L=0)$ of the original firn structure. Note the difference between N_V and N_{Vmax} . N_V describes the number of actually isolated ice objects per volume, whereas N_{Vmax} is a measure of the number of ice objects per volume that can potentially be separated from the ice structure.

All calculations are performed using software specially developed for the processing and analysis of volume images (MAVI (modular algorithms for volume images); Fraunhofer ITWM, 2005).

SAMPLING AND STUDY AREA AT KOHNEN STATION

The μ CT measurements were carried out on 114 samples of a shallow firn core (B35) drilled during the 2005/06 field campaign at Kohnen station (75°00' S, 0°04' E), which is the EPICA (European Project for Ice Coring in Antarctica) deep drilling site at Dronning Maud Land (DML), Antarctica. The mean annual temperature at Kohnen station is about -44.6°C . The recent accumulation rate is estimated to be $62 \text{ mm w.e. a}^{-1}$. The firn core was sampled between 1 and 9 m depth. Stripes of $\sim 37 \text{ cm}$ length were selected at 1, 2, 3, 4, 6 and 8 m depth and cut into 15 samples of 2.5 cm height to obtain a series of short profiles of continuously measured intervals. Each such profile of 15 samples represents about 2–3 years of accumulation. At 3 m depth the sample interval was extended to 1 m (39 samples). Three samples from 4, 6 and 8 m depth were horizontally cut for 2-D cross-section measurements.

In DML the near-surface climate is mainly determined by katabatic winds and transient cyclones. Obvious features are snow dunes (barchans). Three events of dune formation at wind speeds higher than 10 ms^{-1} are observed during the 2005/06 summer campaign. Dune layers from past formation events are detected in the drilled firn cores by visual inspection of lengthwise-cut core sections. They can be distinguished by their smooth surface with small pores that are filled with white ice powder due to the strong hardness and the compact fine-grained microstructure. The boundaries to the neighboring layers are sharp. This indicates the strong impact of wind drifts on the microstructure of deposited snow and the persistence of dunes against erosion processes. The inspection of firn cores from nine drill sites reveals an average of two dune layers per firn meter.

METHODOLOGICAL ASPECTS

Representative volumes

The first calculations are performed to investigate the size effect of the sample on the relative density D , as well as on




Fig. 3. The evolution of normalized standard deviations from relative density, Euler and coordination number with sample size. The dashed lines extrapolate the trends to the cube length of 400 voxels indicating the size of the cubes finally used for the 3-D calculations.




Fig. 4. Comparison of μCT densities with values from weighted bag means. The two lines follow the mean profile of the weighted bag means and highlight the two regimes of different densification rates. The critical density D_0 at the kink of the profile is about 0.52.

the Euler and coordination numbers E and Z . The reconstructed firn cubes with an original size of 400^3 voxels (4.096 cm^3) are divided into eight disjoint cubes of 200^3 voxels (0.512 cm^3) followed by a separation into eight disjoint cubes of 150^3 (0.216 cm^3), 100^3 (0.064 cm^3) and 50^3 voxels (0.008 cm^3). D , E and Z are estimated for each cube. Then the standard deviations are calculated for each set of eight equal-sized cubes. The calculations are carried out for three firn samples from different depths. The overall changes of relative standard deviations $\sigma D/D$, $\sigma E/E$ and $\sigma Z/Z$ with size are displayed in Figure 3. Density D shows the smallest relative deviations compared with the other parameters. The uncertainty is $<5\%$ at sample volumes of 0.5 cm^3 . E and Z show relative standard deviations of about 8% at the 0.5 cm^3 level starting at much higher uncertainties for small samples. The relative standard deviations decrease rapidly with increasing size. Simple extrapolation to larger volumes yields uncertainties clearly below 5% for an eight-fold increase to 4 cm^3 . The μCT parameters displayed in Figures 4–7 are all calculated from firn cubes with volumes of 4.096 cm^3 . Note that the large variability on the cm scale in almost all parameters is mainly not caused by uncertainties but points to the strong horizontal layering at that specific Antarctic site already detected by visual inspection. A detailed description of these features favors small sample sizes. Thus a restriction to about 4 cm^3 sample volume seems to be the best compromise between inherent uncertainty and natural fluctuations.

Validation

The relative density was independently measured by weighting core bags of known volume. The relative densities are mean values averaged over core pieces with 10 cm diameter and 30–100 cm length (personal communication from H. Oerter, 2006). For comparison, the μCT densities are averaged over 16 samples from the 37 cm long stripes. Overall, the μCT densities are in good agreement with the mean relative densities derived from weighted bag samples (Fig. 4).

Comparison with 2-D methods

The μCT coordination numbers, bond and grain radii are compared with the values derived from 2-D cross-sections using methods described in Kry (1975) and Alley (1987b). The values for three samples of different depth are compiled in Table 1. The harmonic mean used for the 2-D calculations of bond radii is very sensitive to contributions of small sizes which are in turn potentially interfered with by image noise. Therefore, mean 2-D bond radii are calculated twice with and without the smallest size class of lengths between 3 and $30 \mu\text{m}$ (1–10 pixels). In the studied cross-sections, about 3% of identified grain bonds belong to the smallest size class. The μCT bond radii are within the range $\pm 20\%$ of the mean 2-D bond radii calculated without the smallest size class using the method of Alley (1987b). Including that bond class would reduce the mean bond radii and increase Z_3 up to 25% (see values in parentheses, Table 1). The reduced bond radii seem to be unrealistically small in comparison to bond radii calculated from selected grain constrictions using the method of Kry (1975). Thus we believe that the 2-D calculations without the smallest size class probably give the best estimates. However μCT coordination numbers are not always well reproduced by Z_3 derived from the 2-D cross-sections. A high negative Euler number implies high connectivity without being reflected in Z_3 for the sample at 4.24 m depth. Here the connectivity indicated by the Euler number might be related to the connectivity of crystallite agglomerates rather than to the connectivity of single crystallites. The existence of crystallite agglomerates is supported by the fact that the μCT grain radii R_{agg} are much larger than the grain radii R_{crystal} derived from the 2-D cross-sections with visible crystallite boundaries. The volume of a crystallite agglomerate is about 2–5 times larger than the volume of a single crystallite.

μCT MEASUREMENTS AT KOHNEN STATION

Depth profiles of relative density D , Euler number E , coordination number Z , bond and grain radii r_b , R_{agg} are




Fig. 5. Depth profiles from B35 at Kohnen station for specific Euler number E_v , coordination number Z , grain radii R_{agg} and bond radii r_b derived from the 3-D μ CT measurements.




Fig. 6. Bond radii r_b vs grain radii R_{agg} derived from 3-D μ CT measurements.




Fig. 7. Coordination number Z vs relative density D . The data are separated into samples from dune layers (crosses) and dune-free layers (circles). Linear regression results in curves of similar slope of about 13.

displayed in Figures 4–8. Almost all parameters exhibit a large variability on the cm scale. Layers of high density, small grain radii, high connectivity and negative Euler number are identified as snow dune layers. The kink in the density profile indicating the regime shift of the dominant densification processes is located at about 10 m depth (Fig. 4). The mean critical density $D_0 = 0.52$ is slightly lower than the expected value of 0.55 using the empirical relationship from Arnaud and others (2000, equation 8). The mean bond and grain radii (agglomerates) grow rapidly from 1 and 4 m depth (Fig. 5). There is only a slight increase of grain radii below 4 m depth. The growth of bonds is linked to the development of larger grains. Bond and grain radii are linearly correlated with a ratio of about 0.3 (Fig. 6). The coordination number continuously increases along the whole profile, whereas the Euler number remains fairly constant apart from some high negative values. These outliers are associated with dune layers. For all dune layers the coordination number is larger than 6. The coordination number is linearly correlated to the relative density (Fig. 7) with a slope of approximately 13. There is an offset between dune and dune-free layers. Dune layers show higher coordination numbers than dune-free layers for equal densities.

DISCUSSION AND CONCLUSIONS

It has been shown above that the topological properties of polar firn can be estimated from μ CT volume images of about 4 cm^3 size with $40\ \mu\text{m}$ resolution. This allows estimation not only of the mean behaviour with depth but also of the distinct properties of firn layers. Without further assumptions, the calculated specific Euler number provides information about the connectivity of the ice network in terms of number and size of bonds. The mean specific Euler number in the low-density regime at Kohnen station is remarkably constant with depth (Fig. 5). There must be a compensation of two contrary processes. The growth of crystallites and agglomerates reduces the number of bonds per volume, whereas further densification generates new bonds. For detailed examinations, one has to separate the ice network into single objects. The separation is at some point arbitrary because the μ CT technique does not supply information about the 3-D outline of crystallites or crystallite boundaries. In our approach we suggest using the connectivity function which separates objects at small bridges. This allows us to derive the number of bonds per potential object (coordination number). From the inspection of 2-D

cross-sections we conclude that the geometrical constrictions are mainly linked to crystallite boundaries. The objects separated by μ CT have 2–5 times larger volumes than single crystallites observed from 2-D cross-sections. This implies that the ice network consist of agglomerates formed by two to five single crystallites.

The 2-D method used by Alley (1987b) to derive bond sizes between single crystallites seems questionable. The assumption of disk-shaped bonds is not realistic if all crystallite boundaries are interpreted as bonds. The arithmetic mean of crystallite boundaries identified on the 2-D images seems to be a better parameter than the harmonic mean. Small lengths are related to boundaries of exceptionally small crystallites rather than to bond shape features. The high sensitivity of the harmonic mean to small-sized bonds would lead to a strong underestimation of the intercrystalline bonds if non-disk-shaped bonds are counted. For intercrystalline bonds derived by 2-D methods, bond sizes are actually lower than those of agglomerates derived by 3-D methods. This is contradictory because the 3-D method definitely detects all kinds of small connections. It is very likely that the 2-D method underestimates the grain bonds considerably. Furthermore, the 3-D bond estimates also show that there are no loosely bonded agglomerates in polar firn even at low density, as was proposed by Arnaud and others (2000) on the basis of 2-D images.

Our μ CT data confirm the linear relationship between the coordination number Z and relative density D (Fig. 7) formerly found by Alley (1988) from 2-D cross-sections. This is surprising because Alley (1988) derived Z for single crystallites, whereas in the 3-D approach Z is related to crystallite agglomerates. The slopes in both relationships differ slightly between 10 for single crystals (Alley, 1988) and 13 for agglomerates. Due to their complex shape, agglomerates tend to interconnect much more easily with increasing density.

An important feature of $Z(D)$ at Kohlen station is the offset between dune and dune-free layers. Dune layers exhibit higher coordination numbers than dune-free layers with equal densities. This difference points to a structural influence. A further difference to the data of Alley (1987a) is that Z is frequently larger than 6 although the critical density D_0 is not reached. The geometrical constraint of 6 for sliding is not valid for the separated crystallite agglomerates. We

suppose that in polar firn the ‘critical coordination number’ for sliding is higher than 6, as is known for arrangements of particles with non-spherical shapes (Blouwolf and Fraden, 2006). The formation and growth of crystallite agglomerates seem to be important for the critical density D_0 at a specific polar site. The depth profile shows that agglomerates grow rapidly in the uppermost 4 m (Fig. 5). This depth is about the limit for the occurrence of firn metamorphosis driven by temperature gradients (TGM). Below 4 m depth the firn is approximately isothermal with negligible seasonal temperature fluctuations. At polar sites with low accumulation rates, the snow and firn is exposed for a long time to TGM, with the consequence of strong growth of crystallite agglomerates. The enhanced formation of agglomerates would lead to an early geometrical-induced restriction of grain boundary sliding and would reduce the critical density D_0 . This behaviour is consistent with the trend of D_0 so far observed at several polar sites (Arnaud and others, 2000).
