Dynamics of the Party System: Alignment and Realignment of Political Parties in the United States

JAMES L. SUNDQUIST

This widely adopted book for courses on political parties presents a comprehensive historical analysis of the circumstances, causes, and processes of change in the political party system in the United States. Using the case study approach, the author blends the findings of traditional historical research and newer quantitative analytical techniques to examine the three major realignments of the American party system—those of the 1850s, the 1890s, and the 1930s—as well as some minor realignments. He concludes that a realignment comparable to the three major upheavals of the past is not apparent now. Looking ahead, however, he foresees a new strengthening of party attachment, but along the lines of the party system established in the 1930s rather than on new lines.
