Course Areas: 1) Social Change in Latin America; 2) Structural Linguistics

CIF LANGUAGE SCHOOL: Spoken Spanish

CIDOC SEMINARS: Personality and Institutional Change

The INSTITUTE offers the university student a new approach to the study of contemporary transformation in Latin America. Each course selects a specific problem, topic or issue vital to a global understanding of Latin America: geo-historical framework; characteristic universe of symbols and concepts; transformation of traditional institutions; urbanization and industrialization.

Professors of INSTITUTE courses are both experienced researchers and active participants in transformation and development of Latin America.

Course Area 1: COMPARATIVE STUDY OF CHANGING INSTITUTIONS IN LATIN AMERICA—Party, Church, Labor Union, University, School System, Student Organization, Industrial Plant and System. Each course will concentrate on one institution in one country during the last 15 years. Each will be made up of 15 to 30 class hours spread over four to nine weeks.

Course Area 2: STRUCTURAL LINGUISTICS—Two parallel courses of nine weeks' duration for which one may register for the first or second month, or both. One course will deal with structural linguistics applied to the teaching of Spanish as a second language. The second will study the theory of comparative structural analysis.

CIF LANGUAGE SCHOOL aims to teach Spanish as a second language to reach a functionally native fluency. A maximum of four students to the instructor, supervised laboratory work, and a minimum of 25 class hours per week (and more if the student wishes) make this an outstanding course for beginners, intermediate and advanced level students. Throughout the year, language courses for all fluency levels begins on the first Monday of the month. In June, July and August, additional courses begin on the third Monday.

CIDOC SEMINARS—Colloquys during Summer 1968 will focus on Personality and Institutional Change. Scholars are invited to discuss the topic from the point of view of their speciality. Students in INSTITUTE courses and the CIF Language School may also register to participate in these discussions after a personal interview.
