POLICY STUDIES Organization

The Policy Studies Organization has been active in expanding its publication activities during 1976. The spring symposium of its *Policy Studies Journal* dealt with "The Research Utilization Quandary" under the editorship of Carol Weiss. The summer symposium dealt with "Educational Policy Research" under the edi-

torship of Samuel Gove and Frederick Wirt. The autumn symposium will be on "Administering Public Policy" by George Frederickson and Charles Wise, and the winter symposium will be on "Science and Technology Policy" by Joseph Haberer. Those symposia will also be published in expanded book-length versions as part of the Policy Studies Organization Series of D.C. Heath and Company.

In addition to the quarterly symposia, the Policy Studies Organization is also adding to its Yearbooks in Politics and Public Policy published through Sage Publications. The 1976 volume is entitled *Public Policy in a Federal System* under the editorship of Charles Jones and Robert Thomas. The public policy panels at the 1976 APSA convention will serve as the basis for two forthcoming volumes in the series. One is entitled *Shaping Future Policy Strategy* under the editorship of Theodore Lowi and Alan Stone, and the other is entitled *Policy Studies and Public Choice* under the editorship of Douglas Rae.

Other PSO activities include the recent publication of the second edition of the Policy Studies Directory which provides a department-bydepartment survey of policy studies teaching, research, and related activities. The new edition has been expanded to include M.A. departments and interdisciplinary programs as well as political science Ph.D. departments. Questionnaires are now being sent to a variety of funding sources for the compilation of a Policy Studies Grants Directory. The Policy Studies Organization is currently headed by Thomas Dye, with Theodore Lowi as Vice President and President-Elect, and Stuart Nagel as Secretary-Treasurer. Utah State University NATURAL RESOURCE PROGRAM

Beginning in the Fall of 1976, the Department of Political Science, in cooperation with the College of Natural Resources, at Utah State University, will offer a new Master of Science Program. The focus of study is on Natural Resource Policy and Administration with comprehensive training in public policy analysis. Individuals who are currently employed by state and federal agencies and who wish to pursue graduate training may find this program especially attractive.

The program assumes a background in a natural resource related field such as Forestry, Range, or Wildlife, and a keen interest in the effective management of public resources. Students will study the development of public policy concerning natural resources and the administration of those policies. Particular attention will be given to the Intermountain West. Current issues such as energy development and public land use planning will provide the substance of analysis. Focus is on the design of political institutions and their responsiveness to public demands and preferences.

Within the scope of our program the analysis of natural resource problems is basically concerned with the questions: (1) What resource issues should be dealt with by government, (2) How are we now dealing with these issue areas, and (3) How can the performance of government institutions be improved to render them more responsive to the public demands for both increased production and a high quality environment?




