Unrecognized Patriots: The Jews in the American Revolution by Samuel Rezneck. LC 74-15160. xiv, 299 pp., \$13.95

Here is the story of the contributions early American Jews made to society and the legacy they left to succeeding generations. The story begins with the American Revolution itself—and extends through several post revolutionary themes.
