NOTES ON THE CONTRIBUTORS

Raymond Dennett is director of the World Peace Foundation in Boston, and lecturer in international politics at the Fletcher School of Law and Diplomacy. He is managing editor of International Organization, and co-editor, with Joseph E. Johnson, of the symposium Negotiating with the Russians (1951).

Albin T. Anderson is assistant professor of history at the University of Nebraska. The recipient of a Ford Foundation Faculty Fellowship, he has been working at the Russian Research Center, Harvard University, during the past year.

Paul E. Zinner is a graduate fellow at the Russian Research Center, Harvard University, engaged in writing his doctoral dissertation. He has contributed previously to World Politics.

Jean Gottmann is professor at the Institut d'Etudes Politiques of the University of Paris and a member of the Institute for Advanced Study in Princeton. His recent publications include A Geography of Europe (1951) and La politique des états et leur géographie (1952).
