The China Quarterly is pleased to award the 2010 Gordon White Prize to **Graeme Smith** for his article entitled "The Hollow State: Rural Governance in China" (September 2010, No. 203).

The £500 prize is awarded annually for the most original article or research report published in **The China Quarterly** in the relevant year.
