ESSAYS ON THE AMERICAN CONSTITUTION: A COMMEMORATIVE VOLUME IN HONOR OF ALPHEUS T. MASON Edited by GOTTFRIED DIETZE, Johns Hopkins University. This book is a traditional festschrift—a volume of essays contributed by students, colleagues, and admirers of Alpheus T. Mason, McCormick Professor of Jurisprudence at Princeton University and one of America's distinguished scholars. The essays were written by former students of Professor Mason and many of them, through contributions to learning in their own right, salute Dr. Mason by treating subjects associated with him in some way. 1964, 245 pp., \$6.95

PUBLIC ADMINISTRATION: A COMPARATIVE PERSPECTIVE by FERREL HEADY, The University of Michigan. A comparative treatment of public administration in a wide range of countries. The focus is on public bureaucracies as governmental institutions common to present day nation states. Characteristic features of administrations in both developed policies and developing nations are identified followed by specific examples of representative countries in all major types of political systems and in various regions of the world. VARIETIES OF POLITICAL THEORY Edited by DAVID EASTON, University of Chicago. David Easton brings together a number of original essays by distinguished social scientists who all deal with different ways of approaching the construction of general, empirically-orientated theories about politics. This collection reveals the extraordinary degree to which contemporary political theory has been stimulated by ideas originating outside the discipline of political science. These areas include, among others, organizational theory, structural analysis, economic theory, decision-making theory, action theory, and systems analysis. PEOPLE AND POLITICS: AN ANALYSIS OF THE AMERICAN POLITICAL SYSTEM by LEWIS A. FROMAN, JR., University of California, Irvine. An integration of numerous political, social and psychological hypotheses into a consistent theory based on the premise that political decisions involve the distribution of advantages and disadvantages among people with different resources. The author then analyzes six major institutions in American politics. 1962, 114 pp., paper \$2.25

THE PROMISE OF POLITICS by HENRY S. KARIEL, University of Hawaii. An explicit counterposition to the conventional model of political analysis. Revises the prevailing conception of political man and calls attention to America's failure, due to contemporary political science, to reach political maturity. Can be used as supplementary reading for courses in political science, economics, and the philosophy and sociology of politics. September 1966, 118 pp., paper, \$1.95
