## Award Prize of $\$ 300$

A cash prize of $\$ 300$ is awarded to the author of the best article, in the opinion of the judges, submitted to the Western Historical Quarterly' on any phase of the history of the Spanish Borderlands, that region reached by the northern thrust of the Spanish in North America, from the Floridas to the Californias, from the fifteenth century to the present day. Essays are preferred on major political, economic, and social developments, cultures, peoples, institutions, and movements, including the great northward movement of Mexicans into the United States in the twentieth century. Broad essays of synthesis or new interpretations are encouraged.

The winning essay will be published in the Western Historical Quarterly. Manuscripts should be from 5,000 to 7,500 words, typewritten in conformity with the editorial style of $W H Q$, and submitted by September 1, 1974, for the 1974 award. The winner will be announced at the 1974 Western History Association conference and in the January 1975 issue of $W H Q$. If in the opinion of the judges no manuscript merits the prize, no prize will be given that year. The monetary prize is made through the generosity of Lawrence Kinnaird, Professor Emeritus of History, University of California, Berkeley.
