Normally, accepted manuscripts are published within four months or less from the date of submission.

The editorial pages and the table of contents for the *Archives* are to be found in each issue of the *Philosopher's Index*.

Yearly volumes are available on microfiche at a cost of \$20 for institutions and \$10 for individuals. Copies of individual articles are available in the form of page prints.
