

The First Afghan War 1838-1842 J. A. NORRIS

Believing that Sir John William Kaye, the Victorian authority on this war, made some strong partisan judgments which still have not been challenged, J. A. Norris has reexamined the original sources including some that were not available to Kaye.

This study attempts to assess the political significance of the Afghan incident, relating it to the Eastern question, and at the same time to vindicate the actions of Lord Auckland and Alexander Burnes. 


