Steven A. Bank is professor of law and vice dean at the UCLA School of Law. His recent publications include *War and Taxes* (2008) (with Kirk Stark and Joe Thorndike), “Tax and the Separation of Ownership and Control,” in *Tax and Corporate Governance*, ed. Wolfgang Schon (2008) (with Brian R. Cheffins), “Corporate Ownership and Control in the U.K.: The Tax Dimension,” *Modern Law Review* (2007) (with Brian R. Cheffins), “Dividends and Tax Policy in the Long Run,” *University of Illinois Law Review* (2007), and “A Capital Lock-In Theory of the Corporate Income Tax,” *Georgetown Law Journal* (2006). He is also coauthor of *Taxation of Business Enterprises*, 3rd ed. (2006) (with Robert Peroni and Glenn Coven).

Carsten Burhop has been the Heisenberg Fellow at the Max Planck Institute for Research on Collective Goods in Bonn, Germany, since 2007. His research interests include German economic and business history especially in relation to finance, the history of innovations and patents, and the history of national accounting. He also studies British–German comparative economic and business history. Among his recent publications are “Cartels, Managerial Incentives, and Productive Efficiency in German Coal Mining,” in the *Journal of Economic History* (2009), and “Corporate Governance and Incentive Contracts: Historical Evidence from a Legal Reform,” in *Explorations in Economic History* (2009).

Rafael Castro, a PhD candidate at the Universidad Complutense de Madrid and visiting researcher at the U.F.R. d’Études Européennes at Université Paris III—Sorbonne Nouvelle, is writing his dissertation on the long-term development of French investment in Spain. He has published several articles on the role of French banks, engineering, and retailing in the economic and business development of Spain and on the internationalization of Spanish firms.

Brian R. Cheffins is the S. J. Berwin Professor of Corporate Law at the Faculty of Law, University of Cambridge, and a fellow of the European Corporate Governance Institute. His book *Corporate Ownership and Control: British Business Transformed* was recently published by Oxford University Press. His publications also include “Outside Director Liability,” *Stanford Law Review* (2006) (coauthored with Bernard Black and Michael Klausner), “Dividends as a Substitute for Corporate Law: The Separation of Ownership and Control in the United Kingdom,” *Washington and Lee Law Review* (2006), and “The Eclipse of

Private Equity,” *Delaware Journal of Corporate Law* (2008) (with John Armour).

David Merrett is professor in the Department of Management and Marketing at the University of Melbourne. He is currently researching Australian and international economic and business history, including wool-marketing arrangements, international banking in the inter-war period, Australian competition policy, and the internationalization of Australian firms in the last quarter of the twentieth century. His latest books are *The Big End of Town: Big Business and Corporate Leadership in Twentieth-Century Australia* (2004), cowritten with Grant Fleming and Simon Ville, and *The Internationalisation Strategies of Small-Country Firms: The Australian Experience of Globalisation* (2007), which he coedited with Howard Dick.

Yovanna Pineda is associate professor of Latin American history at St. Michael's College where she has taught since 2001. Her recent book, *Industrial Development in a Frontier Economy: The Industrialization of Argentina, 1890–1930*, was published by Stanford University Press in 2009.

Núria Puig is professor of economic and business history at the Universidad Complutense de Madrid. Her research interests include transnational economic influences, national business cultures, and the role of business groups and family firms in twentieth-century Spain. Her most recent publications are “A Silent Revolution: The Internationalization of Large Spanish Family Firms,” in *Business History* 51 (May 2009), and “Global Lobbies for a Global Economy: The Creation of the Spanish Institute of Family Firms in International Perspective,” in *Business History* 51 (September 2009), both coauthored with Paloma Fernández. She is currently a visiting scholar at the Minda de Gunzburg Center for European Studies at Harvard University.

Simon Ville is professor and head of the School of Economics at the University of Wollongong in Australia, where he specializes in the economic and business history of Britain, Europe, Australia, and New Zealand. He is a fellow of the Academy of Social Sciences in Australia and president of the Economic History Society of Australia and New Zealand. His most recent books are *The Development of Modern Business* (with Gordon Boyce, 2002); *The Big End of Town: Big Business and Corporate Leadership in Twentieth-Century Australia* (with Grant Fleming and David Merrett, 2004); and *How Organisations Connect: Investing in Communication* (edited with Stuart Macintyre and Gordon Boyce, 2006).
