# Journal of Policy History

The *Journal of Policy History* provides an interdisciplinary forum for scholars concerned with the application of historical perspectives to public policy studies. The journal aims to encourage research into the formation and development of public policy while encouraging the application of diverse methods and theories to public policy and their politics within a historical perspective. In addition to social scientists and historians, the journal seeks to inform policymakers through a historical approach to public policy.

The Journal of Policy History is intended to give voice to scholars interested in understanding public policies and their development through historical inquiry and interpretation. The journal publishes historical studies of specific policy areas and policy institutions, and explores continuities and shifts in policy over time. The journal encourages interdisciplinary research into the origins and development of public policy in the United States and other countries. Comparative historical approaches to the development of public policies are also welcomed.

Manuscripts should be typed and double-spaced with end notes following the text and generally should not exceed 8,000 words. *Please follow the Chicago Manual of Style for citation format*. Manuscripts accepted for publication will be reviewed anonymously, and authors' names, including positions, addresses, and phone numbers, should appear only on the title page. Four copies of a manuscript, an abstract of no more than 150 words, and a biographical sketch of no more than 50 words should be sent to the Editor, *Journal of Policy History*, Saint Louis University, 3800 Lindell Blvd., P.O. Box 56907, St. Louis, MO 63156-0907. Please include with your submission a disk (IBM formatted for MS Word or Word Perfect) that contains the manuscript, abstract, and biographical statement. The Journal of Policy History proudly announces the founding of the Hugh Davis Graham Research Fund, sponsored by the Institute of Political History. This fund was established to honor the late Hugh Davis Graham (1936-2002). Graham was educated in the public schools of Nashville, Tennessee. He attended Yale University (B.A., 1958) and Stanford University (Ph.D., 1964). After tours of duty in the U.S. Marine Corps and the Peace Corps, he taught history at Johns Hopkins University and the University of Maryland, Baltimore County, before joining the faculty of

Vanderbilt University in 1991 as the Holland N. McTyeire Professor of History. He was the author or editor of sixteen books in American history.

In order to honor Graham and to promote research in policy history and political history, the Hugh Davis Graham Research Fund was established in 2004 with initial gifts from friends and family. This fund will provide research stipends for graduate students and established scholars doing archival research in policy and political history. Doctoral students, junior scholars, and senior scholars will be eligible for support from the Fund.

The campaign committee to establish the Hugh Davis Graham Research Fund is chaired by Julian Zelizer (History, Boston University) and includes Jane DeHart (History, University of California, Santa Barbara), Otis Graham (History-emeritus, University of California, Santa Barbara), Samuel McSeveney (History-emeritus, Vanderbilt University), James Mohr (History, University of Oregon), James Patterson (History-emeritus, Brown University), and Byron Shafer (Political Science, University of Wisconsin, Madison). The Fund is established as a restricted account through the Institute for Political History. Organized exclusively for charitable and educational purposes, the Institute was established in 2000 as a tax-exempt organization under section 501 C (3) of the Internal Revenue Code and is incorporated in the state of Missouri.
