### An Archaeological Perspective

His introduction to AN ARCHAEOLOGICAL PER-SPECTIVE is a highly personal account of his experiences as a rebel anthropologist whose concepts have only recently

been accepted by traditional archaeologists. With candor reminiscent of Watson's THE DOUBLE HELIX he describes the intense conflicts and passions that arise when man studies man. The rest of the book is divided into four sections-Archaeological Method and Reasoning, Data Collection, Theory and Assumption, and Analysis—each of them introduced in a short essay by Professor Binford.


