IN MEMORIAM

Leonard Dupee White, a member of the University of Chicago faculty from 1920 to 1956, and for three decades the most influential figure in the study of American public administration, died on February 23, 1958. After a serious operation in August, 1956, he had recovered sufficiently to resume his work, and had completed the fourth and final volume of his administrative history of the United States before his death.

Leonard White was born in Acton, Mass., on

January 17, 1891. He graduated from Dartmouth College in 1914, and received his Ph.D. from the University of Chicago in 1921. He taught at Dartmouth and Clark University before joining the U. of Chicago faculty in 1920. With the encouragement of Charles E. Merriam, White began to develop courses and research in public administration, and in 1926 published the first textbook in that field, *Introduction to the Study of Public Administration*. Running through four editions, this book did more than
