Second World Congress on Soviet and East Euripean Studies (September 30-October 4, 1980)

Prof. Dr. Oskar Anweiler, Chairman of the Planning Committee, has officially notified the Association that the ASN will be represented at the Congress with two sessions and an informative meeting with participants in the Congress. ASN IN GERMANY

Recently I had an opportunity to visit several German East European institutes at the universities of Munich, Heidelberg, and Tubingen as well as the Auslandsinstitut in Stuttgart and Bayerische Staatsbibliothek in Munich. In addition to establishing contacts with those institutions, my visit resulted also in the promotion of the Nationalities Papers and ASN monographs. Some 25 subscriptions to our journal come from Germany, and we are looking toward closer collaboration with our German colleagues. To this end I have met in Munich with Dr. Rudolf Hilf, an executive member of the International Institute for Nationality Rights and Regionalism, which represents scholars from various European countries interested in nationalities problems and conflicts. The Institute believes that "in developing a charter of nationality rights (ethnic group rights) and principles of regionalist independence and self-determination, instruments can be created to reduce the dangers of armed conflict and safeguard the peace."

Bayerische Staatskanzlei, Landeszentrale für politische Bildungsarbeit, in cooperation with the International Institute for Nationality Rights and Regionalism held a special study conference "Regionalism in Europe" in Brixen (South Tirol) from October 31 to November 3, 1978. Some 26 scholars from several European countries delivered papers covering many aspects of the conference's topic.

The sixth conference of the Association for the Advancement of Baltic Studies (AABS) was held May 11-14, 1978, at the University of Toronto. Over 100 papers covering eleven subjects, in addition to an art exhibition, made that conference a great success attended by some 250 individuals from the USA, Canada and Europe. The chairman of the Program Committee, Prof. Juris Dreifelds, is also an active member of the ASN.

The first Ukrainian Historical Conference was held on May 29-31, 1978, within the framework of the annual meeting of the Canadian Association of Slavists, at the University of Western Ontario in London, Ontario. The conference was organized jointly by the Canadian Institute of Ukrainian Studies, the Harvard Ukrainian Research Institute, and the Ukrainian Historical Association.

Seventeen papers read at the conference dealt with such issues as Historiography, the historical legacy of Kievan Rus', Ukraine's part in the Russian revolution, the role of the city in Ukrainian history, the Ukraine and the Moslem world, the question of the Ukrainian elites, and Poland's policy in the Ukraine. The following members of the ASN delivered papers: Orest Subtelny, Oleh S. Fedyshyn, Lubomyr R. Wynar, and Roman Szporluk.

The papers of the conference will be included in a symposium to be published by the CIUS.

The Shevchenko Scientific Society in America commemorated its 30th anniversary with a conference held at Columbia University and the Ukrainian Institute in New York, November 24-26. 1978.

Fifty papers read at the conference dealt mainly with a review of activities of that institution established in Lviv in 1873. Its long scholarly tradition is continued in the United States by an American Branch of the Shevchenko Scientific Society founded thirty years ago.
