This book seeks to understand the workings of national politics in Singapore and the hegemony of the People's Action Party Government through a micro-level analysis of the political system. It represents the first systematic exploration of the relationship between the governors and the governed—of how people are ruled—through an investigation of local interests, the party organization, local non-party institutions, the local bases of support, and the management of local issues. The dynamics of politics at the grass-roots is then related back to the macro-level development.

The author shows how the political base is structured and a petitionary political culture is nurtured to buttress the existing political system.



SOUTHEAST ASIAN AFEAIRS 1976

Southeast Asian Affairs 1976, third in the series, places special emphasis on the ASEAN countries, while other countries in the Southeast Asian region and topics pertaining to them are not entirely neglected. The publication aims primarily at giving the enquiring reader and student a broad grasp of current regional affairs. Readable and easily understood analyses are made of the major political, economic, social and strategic developments within Southeast Asia. The result has been a collection of essays in which the facts and the accompanying analyses are presented in a simple and interesting fashion.

Southeast Asian Affairs 1976 presents two broad groups of contributions. There are those which highlight and, if necessary, explain the main political, economic and social events and developments of the year in individual countries and for the region as a whole. These papers are supported by articles dealing with issues of current interest but not necessarily relating to the calendar year 1975. Contributors to the volume represent a broad spectrum of disciplines and come from a wide diversity of countries, but the majority are Southeast Asians.

Although the subject matter is quite extensive in range, the articles generally focus on the more important questions in the political, economic and social fields that have been of relevance to the region. These questions refer, for instance, to the Vietnam War and its aftermath — including the changing balance of political power in the region and its security aspects — the relationship between the Southeast Asian countries and the People's Republic of China, great power influences in the region, and maritime problems and policies. In conformity with the prevailing mood of many governments of the region, problems of national unity and of national language, and economic and social developments have also been treated at length in some of the articles.
