'Amr, son of Qami'ah, who lived in the 5th century A.D., belonged to the great tribe of Bakr, son of Wā'il, and to the section of it called after Qais, son of Tha'labah. Of his life very little is recorded by tradition. A few only of his compositions, mostly short, are well known. 'Amr is rather sparingly cited in works of Adab or Belles-lettres, perhaps because his style is, like that of the earlier poets in general, simple and easily intelligible, and free from takalluf or curiositas.

## The Dîwân of Ghailân Ibn 'Uqbah

known as Dhu'r-Rummah.

The present work is the first printed edition of the Dîwân, or collected verse, of Dhu'r-Rummah, the last of the great Bedouin poets. Apart from the scarcity of MSS, the long neglect of this famous poet is the more remarkable as in his own time and among his own people he was held in high esteem by virtue of the intrinsic beauty of his verse; further, he was continually cited by native scholars, lexicographers, and grammarians as an authority on philological points. Of these he had an intimate knowledge, and his use of the true ancient Bedouin idiom, then dying out as a literary medium, is always accurate. The present edition, as regards almost all the most important poems in the collection, is based upon two remarkable MSS, which have the rare authority of having through a short chain of transmission been taken down from the poet's own mouth. With these credentials it is hoped that the appearance of this book may be acceptable to scholars, and that, apart from the beauty of the verse itself, they may find in it much to reward study, and feel satisfaction that a gap in Arabic literature—too long vacant—is now filled.
