# Contributors

Pak K. Auyeung is senior lecturer at Griffith University in Queensland, Australia. Among his research interests are accounting history, financial reporting, and accounting education. He has published articles in various journals, including Accounting Historians Journal; Accounting, Business & Financial History; Accounting and Finance; and Accounting Education (U.K.).

Lei Fu is professor of accounting at Capital University of Economics and Business in Beijing, where he is also currently dean of the Accounting School. He conducts research in accounting history, accounting theory, accounting education, and accounting reform in China, and he has published extensively in the journal Accounting Research.

Louis Galambos is professor of history, editor of the Papers of Dwight D. Eisenhower, and codirector of the Institute for Applied Economics and the Study of Business Enterprise. He recently published (with Roy Vagelos) Medicine, Science, and Merck (2004), and (with Eric John Abrahamson) Anytime, Anywhere: Entrepreneurship and the Creation of a Wireless World (2002). His essay "The U.S. Corporate Economy in the Twentieth Century" was published in The Cambridge Economic History of the United States, Volume 3: The Twentieth Century, and he is a coeditor of the Cambridge Studies in the Emergence of Global Enterprise.

Zhixiang Liu is associate professor of accounting at Capital University of Economics and Business in Beijing. His research interests include financial accounting and budgeting, and he has published a number of articles in the journal *Modern Accounting*.

Paul J. Miranti is professor in the Department of Accounting and Information Systems at Rutgers Business School—Newark and New Brunswick. Prior to returning to the faculty in 2002, he served as the school's associate dean of faculty and research for three years. His previous books include Accountancy Comes of Age: The Rise of an American Profession, 1886–1940, A History of Corporate Finance coauthored with the late Jonathan B. Baskin, and The Institute of Accounts: Nineteenth Century Origins of Accounting Professionalism in the United States, coauthored with Stephen E. Loeb. His current research is on the learning processes that extended the effectiveness of managerial capabilities through the integration of probability theory at the Bell System before World War II.
