# International Law

The Essential Treaties and Other Relevant Documents Edited by Ingo von Münch and Andreas Buske 1985. 23 x 15,5 cm. XX, 702 pages. Cloth. DM 178,-

The book contains a collection of the most important treaties in international law with an introduction by the editors.

A variety of factors suggests that public international law is constantly gaining in importance. The prime cause is that the number of subjects of international law is considerably higher than previously. For example, the number of states – the most important subjects of international law – quadrupled within the past seventy years. In 1913, the record listed 43 states. In 1939, the League of Nations listed 63 member states while Brazil, Germany and Italy had left the League and the Soviet Union had been excluded. In December 1984, the United Nations Organization had 159 member states.

The process of decolonization has not yet finished. As a result, it is quite possible that, eventually, the world will have a total of more than 200 states. The increasing number of states causes both the number of parties to multilateral treaties and the number of bilateral treaties to multiply.

Three forms of law – public international law, constitutional law or a law sui generis – may govern the relations of a federal state with its member states and the relations of member states among each other. Public international law does not prescribe a specific form. Apart from a general rule, a federal state is free to determine the nature of these relations. Thus, a federal constitution may grant permission to the member states to conclude treaties with foreign states. Such treaties will be treaties of public international law provided that (1) the foreign state recognizes the "member state" as a subject of international law for the purposes of the treaty; and (2) the treaty concerns state acts.
