ON THE DECAY OF SOLUTIONS FOR SOME NONLINEAR EVOLUTION EQUATIONS OF SECOND ORDER

YOSHIO YAMADA

1. Introduction

In this paper we consider nonlinear evolution equations of the form

(E)
$$u''(t) + Au(t) + B(t)u'(t) = f(t), \quad 0 \le t < \infty$$

 $(u''(t) = d^2u(t)/dt^2, u'(t) = du(t)/dt)$, where A and B(t) are (possibly) nonlinear operators. Various examples of equations of type (E) arise in physics; for instance, if $Au = -\Delta u$ and B(t)u' = |u'|u', the equation represents a classical vibrating membrane with the resistance proportional to the velocity. As to the initial value problems for (E), many authors have established various sufficient conditions on A and B(t) so that there exists a global solution of (E) (see e.g. Barbu [4], Lions [10] and Tsutsumi [18]).

As for the asymptotic behavior of solutions of (E), Nakao [14], [15] has recently obtained interesting results under the appropriate assumptions on A and B(t); in [15] he treats the case when A as well as B(t) depends on t. When f(t) tends to zero (in some sense) as $t \to \infty$, he showed that any global solution of (E) satisfying the energy equation satisfies a difference inequality of the form

$$\sup_{t\leq s\leq t+1} E(s)^{{}_{1+lpha}} \leq C(t+1)^{{}_{7}} \{E(t)-E(t+1)\} + g(t)$$
 ,

where E(t) denotes the energy associated with such a solution, g(t) is a nonnegative function tending to zero as $t \to \infty$ and α, γ and C are some positive constants. From this inequality he derived the decay property of E(t): if f(t) tends to zero in an appropriate sense as $t \to \infty$, then E(t) decays to zero as $t \to \infty$.

The main purpose of the present paper is to discuss the asymptotic behavior of solutions of (E). We put almost the same assumptions on

A and B(t) as those of Nakao [15] so that the decay property of (E) holds; but, for simplicity of arguments, the case when A depends on t is not treated here. Moreover, we assume that there exists a global solution of (E) which satisfies a certain kind of an energy inequality (see (2.6)). Then our problem is the following: if f(t) tends to zero as $t \to \infty$, how fast does the energy E(t) decay to zero as $t \to \infty$? Our approach to this problem relies on the weighted energy method and is quite different from Nakao's. In order to investigate the rate of the decay of E(t), we introduce a pair of $\{G(t), h(t)\}$ of two monotone increasing functions on $[0, \infty)$ which satisfy several conditions (see §2.4). We take G(t) as a weight function of E(t) and take h(t) as an auxiliary function of G(t). Using this pair $\{G(t), h(t)\}$, we can show

$$\sup_{t\geq 0} G(t)E(t) < \infty \ .$$

If the rate of the convergence of f(t) to zero is known, we can obtain, with a suitable choice of $\{G(t), h(t)\}$, preciser results on the rate of the decay of E(t) than those of Nakao [14], [15].

The content of this paper is as follows. We introduce some notation in §2.1 and give some assumptions on A and B(t) in §2.2. In §2.3 we define a solution of (E) which has the weak conservation property. Main results (Theorems 1, 2 and 3) are stated in §2.4. §3 is devoted to the proofs of Theorems 1, 2 and 3. Finally, in §4 we apply our results to some nonlinear partial differential equations such as the nonlinear wave equations and the nonlinear beam equations.

§2. Assumptions and Results

2.1. Preliminaries

We first of all explain some notation which will be used later.

Let X be a real Banach space. We denote the norm in X by $|\cdot|_X$ and denote the dual space of X by X*. The pairing between $x^* \in X^*$ and $x \in X$ is denoted by $(x^*, x)_X$.

Let $1 \leq r < \infty$ and $a \leq b$. When X is a real Banach space, we say that f belongs to $L^{r}(a, b; X)$ if f is measurable in $a \leq t \leq b$ with values in X and satisfies

$$|f|_{L^{r(a,b;X)}} < \infty$$
 ,

where

In particular, for $X = \mathbf{R}$ we simply write $L^r(a, b) = L^r(a, b; \mathbf{R})$. Finally, we define $L^r_{loc}(0, \infty; X)$ by

$$L^r_{\text{loc}}(0,\infty;X) = \{f: [0,\infty) \to X; f \in L^r(0,T;X) \text{ for any } T > 0\}.$$

2.2. Assumptions

We are given a real Hilbert space H and two real Banach spaces V and W which satisfy

$$V \subset W \subset H$$
 ,

where each inclusion mapping is continuous. Then there exist positive constants c_1 and c_2 such that

$$|v|_{W} \leq c_{1} |v|_{V} \quad \text{for } v \in V$$

and

(2.2)
$$|w|_{H} \leq c_{2} |w|_{W}$$
 for $w \in W$.

Moreover, we assume that V is dense in W and H. We identify H with its own dual, so that the following inclusion relation holds

$$V \subset W \subset H \subset W^* \subset V^*$$
.

The natural pairing between $u^* \in V^*$ (resp. $u^* \in W^*$) and $u \in V$ (resp. $u \in W$) is denoted by $(u^*, u)_V$ (resp. $(u^*, u)_W$); if $u^*, u \in H$, this is the ordinary inner product $(u^*, u)_H$ in H.

Besides these spaces we are given two nonlinear operators A and B(t) which satisfy the following assumptions.

(A.1) $A: V \to V^*$ is the Fréchet derivative of a convex functional F_A on V such that

$$F_{A}(0) = 0$$

and

$${F}_{\scriptscriptstyle A}(u) \geqq a \, | u |_V^p \qquad ext{for } u \in V$$
 ,

where a > 0 and $p \ge 2$.

(A.2) For each $0 \leq t < \infty$, $B(t): W \to W^*$ satisfies

 $(B(t)u, u)_W \ge b_1 \beta(t) |u|_W^q$ for $u \in W$,

and

$$|(B(t)u, v)_W| \leq b_2 \beta(t) |u|_W^{q-1} |v|_W$$
 for $u, v \in W$,

where $b_2 \ge b_1 > 0$, $q \ge 2$ and $\beta(t)$ is a positive continuous function on $[0, \infty)$.

Finally we assume

(A.3)
$$f \in L^{\infty}(0, \infty ; W^*)$$

Remark 2.1. Assumption (A.1) implies

(2.3)
$$(Au, u)_V \ge F_A(u) \ge a |u|_V^p \quad \text{for } u \in V .$$

Indeed, since, by the convexity of F_A ,

$$\alpha(F_A(0) - F_A(u)) \ge F_A(u + \alpha(0 - u)) - F_A(u) , \qquad 0 < \alpha < 1, u \in V ,$$

we conclude, by dividing both sides of the above inequality by α and letting $\alpha \downarrow 0$, that (2.3) holds.

Remark 2.2. We can replace (A.1) with a slightly weaker assumption (A.1)':

(A.1)' $A: V \to V^*$ is the Fréchet derivative of a convex functional F_A on V such that

$$F_{A}(0) = 0$$

and

$$F_A(u) \ge a_1 |u|_{V_1}^p$$
 for $u \in V$,

where $a_1 > 0$, $p \ge 2$ and V_1 is a real Banach space such that $V \subset V_1 \subset W$ and the inclusion mapping of V_1 into W is continuous.

In what follows, we treat only the case of (A.1) because the arguments in the case of (A.1)' are quite similar (see Remark 3.1).

2.3. Definitions

Under assumptions (A.1)-(A.3) we consider abstract nonlinear evolu-

tion equations of the form

(E)
$$u''(t) + Au(t) + B(t)u'(t) = f(t), \quad 0 \le t < \infty$$

where $u''(t) = d^2u(t)/dt^2$ and u'(t) = du(t)/dt. We first define a class of solutions of (E) in which we investigate (E).

DEFINITION 2.1. Let $u: [0, \infty) \to V$. Then u is called a *solution* of (E) if $u \in L^{\infty}_{loc}(0, \infty; V)$, $u' \in L^{\infty}_{loc}(0, \infty; H) \cap L^{q}_{loc}(0, \infty; W)$ and, for every such function $\phi: [0, \infty) \to V$, u satisfies

$$(u'(t), \phi(t))_{H} + \int_{0}^{t} \{-(u'(s), \phi'(s))_{H} + (Au(s), \phi(s))_{V} + (B(s)u'(s), \phi(s))_{W} \} ds$$

$$= (u'(0), \phi(0))_{H} + \int_{0}^{t} (f(s), \phi(s))_{V} ds , \qquad 0 \leq t < \infty .$$

DEFINITION 2.2. Let u be a solution of (E). Then the energy E(t) is defined by

(2.5)
$$E(t) = \frac{1}{2} |u'(t)|_{H}^{2} + F_{A}(u(t)) .$$

Moreover, it is called that u has the *weak conservation property* if, for any positive C^{1} -function ψ on $[0, \infty)$, u satisfies

(2.6)
$$\psi(t)E(t) + \int_{s}^{t} \psi(r)(B(r)u'(r), u'(r))_{W}dr$$
$$\leq \psi(s)E(s) + \int_{s}^{t} \psi'(r)E(r)dr + \int_{s}^{t} \psi(r)(f(r), u'(r))_{W}dr ,$$
$$0 \leq s \leq t .$$

In this paper we are interested in the dacay property of solutions of (E) rather than the existence of solutions of (E). Therefore, in what follows, we always assume the existence of a solution of (E) with the weak conservation property and treat only such a solution.

For the existence of solutions of (E) with the weak conservation property, we refer to Barbu [4], Brezis [5], Lions and Strauss [11], Strauss [17], Tsutsumi [18] and Yamada [19] (see also § 4).

Remark 2.3. Formally, setting $\phi = u'$ in (2.4) leads to the energy equation of the form

(2.7)
$$E(t) + \int_0^t (B(s)u'(s), u'(s))_w ds = E(0) + \int_0^t (f(s), u'(s))_w ds,$$
$$0 \le t < \infty.$$

If (2.7) holds, then (2.6) also holds for any positive C^{1} -function ψ on $[0, \infty)$. Therefore, any solution of (E) satisfying the energy equation (2.7) has the weak conservation property.

2.4. Results

Now we shall investigate the rate of the decay to zero of solutions of (E) when f(t) tends to zero as $t \to \infty$. To this end, we employ the weighted energy method. We assume that we can take a pair of two functions G(t) and h(t) which satisfy the following conditions.

(GH.1) $G \in C[0, \infty) \cap C^2(0, \infty)$ is strictly monotone increasing on $[0, \infty)$ and satisfies

$$G(0) \ge 0$$
 and $\lim_{t\to\infty} G(t) = \infty$.

(GH.2) $h \in C[0, \infty)$ is strictly monotone increasing on $[0, \infty)$ and satisfies

$$t > h(t) > 0 \qquad ext{for} \ \ t > t_{\scriptscriptstyle 0} \ \ ext{and} \ \ \lim_{t o \infty} h(t) = \infty$$
 ,

where t_0 is a non-negative constant.

(GH.3)
$$\sup_{t>t_0} \{ |\beta^{-1/q} \cdot G^{1/q'} \cdot f|_{L^{q'}(h(t),t;W^*)} \} \equiv L < \infty ,$$

where q' = q/(q-1) and β is the function in (A.2).

In addition to (GH.1)-(GH.3), we put different conditions on $\{G, h\}$ according as p + q > 4 or p = q = 2. (Recall that $p \geq 2$) and $q \geq 2$) are constants in (A.1) and (A.2), respectively.)

When p + q > 4, we set the following conditions on $\{G, h\}$.

(GH.4) There exists a positive constant M with the following properties (i), (ii) and (iii).

Here a, b_1, b_2, c_1 and c_2 are positive constants in §2.2.

When p = q = 2, we replace conditions (GH.4) and (GH.5) with the following conditions (GH.4)' and (GH.5)'.

When $\beta \equiv 1$ and $f \equiv 0$, examples of $\{G, h\}$ which satisfy the above conditions are given by functions of the form

$$(2.8) \quad \{G(t), h(t)\} = \{t^{\alpha}, ct\} , \quad \alpha \ge 0, 1 \ge c \ge 0 , \qquad \text{if } p + q \ge 4 ,$$

$$(2.9) \quad \{G(t), h(t)\} = \{e^{\alpha t}, t-c\} , \quad \alpha \ge 0, c \ge 0 , \quad \text{ if } p = q = 2 ,$$

where α and c in (2.8) (resp. (2.9)) must be determined so as to satisfy (GH.4) and (GH.5) (resp. (GH.4)' and (GH.5)'). see also §§ 3.3 and 3.4. Now we shall state our main theorems.

THEOREM 1. Let u be a solution of (E) with the weak conservation property. If $\{G, h\}$ satisfies (GH.1)-(GH.5) in case $p + q \ge 4$ or (GH.1)-(GH.3), (GH.4)' and (GH.5)' in case p = q = 2, then there exists a positive constant C such that

 $G(t)E(t) \leq C$, $t \geq 0$,

where E(t) is the energy defined by (2.5).

Remark 2.4. Let p < q. If it is known that E(t) decays to zero as $t \to \infty$, then the latter condition in (GH.4) (iii) can be replaced with the weaker one

$$|\beta \cdot (G')^{q-1} \cdot G^{-(q-1)}|_{L^{\infty}(h(t_0),\infty)} < \infty$$

(cf. Remark 3.2).

When $\beta(t) = (t+1)^{\theta} (-1 \leq \theta \leq q-1)$ and $|f(t)|_{W^*} \to 0$ fast enough, we have the following result on the rate of the decay of E(t).

THEOREM 2. Let u be a solution of (E) with the weak conservation property. If $\beta(t) = (t+1)^{\theta}$ with $-1 \leq \theta \leq q-1$ and $|f(t)|_{W^*} = 0(t^{-\gamma})$ with $\gamma > (q-1-\theta)/q$ as $t \to \infty$, then the following results hold.

(i) When $-1 \leq \theta \leq q-1$,

$$E(t) = 0(t^{-\alpha})$$
 (as $t \to \infty$), $\alpha = \min\left\{\delta, \frac{q\gamma - q + 1 + \theta}{q - 1}\right\}$,

where δ is a positive number defined by

$$\delta = \begin{cases} \frac{p(q-1-\theta)}{p-q} & \text{if } (p-2)(1+\theta) \ge p(q-2) \\ \frac{2(1+\theta)}{q-2} & \text{if } (p-2)(1+\theta) \le p(q-2) \end{cases}$$

(ii) When $\theta = q - 1$,

$$E(t) = \begin{cases} 0((\log t)^{-p(q-1)/(p-q)}) & (as \ t \to \infty) & if \ p > q \\ 0(t^{-\alpha}) & (as \ t \to \infty) & if \ p \leq q \end{cases},$$

where α is a positive number such that

In particular, when p = q = 2 and $|f(t)|_{W^*}$ decays to zero exponentially, we have

THEOREM 3. Let u be a solution of (E) with the weak conservation property. If p = q = 2, $\beta(t) = (t + 1)^{\theta}$ with $-1 < \theta < 1$ and $|f(t)|_{W^*} = 0$ (exp $(-\gamma t^{1-|\theta|})$) with $\gamma > 0$ as $t \to \infty$, then

$$E(t) = 0 \; (\exp \left(-\alpha t^{1-|\theta|}\right)) \qquad as \; t \to \infty$$
 ,

where α is a positive number satisfying

Remark 2.5. Recently, Nakao [14], [15] has studied the asymptotic behavior of solutions of (E) under the similar assumptions to ours. He proved that the energy E(t) satisfies a difference inequality of the form

$$\sup_{t \le s \le t+1} E(s)^{1+\alpha} \le C(t+1)^r \{ E(t) - E(t+1) \} + g(t) ,$$

where C > 0, $\alpha > 0$, $1 \ge \gamma \ge 0$ and g(t) is a non-negative function tending to zero as $t \to \infty$. From this inequality he derived the rate of the decay of E(t). However, Theorems 2 and 3 give preciser results than the corresponding ones in [14], [15].

§3. Proofs of Theorems

In this section we always assume that a pair of functions $\{G, h\}$ satisfies (GH.1)-(GH.5) (in case p + q > 4) or (GH.1)-(GH.3), (GH.4)' and (GH.5)' (in case p = q = 2). To prove our theorems we employ the weighted energy method. We take G(t) as a weight function of E(t) and take h(t) as an auxiliary function of G(t).

3.1. Some Lemmas

LEMMA 3.1.

$$\sup_{t>t_0} \left\{ \int_{h(t)}^t G'(s) \, | \, f(s) \, |_{V^*}^{p'} \, ds

where p' = p/(p - 1).

Proof. To prove this lemma, we have only to show that there exists a positive constant M'_1 satisfying

(3.1)
$$\int_{h(t)}^{t} G'(s) |f(s)|_{W^{*}}^{p'} ds \leq M'_{1}$$

for all $t > t_0$ (note (2.1)).

First we shall prove (3.1) in case p > q. We note that

$$\int_{h(t)}^t G'(s) \, |\, f(s) \,|_{W^*}^{p'} \, ds = \int_{h(t)}^t \left\{ eta(s)^{-p'/q} G(s)^{p'/q'} \, |\, f(s) \,|_{W^*}^{p'}

where q' = q/(q-1) (> p'). Using Hölder's inequality we have

$$\begin{split} \int_{h(t)}^{t} G'(s) |f(s)|_{W^{*}}^{p'} ds \\ & \leq \left\{ \int_{h(t)}^{t} \beta(s)^{-\epsilon'/q} G(s) |f(s)|_{W^{*}}^{q'} ds \right\}^{p'/q'} \\ & \times \left\{ \int_{h(t)}^{t} \beta(s)^{p/(p-q)} G'(s)^{q(p-1)/(p-q)} G(s)^{-p(q-1)/(p-q)} ds \right\}^{1-p'/q'}, \end{split}$$

which, together with (GH.3) and (GH.4) (iii), implies (3.1).

In case $p \leq q$, we have

$$\begin{split} \int_{h(t)}^{t} G'(s) \, | \, f(s) |_{W^*}^{p'} \, ds &= \int_{h(t)}^{t} \left\{ \beta(s)^{-\iota'' q} G(s) \, | \, f(s) |_{W^*}^{q'} \right\} \\ & \times \left\{ \beta(s)^{q'/q} G'(s) G(s)^{-1} \right\} | \, f(s) |_{W^*}^{p'-q'} \, ds \\ & \leq | \, \beta^{1/(q-1)} \cdot G' \cdot G^{-1} \, |_{L^{\infty}(h(t_0),\infty)} \cdot | \, f| |_{L^{\infty}(0,\infty;W^*)}^{p'-q'} \, ds \\ & \times \int_{h(t)}^{t} \beta(s)^{-\iota'/q} G(s) \, | \, f(s) |_{W^*}^{q'} \, ds \; . \end{split}$$

Hence, recalling (A.3), (GH.3), (GH.4) and (GH.4)', we see that (3.1) holds. [Q.E.D.]

LEMMA 3.2.

where q' = q/(q - 1).

Proof. To prove this lemma, we define functions $h_i(t)$ (i = 0, 1, 2, ...) as follows:

(3.2)
$$h_0(t) = t$$
 and $h_i(t) = h(h_{i-1}(t))$ for t such that $h_{i-1}(t) > t_0$,
 $= h(t_0)$ for t such that $h_{i-1}(t) \le t_0$.

Now let T and T' be arbitrary numbers such that $T' > T > t_0$ and fix them. Then, by (GH.2), there exists a positive integer n such that

$$h_{n-1}(T') > T$$
 and $h_n(T') \leq T$.

Since the function $t \in [T', \infty) \mapsto h_n(t)$ is continuous and strictly monotone increasing, we can take a number $T'' (\geq T')$ such that $h_n(T'') = T$ (note that $\lim_{t\to\infty} h_n(t) = \infty$). Using (GH.1)-(GH.3), we have with the aid of such functions $\{h_i\}$

On the other hand, (GH.5) (or (GH.5)') implies

Now we shall estimate each $I_i(t)$ $(i = 1, \dots, 5)$ in terms of $|G'E|_{L^1(h(t),t)}$, $|G(B(\cdot)u', u')_W|_{L^1(h(t),t)}$, G(t)E(t) and G(h(t))E(h(t)). By virtue of (2.1), (2.2) and (A.1) we have

In this case, Theorem 1 also holds true (see the proof of Theorem 1).

Remark 3.3. Even if the operator $A: V \to V^*$ depends on t, we can employ the method used here to investigate the rate of the dacay of solutions of (E). However, conditions on $\{G, h\}$ will become more complicate in this case (cf. Nakao [15]).

3.3. Proof of Theorem 2

Let $\beta(t) = (t+1)^{\theta}$ with $-1 \leq \theta \leq q-1$ and let $|f(t)|_{W^*} = 0(t^{-\gamma})$ with $\gamma > (q-1-\theta)/q$ as $t \to \infty$. We shall apply Theorem 1 to prove this theorem; we choose a suitable pair $\{G, h\}$ so that it satisfies (GH.1)-(GH.5) (in case p + q > 4) or (GH.1)-(GH.3), (GH.4)' and (GH.5)' (in case p = q = 2).

(i) The case $-1 \le \theta \le q-1$. We put

Moreover, (GH.5) is satisfied for every $\alpha > 0$ if t_0 is sufficiently large.

In case p = q = 2, (GH.4)' and (GH.5)' are easily verified for every $\alpha > 0$ if t_0 is large enough.

Finally, it follows from (GH.3) that

Let $p \leq q$ and take a pair of functions $\{G, h\}$ of the form (3.22) with c fixed. Then noting (3.23) and (3.24) we can determine $\alpha > 0$; all conditions on $\{G, h\}$ are satisfied when

and determine α and c so that $\{G, h\}$ satisfies (GH.3), (GH.4)' and (GH.5)'; (GH.1) and (GH.2) are satisfied if $t_0^{1-|\theta|} \ge c$. First we fix c > 0. Then (GH.3) is satisfied for every $\alpha > 0$ such that

(3.29)
$$\begin{cases} \alpha \leq 2\gamma & \text{if } 0 \leq \theta < 1 \\ \alpha < 2\gamma & \text{if } -1 < \theta < 0 \end{cases}$$

Moreover, by taking t_0 large enough if $\theta \neq 0$, we can verify (GH.4)' for every $\alpha > 0$ such that

$$(3.30) \quad \begin{cases} \alpha < \frac{ab_1}{b_2^2 c_1^2 (1-\theta)} & \text{if } 0 < \theta < 1 \\ 3 \Big(\frac{c_1 c_2}{\sqrt{2a}} + \frac{c_2^2}{2b_1} \Big) \alpha + \Big(\frac{b_2 c_1}{\sqrt{ab_1}} \Big) \sqrt{\alpha} < 1 & \text{if } \theta = 0 \\ \alpha < \frac{2b_1}{2c_2^2 (1+\theta)} & \text{if } -1 < \theta < 0 \end{cases}.$$

Now we fix α so that it satisfies (3.29) and (3.30). Then it can be shown that the pair $\{G, h\}$ defined by (3.28) satisfies (GH.5)' if t_0 (resp. c) is large enough in case $\theta \neq 0$ (resp. $\theta = 0$). Therefore, using Theorem 1 we obtain the conclusions of Theorem 3 from (3.29) and (3.30).

[Q.E.D.]

§4. Applications

In this section we shall apply the preceding results to some nonlinear partial differential equations.

Let Ω be a bounded domain in \mathbb{R}_x^n with smooth boundary Γ . By $W^{k,p}(\Omega)$ we mean $\{u; D^*u \in L^p(\Omega) \text{ for } |\alpha| \leq k\}$, and by $W_0^{k,p}(\Omega)$ we mean the closure in $W^{k,p}(\Omega)$ of the smooth functions with compact supports in Ω . In particular, for p = 2 we write $H^k(\Omega) = W^{k,2}(\Omega)$ and $H_0^k(\Omega) = W_0^{k,2}(\Omega)$.

4.1. Example 1

First we study the decay property of solutions to the nonlinear

wave equation

(4.1)
$$\begin{cases} \frac{\partial^2 u}{\partial t^2} - \Delta u + (t+1)^{\theta} \left| \frac{\partial u}{\partial t} \right|^{q-2} \frac{\partial u}{\partial t} = f & \text{on } \Omega \times [0,\infty)^{\gamma}, \\ u = 0 & \text{on } \Gamma \times [0,\infty), \end{cases}$$

where $q \geq 2$ and θ is a real number.

We take $H = L^2(\Omega)$, $V = H^1_0(\Omega)$ and $W = L^q(\Omega)$. If we put

$$Au = -\Delta u$$
 and $B(t)v = (t+1)^{\theta} |v|^{q-2} v$,

then we easily see that $A: V \to V^*$ is the Fréchet derivative of a convex functional F_A on V defined by

$$F_A(u) = rac{1}{2} \int_{\mathcal{G}} |\operatorname{grad} u|^2 dx \qquad \left(\equiv rac{1}{2} |u|_V^2
ight)$$

and that B(t) satisfies (A.2) with $b_1 = b_2 = 1$ and $\beta(t) = (t + 1)^{\theta}$.

As for the existence of solutions of (4.1) with the initial conditions

(4.2)
$$u(\cdot, 0) = u_0$$
 and $\frac{\partial u}{\partial t}(\cdot, 0) = u_1$ on Ω ,

it is well known that, for each $f \in L^2_{loc}(0, \infty; H)$, $u_0 \in V$ and $u_1 \in H$, there exists a unique solution u of (4.1) and (4.2) satisfying

$$u \in L^{\infty}_{\text{loc}}(0, \infty; V) \text{ and } u' \in L^{\infty}_{\text{loc}}(0, \infty; H) \cap L^{q}_{\text{loc}}(0, \infty; W)$$

(see e.g. Lions [10] or Lions and Strauss [11]). Furthermore, according to the result of Strauss [17, Theorem 4.1], the solution u always satisfies the energy equation

$$E(t) + \int_0^t (s+1)^{\theta} |u'(s)|_W^q ds = E(0) + \int_0^t (f(s), u'(s))_W ds$$
,

where the energy E(t) is defined by

$$E(t) = rac{1}{2} |u'(t)|_{H}^{2} + rac{1}{2} |u(t)|_{V}^{2}$$
 .

Therefore, we can investigate the rate of the decay of solutions of (4.1) (see Remark 2.3).

Now suppose that $q \ge 2$ if n = 1, 2 and $2n/(n-2) \ge q \ge 2$ if $n \ge 3$. Then, by Sobolev's lemma, there exists a positive number s_q such that

$$|u|_W \leq s_q |u|_V$$
 for $u \in V$;

so that

 $V \subset W \subset H$.

Hence, applying Theorems 2 and 3 to (4.1), we can obtain the following results (cf. Nakao [15] and Sattinger [16]).

THEOREM 4.1. Let u be a solution of (4.1) and let $q \ge 2$ if n = 1, 2and $2n/(n-2) \ge q \ge 2$ if $n \ge 3$. If $-1 \le \theta \le q - 1$ and $|f(t)|_{W^*} = O(t^{-\gamma})$ with $\gamma > (q - 1 - \theta)/q$ as $t \to \infty$, then the following decay properties (i) and (ii) hold.

(i) When
$$-1 \le \theta \le q - 1$$
,

$$E(t) = O(t^{-\alpha})$$
 as $t \to \infty$,

where α is a positive number such that

$$egin{array}{ll} & \left\{lpha\leq 2\gamma \quad and \quad lpha<rac{1}{2s_2^2} & if \ q=2 \ and \ heta=1 \ & lpha=\min\left\{rac{2(1+ heta)}{q-2},rac{q\gamma-q+1+ heta}{q-1}
ight\} & otherwise \ . \end{array}$$

(ii) When $\theta = -1$,

$$E(t) = egin{cases} O((\log t)^{-2/(q-2)}) & as \ t o \infty \ if \ q > 2 \ O(t^{-lpha}) & as \ t o \infty \ if \ q = 2 \ , \end{cases}$$

where α is a positive number satisfying $\alpha < 2\gamma - 2$ and $\alpha < 2/3$.

In particular, if p = q = 2, $-1 \le \theta \le 1$ and $|f(t)|_{W^*} = O(\exp(-\gamma t^{1-|\theta|}))$ with $\gamma > 0$ as $t \to \infty$, then for some sufficiently small $\alpha > 0$

$$E(t) = O(\exp(-\alpha t^{1-|\theta|})) \quad as \ t \to \infty$$
.

Remark 4.1. When $\theta = 0$ and f(x, t) tends to a function F(x) as $t \to \infty$, Nakao [12] has investigated the rate of the convergence of u(x, t) to the corresponding steady state solution $\overline{u}(x)$ (see also [13]). Our method can also apply to the study of the stability of solutions of (4.1).

Remark 4.2. Levine and Murray [9] has discussed the asymptotic behavior for solutions to semilinear wave equations and obtained their lower bounds. In particular, when q = 2, $\theta = -1$ and $f \equiv 0$ in (4.1) (Euler-Poisson-Darboux equation), they showed that solutions of (4.1) satisfy, for all t sufficiently large and some C > 0 and $\rho > 0$,

 $E(t) \geqq C t^{- \rho}$,

unless $u \equiv 0$ (cf. Theorem 4.1 (ii)).

4.2. Example 2

We consider the nonlinear equation of the form

(4.3)
$$\begin{cases} \frac{\partial^2 u}{\partial t^2} - \sum_{i=1}^n \frac{\partial}{\partial x_i} \left(\left| \frac{\partial u}{\partial x_i} \right|^{p-2} \frac{\partial u}{\partial x_i} \right) - (t+1)^{\theta} d \frac{\partial u}{\partial t} = f \quad \text{on } \Omega \times [0,\infty) ,\\ u = 0 \quad \text{on } \Gamma \times [0,\infty) ,\end{cases}$$

where $p \geq 2$ and $\theta \leq 0$.

Take $H = L^2(\Omega)$, $V = W_0^{1,p}(\Omega)$ and $W = H_0^1(\Omega)$. If we put

$$Au = -\sum_{i=1}^{n} rac{\partial}{\partial x_i} \Big(\Big| rac{\partial u}{\partial x_i} \Big|^{p-2} rac{\partial u}{\partial x_i} \Big)$$

and

$$B(t)v = -(t+1)^{\theta} \Delta v ,$$

we easily see that $A:V\to V^*$ is the Fréchet derivative of a convex functional F_A defined by

$$F_A(u) = rac{1}{p} \int_{\mathcal{Q}} \sum_{i=1}^n \left| rac{\partial u}{\partial x_i} \right|^p dx \qquad \left(\equiv rac{1}{p} |u|_V^p \right)$$

and $B(t): W \to W^*$ satisfies (A.2) with $b_1 = b_2 = 1$, q = 2 and $\beta(t) = (t + 1)^{\theta}$.

When $\theta = 0$, Tsutsumi [18] treated the initial boundary value problem for (4.3) with initial conditions

(4.4)
$$u(\cdot, 0) = u_0$$
 and $\frac{\partial u}{\partial t}(\cdot, 0) = u_1$ on Ω ,

and showed that, for each $f \in L^2_{loc}(0, \infty; H)$, $u_0 \in V$ and $u_1 \in H$, there exists a solution u of (4.3) and (4.4) satisfying

(4.5)
$$u \in L^{\infty}_{\text{loc}}(0, \infty; V)$$
 and $u' \in L^{\infty}_{\text{loc}}(0, \infty; H) \cap L^{2}_{\text{loc}}(0, \infty; W)$,

(for the special case n = 1 and $\theta = 0$, see e.g. Caughey and Ellison [6], Greenberg [7] and Greenberg, MacCamy and Mizel [8]). He employed the Galerkin's method to construct such a solution u of (4.3) and (4.4).

When $\theta \leq 0$, we can apply Tsutsumi's technics to the initial boundary

value problem (4.3) and (4.4); so that, for each $f \in L^2_{loc}(0, \infty; H)$, $u_0 \in V$ and $u_1 \in H$, there exists a solution u of (4.3) and (4.4) satisfying (4.5). Moreover, such u has the weak conservation property: for every $0 \leq s$ $\leq t$ and every positive C^1 -function ψ ,

(4.6)
$$\psi(t)E(t) + \int_{s} \psi(r)(r+1)^{\theta} |u'(r)|_{W}^{2} dr$$
$$\leq \psi(s)E(s) + \int_{s}^{t} \psi'(r)E(r)dr + \int_{s}^{t} \psi(r)(f(r), u'(r))_{W} dr ,$$

Ct

where $E(t) = \frac{1}{2} |u'(t)|_{H}^{2} + F_{A}(u(t))$. We shall prove these facts briefly.

Let $\{u_m\}$ be a sequence of approximate solutions to (4.3) and (4.4) defined by the Galerkin's method (for details, see Tsutsumi [18]). Then, almost in the same procedure as in [18], we can choose a convergent subsequence $\{u_\mu\}$ of $\{u_m\}$ such that:

- (4.7) $u_{\mu} \rightarrow u$ weakly star in $L^{\infty}(0, T; V)$ and weakly in $L^{p}(0, T; V)$ for every T > 0;
- (4.8) $u'_{\mu} \to u'$ weakly star in $L^{\infty}(0, T; H)$, weakly in $L^{2}(0, T; W)$ and strongly in $L^{2}(0, T; H)$ for every T > 0;

where u is a solution of (4.3) and (4.4). On the other hand, by the monotonicity of A, we have

$$\begin{split} \lim_{\mu \to \infty} \int_0^T (A u_\mu(s), u_\mu(s))_V ds &= \lim_{\mu \to \infty} \int_0^T |u_\mu(s)|_V^p \, ds \\ &= \int_0^T (A u(s), u(s))_V ds = \int_0^T |u(s)|_V^p \, ds \quad \text{for every } T \ge 0 \; , \end{split}$$

(cf. [18, (2.27) and (2.28)]), which, together with (4.7), implies

(4.9)
$$u_{\mu} \rightarrow u$$
 strongly in $L^{p}(0, T; V)$ for every $T > 0$,

because $L^{p}(0, T; V)$ is a uniformly convex Banach space. Now we recall that the approximate function u_{μ} satisfies, for every $0 \leq s \leq t$ and every positive C^{1} -function ψ ,

$$egin{aligned} \psi(t)E_{\mu}(t)\,+\,\int_{s}^{t}\psi(r)(r\,+\,1)^{ heta}\,|u_{\mu}'(r)|_{W}^{2}\,dr\ &=\psi(s)E_{\mu}(s)\,+\,\int_{s}^{t}\psi'(r)E_{\mu}(r)dr\,+\,\int_{s}^{t}\psi(r)(f(r),\,u_{\mu}'(r))_{W}dr\;, \end{aligned}$$

where $E_{\mu}(t) = \frac{1}{2} |\mu'_{\mu}(t)|_{H}^{2} + F_{A}(u_{\mu}(t))$. Hence it follows from (4.8) and (4.9) that (4.6) holds for almost every s and t ($0 \le s \le t$). Therefore, we may conclude that u, after redefinition on a set of measure zero, satisfies (4.6) for every $0 \le s \le t$. (Note that the function

$$t\mapsto E(t)-c\int_0^t |f(s)|^2_{W^*}\,ds$$

is monotone non-increasing for some c > 0.)

Thus we have shown the existence of a solution u of (4.3) which satisfies (4.6). Hence, applying Theorems 2 and 3 to the study of the asymptotic behavior of such u, we have

THEOREM 4.2. Let $-1 \leq \theta \leq 0$ and let u be a solution of (4.3) satisfying (4.6). If $|f(t)|_{W^*} = O(t^{-\gamma})$ with $\gamma > (1-\theta)/2$ as $t \to \infty$, then

$$E(t) = O(t^{-\alpha})$$
 as $t \to \infty$,

where α is a positive number satisfying

$$egin{aligned} &&\left\{rac{p(1- heta)}{p-2},2\gamma-1+ heta
ight\} && ext{if } -1 < heta \leq 0 \ , \ &&\left\{lpha \leq \min\left\{rac{2p}{p-2},2\gamma-2
ight\} \; \; and \; \; lpha < rac{2}{3s_2^2} & ext{if } heta = -1 \; . \end{aligned}$$

In particular, if $p = 2, -1 \le \theta \le 0$ and $|f(t)|_{W^*} = O(\exp(-\gamma t^{1+\theta}))$ with $\gamma > 0$ as $t \to \infty$, then for some sufficiently small $\alpha > 0$,

$$E(t) = O(\exp(-\alpha t^{1+\theta}))$$
 as $t \to \infty$.

4.3. Example 3

In this subsection we denote by Ω an open interval (0, 1). We discuss the rate of the decay of solutions to the nonlinear beam equation

(4.10)
$$\begin{cases} \frac{\partial^2 u}{\partial t^2} + \frac{\partial^4 u}{\partial x^4} - \left(a + \int_{a} \left|\frac{\partial u}{\partial y}(y,t)\right|^2 dy\right) \frac{\partial^2 u}{\partial x^2} + (t+1)^{\theta} \frac{\partial u}{\partial t} = f \\ & \text{on } \mathcal{Q} \times [0,\infty) , \\ u = \frac{\partial^2 u}{\partial x^2} = 0 & \text{on } \Gamma \times [0,\infty) , \end{cases}$$

where a and θ are real numbers; the boundary conditions in (4.10) correspond to the case when the ends of the beam are hinged.

We take $H = W = L^2(\Omega)$ and $V = H^2(\Omega) \cap H^1_0(\Omega)$. Put

$$(Au, v)_{v} = \int_{a} \frac{\partial^{2} u}{\partial x^{2}} \cdot \frac{\partial^{2} v}{\partial x^{2}} dx + \left(a + \int_{a} \left|\frac{\partial u}{\partial x}\right|^{2} dx\right) \int_{a} \frac{\partial u}{\partial x} \cdot \frac{\partial v}{\partial x} dx \quad \text{for } u, v \in V ,$$

and

$$B(t)v = (t+1)^{\theta}v.$$

Then A is the Fréchet derivative of a convex functional F_A on V defined by

$$egin{aligned} F_{A}(u) &= rac{1}{2} \int_{arsigma} \left| rac{\partial^{2} u}{\partial x^{2}}
ight|^{2} dx + rac{a}{2} \int_{arsigma} \left| rac{\partial u}{\partial x}
ight|^{2} dx + rac{1}{4} \Big(\int_{arsigma} \left| rac{\partial u}{\partial x}
ight|^{2} dx \Big)^{2} \ & \left(\equiv rac{1}{2} \left| u_{xx}
ight|_{H}^{2} + rac{a}{2} \left| u_{x}
ight|_{H}^{2} + rac{1}{4} \left| u_{x}
ight|_{H}^{4}
ight). \end{aligned}$$

When $\theta = 0$ and $f \equiv 0$, Ball [1], [2] treated the initial value problem for (4.10) and showed the existence and uniqueness of solutions of (4.10). His technics can also apply to the case when $\theta \neq 0$ and $f \equiv 0$; so that, for each $f \in L^2_{loc}(0, \infty; H)$, $u_0 \in V$ and $u_1 \in H$, there exists a unique solution u of (4.10) satisfying

$$u(0) = u_0$$
 and $u'(0) = u_1$.

Moreover, such u always satisfies the energy equation

$$(4.11) \quad E(t) + \int_0^t (s+1)^{\theta} |u'(s)|_H^2 ds = E(0) + \int_0^t (f(s), u'(s))_W ds , \qquad t \ge 0$$

where $E(t) = \frac{1}{2} |u'(t)|_{H}^{2} + F_{A}(u(t)).$

Now we note

$$(4.12) |u_{xx}|_H \ge \pi |u_x|_H for \ u \in V.$$

Thus

$$F_A(u) \ge \frac{1}{2}(a + \pi^2)|u_x|_H^2 + \frac{1}{4}|u_x|_H^4 \quad \text{for } u \in V.$$

Therefore, for $a \ge -\pi^2$, A satisfies (A.1)' (see Remark 2.2) with $V_1 = H_0^1(\Omega)$ and

$$egin{cases} p = 2 & ext{if} \; a > -\pi^2 \ p = 4 & ext{if} \; a = -\pi^2 \,. \end{cases}$$

Then, recalling Remark 3.1 we obtain the following results (cf. Ball and Carr [3]).

THEOREM 4.3. Let $a \ge -\pi^2$, $-1 \le \theta \le 1$ and let u be a solution of (4.10)

(i) The case $a \ge -\pi^2$. If $|f(t)|_H = O(t^{-\gamma})$ with $\gamma \ge (1-\theta)/2$ as $t \to \infty$, then

$$E(t) = O(t^{-\alpha})$$
 as $t \to \infty$,

where α is a positive number such that

$$egin{array}{ll} lpha &\leq 2\gamma \quad and \quad lpha < rac{a \,+\, \pi^2}{2\pi^2} & \ if \ heta = 1 \ lpha &= 2\gamma - 1 \,+\, heta & \ if \ -1 < heta < 1 \ lpha &\leq 2\gamma - 2 \quad and \quad lpha < rac{2}{3} & \ if \ heta = -1 \;. \end{array}$$

In particular, if $-1 \le \theta \le 1$ and $|f(t)|_H = O(\exp(-\gamma t^{1-|\theta|}))$ with $\gamma \ge 0$ as $t \to \infty$, then for some sufficiently small $\alpha \ge 0$

$$E(t) = O(\exp(-\alpha t^{1-|\theta|}))$$
 as $t \to \infty$.

(ii) The case $a = -\pi^2$. If $|f(t)|_H = O(t^{-\gamma})$ with $\gamma > (1 - \theta)/2$ as $t \to \infty$, then

$$E(t) = egin{cases} O((\log t)^{-2}) & as \ t o \infty & if \ heta = 1 \ O(t^{-lpha}) & as \ t o \infty & if \ -1 \leq heta < 1 \ , \end{cases}$$

where α is a positive number such that

$$egin{array}{lll} \{lpha=\min\left\{2(1- heta),2\gamma-1+ heta
ight\}& if\ -1< heta<1\ lpha\leq\min\left\{4,2\gamma-2
ight\}& and\ lpha<2/3& if\ heta=-1\ . \end{array}$$

Remark 4.3. Even if we replace the boundary conditions in (4.10) with the conditions corresponding to the case of clamped ends

$$u=rac{\partial u}{\partial x}=0$$
 on $\Gamma imes [0,\infty)$,

we can also investigate the decay property of solutions for such problems (which we denote by (4.10)').

Take $H = W = L^2(\Omega)$ and $V = H_0^2(\Omega)$. As for the existence of solutions of (4.10)' satisfying the energy equation (4.11), the same results as in the case of hinged ends hold true. (See [1] and [2].) However, we note that, instead of (4.12),

$$|u_{xx}|_H \ge 2\pi |u_x|_H$$

holds for every $u \in V$. Hence, for $a \ge -4\pi^2$, we can prove the similar results to those of Theorem 4.3.
