



With this book, Roger L. Geiger completes a two-volume study of American research universities in the twentieth century. This book describes how the federal government first relied on university scientists during World War II, and how the resulting relationship set the pattern for the postwar mushrooming of academic research. Although the vicissitudes of federal-university relations are one crucial element of this history, the focus is on the universities themselves, their internal aspirations to conduct research, and their adaptations to external constraints and opportunities.


