Cultural change is not just a straightfoward response to external pressures: the culture itself, as a powerful and autonomous system of ideas, plays a large part in shaping people's internal adaptation to new circumstances. Recent far-reaching changes—educational expansion, increasing wage dependency, population growth and urban unemployment—have all had their impact on the populations of Africa, but underlying cultural differences have persisted throughout. It would be misleading, therefore, to think of ethnicity as a mere 'false consciousness', without any bearing on the destiny of a people. The Luo of Kenya, who are the main subject of this investigation into the nature of cultural change and its semantic aspects, are no exception to the rule.

English Accents and Dialects

An Introduction to Social and Regional Varieties of British English Arthur Hughes and Peter Trudgill

This book is a concise introductory survey of the main regional and social varieties of spoken British English, and the factors influencing them. The authors discuss accent and dialect in the broader framework of language variation - phonetic, phonological, grammatical, lexical, historical and stylistic - and variation within Received Pronunciation and Standard English. A section is devoted to each of ten main varieties of spoken English, each section including a discussion of differences from RP and Standard English, neighbouring varieties, features of continuous speech, explanatory notes, transcriptions, and a transcription exercise. The book is complemented by a recording. This consists of an RP

speaker reading a list of key words, and of sections with speakers from each of the different areas first reading the word list and then in edited interviews.

The study of accent and dialect is of interest not only to the advanced learner of English as a second or foreign language, who will often encounter varieties of English differing considerably from the one he has learned, but also to those studying and teaching sociolinguistics and language varieties.

Typescripts. The top copy of the typescript should be submitted and, if possible a second copy also. Contributions should be clearly typed on one side of the paper only using a conventional size of paper, preferably A4 (or 21.6 by 28 centimeters for those at work where A4 is not available). Authors should hold one copy for the correction of proofs. The title-page should include the title, author's name and affiliation, in that order, along with an abstract of the article. Areas of study to which the articles may be of interest should be listed at the end of the abstract.

Titles should be so worded that the first part may be used as a running headline (with a maximum length of 50 characters, including spaces). They should be typed on a separate sheet, together with the author's name and address to which he wishes proofs to be sent.

Citations and forms of emphasis.

Normally the Latin alphabet is to be used. Cited forms should be underlined to represent italicization in print. Translational 'meanings' should be placed within single quotation marks.

References are to be made in the text (and not in footnotes) by giving in parentheses the name of the author and year of publication, and where relevant the page(s) referred to; e.g. (Whitney 1867: 45-53). If the author's name is part of the text, the following form should be used: 'Whitney (1867: 48) maintained that . . . '. When a work written by two or more authors is referred to, all names should be given in the first citation; e.g. (Weinreich, Labov & Herzog 1068): in subsequent citations the first name only should be given, with 'et al.' added; e.g. (Weinreich et al. 1968). When separate works are referred to in the same parentheses, those by the same author should be separated by commas and those by different authors by semi-colons: e.g. (Whitney 1867; Firth 1935, 1957a). Initials should be used (after the author's name) only when it is necessary to distinguish between two or more authors of the same name, all of whom are referred to in the same article.

All works referred to should be listed at the end of the article, double-spaced and in alphabetical order. The titles of articles should so far as possible be abbreviated according to the conventions of the Linguistic Bibliography of the Permanent International Committee of Linguistics (CIPL).

Book reviews. With the exception of the title-page, book reviews should be submitted in the same form as articles. The title-page should take the following form: Edwin Ardener (ed.), *Linguistic and Social Anthropology*. (ASA Monographs, 10.) London: Tavistock, 1971.

There is no need to submit an abstract with a book review.

Proofs. First proofs only will be sent to the author (or his nominee), who will be expected to correct them and return them to the Editor, by airmail where appropriate, within ten days of receipt.

Offprints. Fifty offprints of both articles and review articles will be provided free of charge. Additional offprints may be obtained at reasonable cost, provided that these are ordered before publication on the special form sent out with the proofs.

Submission of an article is taken to imply that it has not previously been published, or is not being considered for publication elsewhere. If an author is publishing a related article elsewhere, this fact should be stated.

Copyright. Contributors of accepted articles will be asked to assign their copyrights, on certain conditions, to Cambridge University Press, to help protect their material, particularly in the U.S.A.
