#### Experiential Learning

With the support of the ASU Lincoln Center for Applied Ethics, the Center offers an experiential learning project that supports four students working with two faculty members to prepare a series of policy papers for the U.N. Climate Change Secretariat and to attend an international negotiation. The Student Research Fellows Program links students with human rights and rule of law projects, such as supporting the U.N. Subcommittee on the Prevention of Torture in its multiple site visits.

#### Third Annual ASU Human Rights Film Festival

The Center and other ASU partners host a three-day festival of documentary and feature films dealing with key human rights issues.

Today's world is post-colonial and post-Cold War. These twin characteristics explain why international society is also riddled by the two major forms of injustice which Nancy Fraser identified as afflicting national societies. First, the economic and social disparities between states caused outcry in the 1950s when the first steps were taken towards decolonisation. Second, international society is increasingly confronted with culture- and identity-related claims, stretching the dividing line between equality and difference. In answer to these two forms of claim, the subjects of international society have come up with two types of remedy encapsulated in legal rules: the law of development and the law of recognition, the first milestones towards what might become a fairer international society.

The ASIL Holtzmann Center is established in honor of Judge Howard M. Holtzmann. Over the course of his career, Judge Holtzmann has made enormous contributions to the field of international arbitration and conciliation, and mentored scores of young lawyers working in the field. He was central to the American Arbitration Association (AAA) work with the Arbitration Institute of the Stockholm Chamber of Commerce to build an East-West bridge through international arbitration. Notable achievements include: service as a member of the U.S. delegation to the Arbitration Working Group of the UN Commission on International Trade Law (1974-2011), which produced the UNCITRAL Arbitration Rules, the UNCITRAL Conciliation Rules, and the UNCITRAL Model Law on International Commercial Arbitration, and service as a Member of the Iran-U.S. Claims Tribunal (1981-1994). For his pioneering work, the King of Sweden inducted Judge Holtzmann as a Commander of the Royal Order of the Polar Star in 2003. In 2005, he received the Silver Medal of Honor of Vienna, and in 2006, the AAA gave him its highest honor, the Peacemaker Award, for his "work to further peace throughout the world." Judge Holtzmann has been a member of ASIL since 1972.

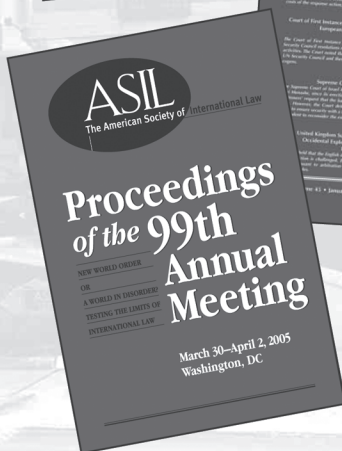

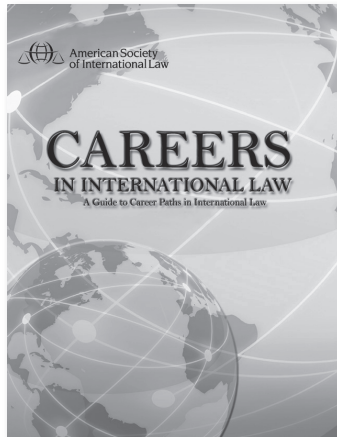
