

Contributors

Dimitry Anastakis is assistant professor in the Department of History at Trent University, in Peterborough, Ontario, Canada. In 2003, he was a Fulbright visiting scholar at Michigan State University. The author of *Auto Pact: Creating a Borderless North American Auto Industry*, 1960–1971 (University of Toronto Press, forthcoming), he has also published articles on various aspects of the auto industry in the *Michigan Historical Review*, *Labour/Le Travail*, and the *Canadian Business Law Journal*. He is currently examining the development of the North American auto industry from 1971 to the implementation of the Canada–U.S. Free Trade Agreement in 1989, particularly the Chrysler bailout, the schism within the United Auto Workers, and the emergence of the Japanese transplants.

F. Kees Boersma is lecturer in the Culture, Organization, and Management Department at the Vrije Universiteit in Amsterdam, where he teaches courses on organizational behavior, technology, and culture. His Ph.D. thesis, which he wrote for the Eindhoven University of Technology, was given a dissertation award by the European Business History Association and was published in 2002 under the title *Inventing Structures for Industrial Research: A History of the Philips Nat.Lab.* In 2000 he was a visiting scholar at The Johns Hopkins University.

Marcelo Bucheli is the 2004–5 Harvard-Newcomen Fellow in Business History and professor of economic history at Universidad de los Andes in Colombia. His book, Bananas and Business: The United Fruit Company in Colombia, 1899–2000, will be published by New York University Press in February 2005. He has also written "United Fruit Company in Latin America," published in Banana Wars: Power, Production, and History in the Americas, edited by Steve Striffler and Mark Moberg (2003), and "The United Fruit Company in Colombia: Impact of Labor Relations and Governmental Regulations on its Operations, 1948–1968," which appeared in Essays in Economic and Business History (1997).
