#### The Cameroon Federation

Political Integration in a Fragmentary Society WILLARD R. JOHNSON

The formative years of Africa's only surviving bilingual federation are assessed in this book. The author shows how the 1961 federation of the British and French Cameroons attempted to integrate a highly fragmented society representing every social cleavage found in Africa, including disparate and bilingual colonial legacies. After examining accepted theory on the integration of political systems and the maintenance of the resulting unions, Professor Johnson then applies this theory to the actual experience within the Cameroon Federation.
