The instruments of power are many and diverse. Important men everywhere reinforce their positions, carry out their decisions, and maintain social values by the use of art forms imbued with power. The tremendously rich heritage of Africa's art has received world-wide attention, and the varieties and intricacies of her socio-political systems have been long recognized. Until now, however, their fascinating relationship has only been acknowledged, never explored in depth.

The complex interactions between art and leadership are discussed here on two levels. A series of fourteen thought-provoking essays by art historians, anthropologists, and historians analyze the specifics of the relationships among cultures in the broad area watered by the Niger and Congo rivers and their tributaries. The essays embrace a considerable range of art formswith a special emphasis on sculpture - produced in societies with varying kinds of leadership. An epilogue approaches the subject from a more general and inclusive point of view.

The contributors include many of the most able scholars in this new field of research: Daniel Biebuyck, Rene Bravmann, Daniel J. Crowley, Hans Himmelheber, A. A. Y. Kyerematen, Simon Ottenberg, Suzanne Rudy, Roy Sieber, Leon Siroto, Robert F. Thompson, Jan Vansina, Frank Willett, and the co-editors.

The *History of West Africa*, edited by two of the most internationally eminent African historians and written by scholars chosen for their specialist knowledge, provides a lucid, scholarly and authoritative synthesis of West African history: to serve as a basic university textbook, a work of reference for teachers and a general background for all those interested in the subject.

In this, the first of two volumes, the major emphasis has been on the theme of state formation in West Africa. The approach has been regional, apart from three introductory chapters, and much of the material is the result of primary research, providing new insights into the interaction between land tenure, agriculture and other economic activities on the one hand, and state formation on the other.

### CONTRIBUTIONS

Contributions to the *Journal* are welcomed. They may be submitted in either English or French and, except with the prior approval of the Editors, should not exceed about 6000 words. Two copies should be submitted, clearly typed with double spacing on quarto paper, and with a left-hand margin of at least  $1\frac{1}{2}$  in. (4 cm.). A summary of the contents of the article, not exceeding about 300 words in length, should be attached on a separate sheet. Footnotes, which should also be typed with double spacing, should be numbered consecutively throughout the article, and should include all bibliographical references; there should be no separate bibliography. First references should be complete, in standard form, so as to permit unequivocal identification of the book or article in question. Subsequent references should be by author's name and short title. Articles may be illustrated with line drawings and maps and, should the Editors agree that it is necessary, also with half-tone plates.

Galley proofs will be sent, if necessary by airmail, to each contributor (or his nominee) provided that the Editors have been given an address through which he can be reached without delay. Corrections should be kept to the minimum, and should be corrections, not new material. If they are to be incorporated in the master proof corrected by the Editors, it is important that the contributor should return the galleys, by airmail if necessary, to the Editor named when they are sent out (and *not* to the Cambridge University Press), within ten days of his receipt of them.

Contributors of articles and review articles receive 25 free separates. Additional separates may be obtained at reasonable cost, provided that they are ordered before publication on the special form sent out with the galley proofs.
