The 'early modern' period of world history (ca. 1300-1800) was marked by a large increase in the level of global interaction. Between the aftermath of Mongol conquest in the East and the onset of industrialization in the West, European expansion set the framework for new kinds of contacts and collective self-definition. The Journal of Early Modern History offers a broad audience of historians explorations of different cultures on a given theme, whether in explicitly comparative studies, or by the grouping of studies (or books reviewed). One of the elements juxtaposed in this way will often be European, but not always. In addition, there will be articles dealing with two or more elements of the same culture, or bringing quite different kinds of source materials to bear on the same phenomenon. Its coverage is broad, both geographically - Europe, the Americas, Asia - and in terms of subject matter. Half of the articles will treat subjects which are not primarily European.



Utopian Brotherhoods & Secret Societies in the Early Seventeenth Century

Donald R. Dickson

A study of the Protestant utopian movement that began in Germany, inspired in large measure by the writings of Johann Valentin Adreae, and came to England through the efforts of the émigré Samuel Hartlib. The first chapters examine Andreae's utopian writings, including the Rosicrucian manifestos, as part of his lifelong commitment to found a Societas Christiana, a spiritual élite that would improve religious and intellectual life. His writings sparked a transnational movement in early modern Europe. The most significant of the German learned societies are discussed: The Societas Ereunetica, Unio Christiana, and Antilia. The latter chapters consider Hartlib's English circles and various utopian and learned societies in the 1650s. This study contributes to our understanding of the role that "secret" societies and epistolary networks had in the republic of letters.

Donald R. Dickson, Ph.D.. (1981) in English, University of Illinois, is Professor of English at the Texas A & M University. He has published extensively on seventeenth-century literature, including The Fountain of Living Waters: The Typology of the Waters of Life in Herbert (Vaughan and Traherne, 1987).

Rose Cross over the Baltic

The Spread of Rosicrucianism in Northern Europe

Susanna Åkerman

This volume is a study of Rosicrucianism in the early period of the seventeenth century with emphasis both on the local reception of the Rosicrucian pamphlets in the Baltic area and on the original group of Rosicrucian authors in Tübingen.

In the first part of the book the Runic theosophy of the Swedish Rosicrucian Johannes Bureus is studied in its millenarian context, beginning with his *Adulruna Rediviva* of 1616. The Paracelsian prophecy of the Lion of the North is also shown to be a Rosicrucian theme.

The general millenarian background to the Rosicrucian publications is then explored and implications are drawn from the Rosicrucian doctrine of the great conjunctions, from the emergence of new stars, and from their comet research.

Susanna Åkerman, Ph.D. (1989) in Philosophy, Washington University, St. Louis, is Research Fellow in the History of Ideas at Stockholm University. She is author of Queen Christina of Sweden and Her Circle, (Brill, 1991).

Sources Concerning the Hospitallers of St.John in the Netherlands, 14th-18th Centuries

Johanna Maria van Winter

This source collection brings for the first time records from foreign archives concerning the Dutch commanderies of the Order of the Hospital of St. John or of Malta and their place within the Order's international organization.

The book presents bulls and letters from and to the Grandmaster and the Prior of Germany; a 14th-century rent-roll of St. Catherine's Convent at Utrecht; visitations and inquiries 1373-1732; and a list of pamphlets concerning the regaining of the Order's confiscated property in the Dutch Republic. All sources are given in their original language: Latin, French, Italian, German or Dutch. Because of the long period (14th-18th centuries) and the broad variety of subjects they are important for researchers of political as well as economic history from medieval to early modern times.



Communities, Politics, and Reformation in Early Modern Europe

Thomas A. Brady, Jr.

The studies united in this volume explore themes of community, politics, religion, gender, and social conflict and accommodation during the first decades of the Reformation movement.

Other chapters investigate historiographical themes, especially the interpretation of early modern German history. Two longer chapters address European themes: the historical sociology of early modern societies in terms of legal definitions of status and modern conceptions of economic class; and the difference between central and western European development in a global context. Taken together, the studies explore the transition zone between medieval and modern history in both microhistorical, especially urban and regional, and broadly comparative contexts. Some of the studies are supplementary to the author's books on the sixteenth-century Protestant Reformation at Strasbourg, in southern Germany, and in the Holy Roman Empire.

Thomas A. Brady, Jr., Ph.D. (1968) University of Chicago, is Professor of Early Modern European History at the University of California,




