



## TENSION...

Outward signs of nervous stress are frequently encountered in present-day practice, and the value of symptomatic treatment with a sedative dose of barbiturate is now accepted. 'Amytal' and 'Sodium Amytal' can be relied upon to relieve nervous tension without irritability or loss of alertness. In nervous dyspepsia, gastric ulcer, etc., the administration of Tablets 'Amytal' gr.  $\frac{1}{2}$  t.d.s. is usually satisfactory.
