The awards are made possible through the generosity and support of the Newcomen Society of the United States.

CONTRIBUTORS

JONATHAN BARRON BASKIN is assistant professor of economics and finance at Baruch College, City University of New York. He has received graduate degrees from the University of Chicago, Columbia University, and Harvard University (Ph.D. in economics). He has published work on corporate financial policy, and his research spans the interstices of finance, corporate strategy, and business history. He is currently writing a book on financial history from ancient Babylon to the present.

CLAYTON A. COPPIN is research consultant for the Center for the Study of Market Processes, George Mason University, and an independent historical researcher living in Washington, D.C. He is presently at work on a book-length study of Harvey Wiley's enforcement of the Pure Food and Drugs Act of 1906.

STEVEN A. EPSTEIN is associate professor of history at the University of Colorado, Boulder. He received his Ph.D. in history from Harvard University in 1981. He is the author of several articles on the social and economic history of medieval Genoa, as well as of *Wills and Wealth in Medieval Genoa*, 1150–1250 (1984). He is at present completing a history of wage labor and the guilds in medieval Europe.

MARGARET B. W. GRAHAM is associate dean at the Boston University School of Management and a founding director of The Winthrop Group, Inc. She holds a BA in history and English from the College of Wooster, an MBA from the Harvard Business School, and a Ph.D. in history from Harvard University. A self-styled "applied historian," she specializes in both the history and the current practice of R&D and the management of advanced manufacturing technologies. She has published for a broad array of audiences in outlets from the Harvard Business Review and Across the Board to Decision Sciences and Technology in Society. She is the author of RCA and the VideoDisc: The Business of Research (1986) and, with Bettye Pruitt, of a forthcoming history of R&D at Alcoa. She is currently investigating the history and present-day operations of strategic alliances.

JACK HIGH is associate professor of economics at George Mason University. He is coeditor (with Richard Fink) of A Nation in Debt (1987) and author of Maximizing, Action, and Market Adjustment (forthcoming). His articles have appeared in the Journal of Post-Keynesian Economics, Economic Inquiry, Theory and Decision, and other economics journals.

H. V. NELLES is professor of history at York University, coeditor of the Canadian Historical Review, and coauthor (with Christopher Armstrong) of Monopoly's Moment: The Organization and Regulation of Canadian Utilities, 1830–1930 (1986) and Southern Exposure: Canadian Promoters in Latin America and the Caribbean, 1896–1930 (1988).
