Competition in the Synthetic Rubber Industry

THIS STUDY offers unique opportunities for the comparison of the regulation of industry through market competition and through direct government control. The synthetic rubber industry, conceived and developed largely by the federal government, was operated, under contract, by private companies; when Congress in 1955 converted the industry to private ownership, it clearly expressed its belief in the relative efficacy of market competition. In assessing the public policy toward the industry, the author concludes that it is workably competitive – both in the static sense that the public interest is served and in the dynamic sense that rapid technological change is an effective substitute for price competition at the present stage of the industry's development.
